TRANSMISSION.

RENDINA DR. RENDINO - He is a Commissario Aggiunto of P.S., and has acted as Questore since the 24th of June, under designation of AMG.. As he was an anti-fascist, he was persecuted even before 25 July 1943, and had the charge of the anti-fascist repression under Badoglio's government : he acted with clarity and intelligence under the guide of the Questore, and was then arrested by the nazi-fascists in October 1943, together with Questore Minevanti. He was taken to Ancone, sent to jail and threatened with being shot; then, having been invited to report to the then Head of police, he hid and through the kindness of doctors, obtained a period of rest for reasons of health.

After a new menace of arrest, he went to Petritoli, and from there he wandered from village to village, remaining in contact with the Liberation Committee of Fermo, acting as an informer to them. After being denounced to the fascist tribunal, when the Allies liberated Ascoli, Dr. Rendina reached the town with the Provincial Committee of Liberation.

Dr. Rendina has shown very good qualities of tact and intelligence, and has obtained very good results, even with the exceedingly small staff at his disposal.

He should be given a particular acknowledgement for his merits.

TRANSLATION.

LEPHUNI Dr. UMBERTO - P.S. Commissario Aggiunto. He held important Police offices. Being hated by the local fascists, he was sent to the internment camp of Urbisaglia for foreign people, whom he helped and advised very much, obtaining the acknowledgement of the Swiss Control Commission. He asked to be given a long leave.

He sent his son, who had been called up by the Republican Army, towards the Allied lines. Because of his friendship with Gustavo Minervini and Dr. Rendina, and because of the above-mentioned facts, his family's ration cards were taken from him, his private correspondence was seized, he was isolated and followed and thereby obliged to adhere to Republic.

Taken into service again after the liberation, he is the only collaborator of Dr. Rendina, who has no other official in his service.

PIETRAPERZIA Gaetano - Commissario of P.S. - suspended 24 Jun 44 by order of the Prefettura, on the instigation of AMG, because he had openly declared himself a squadrista, had been prominent during the republican period, and was not thought well of by the local population, his morals being questioned. He was also addicted to prevarication and misrepresentation. He was considered to be in the close confidence of the former "Capo della Provincia" Altini - He was in close contact with the republican government and with the notorious Adriano Menghi.

GIANNETTO Benedetto - Commissario Aggiunto of P.S. - suspended on 26 Jun 44 for having been an open squadrista, having given arms to the Fascists by way of Menghi (mentioned above), and because he was hated by the public. He was open in his sympathy with the fascists who had arrested the Questore Minervini. He sent to the "Fedrale" (Fascist head of the Province) a copy of a "Most Secret" circular from the Ministry of the Interior to all Prefects.

CONTISSA Carmelo - Vice-Commissario of P.S. - was suspended on 4 Jul 44, by order of the Prefettura; in his position as Capo Gabinetto of the fascist Questore Milone, he made himself particularly prominent during the German occupation, and he effected the enlistment in the auxiliary police and in the Guardia Nazionale Repubblicana of several of his relatives. He assisted his colleagues in the destruction and concealment of office records.

Born the 8/3/1895 - Entered the P.S. administration, following to a regular competition, in 1916 - Performed duties as subaltern at Siracusa, Comiso, and Reggio Calabria - In 1929 was promoted Commissario - in 1932 was transferred from Reggio Calabria to Crotone and in 1936 to Catanzaro - He has been Extraordinary Commissario in the Comunes of Vittoria, S. Croce Camino and Motta S. Giovanni. He was promoted Commissario Capo in 1941; in 1943 the Allied H. s appointed him Questore of Catanzaro. In last September he retired from his office, with the previous agreement of that Subcommission (ACC/14041/39/PS, dated 26/3/1944)

Immediately after the liberation of that province by Allied troops, the following officials have been suspended from duty: dott. Gaetano Pietrapertosa, P.S. Commissario, Mr. Benedetto Giannetta, P.S. Commissario aggiunto, dott. Carmelo Contissa, P.S. Vice Commissario.

In order to completely re-organise the directing staff of a/m office, it is necessary to appoint there a director and 2 capable officials, transferring to another seat those suspended, whose further stay in said Province is deemed incopportune.

In view of the urgent necessity concerning a/m re-organisation, we beg you to grant, as soon as possible, authorisation for a/m movements.
