Married.

Entered P.S. Administration April 1913, following regular examination competition. As subaltern worked in ~~Amante~~ Ancona, then for about 13 years, in Naples, where he was attached to the mobile squad. As Commissario he worked in Grosseto and Salerno.

Promoted vice-questore in 1932, he remained in Salerno.

Promoted Questore in December 1941 he administered the Enna and Frosinone Questure.

He was discharged and put at disposition, by the Nazi-fascist government.
