SUBJECT : Questore - Modena Province.

TO : Ministry of Interior, Director Public Security.

Reference the proposed assignment of a Questore to Modena Province, the Provincial Public Safety Officer A.M.G. has informed this Headquarters that Bertassoli Gova, former Commandante Guardia Civile, is now acting Questore, having been so appointed by the C.L.N., and that it would be inadvisable, at least for the time being, to replace him by an appointee from the South.

Papa Antonio who, until September 1943, was Questore at Modena, recently presented himself to the Prefect with the object of re-entering the service, but was not well received. Papa submitted a statement with the request that it be forwarded to your HQ. This statement is enclosed herewith.

In view of the circumstances, it is considered advisable that no change in Questore be made at Modena at this time.

1. Attached is a report from the Provincial Public Safety Officer, Modena Province, relative to the Questore of that Province.

2. At the present time, BERTAZZOLI Cova, former Commandante of the Guardia Civile is acting as Questore, having been so appointed by the C.L.N.

3. The Provincial Commissioner has been advised as to the name of the Italian Government nominee for the post of Questore for Modena, vide cable 6393 of 29th April 1945, but owing to the rather delicate conditions now existing at Modena, and in fact in most recently occupied towns in Army Area, he prefers to retain, for the time being, the services of BERTAZZOLI as temporary Questore.

4. PAPA Antonio who, until September 1943, was Questore at Modena, recently presented himself to the Prefect with the object of re-entering the service, but was not well received, and a statement from PAPA is attached herewith for transmission to the Italian Authorities concerned.
