1. Reference your letter 46/4041/55 PC. of 2nd October 1945, respecting Questura for LA SPEZIA.

2. Dr. PAPA ANTONIO is the present Questura of LA SPEZIA. He reported back to LA Spezia on 12th September.

3. His explanation for his sudden departure immediately after arrival without notice or authority, was that he had reported earlier than was called for in his orders and therefore he decided to take advantage of the time that remained before he should take office here, to go to Rome on official business.

4. Doctor LAIA has taken complete control of the Questura and has already proven himself a police officer of experience and capacity. For the first time since the occupation by the allies, the Questura is under control. PAPA is faced with many problems which have been carried over from the first weeks. He is dealing with them in an efficient manner. He will not be dictated to by the C.I.M. or other political factions. It is regrettable that he was not here from the first days of liberation.

5. Considering his activities since his return, this office considers the act of leaving without orders, one committed in good faith. It is requested that no action be taken against him and under no consideration should he be removed or transferred.

Re the notice which appeared in some Italian papers here about the Questors and the Vice-Questors being arrested.

- 1 So far as is known this report is quite incorrect. LIGURIA Region have been called on for a report which is not yet to hand. According to Lt. Col. MANNES, Provincial Commissioner GENOA Province, who visited us the day before yesterday, a new Questors and Vice-Questors were installed on October 5th.
- 2 As usual, the local CIN did their best to prevent any change, which before I left GENOA I knew to be desirable, and there were representations from other quarters. Lt. Col. MANNES said that these representations had been dealt with and the change made on October 5th. I am not surprised that mistaken information got into the press.

TO : Director, Public Safety Sub-Commission

1. Dottore PAPA Antonino, the Questore mentioned in letter AC/14041/61/PS dated 30 August 1945, reported for duty in La Spezia Saturday Sept. 8th. As it was late afternoon, when he arrived, he was told to arrange for lodging, etc. and report to the P.P.S.O. on Monday morning, 10th Sept.
2. PAPA failed to report back to P.P.S.O. as directed and according to information received from other officials, he has gone to Rome, supposedly on official business. The Prefect, however, knows nothing of his parting and the P.P.S.O. was not notified.
3. Although PAPA has not been interviewed by the P.P.S.O. enquiries indicate that he is an elderly man and not the type which is so necessary in La Spezia. In any case his action in going to Rome, if he has gone there, does not tend to inspire confidence in him and it is suggested that urgent enquiries be made of the Ministry for information regarding the movements and intentions of the subject.

My dear Admiral :

With reference to cable 764 dated 24 August 1945 from Regional Commissioner Liguria on the subject of Questore.

The question of Questori for La Spezia and Imperia and Questore and Vice Questore for Genoa has been raised with H.E. Ferrari, Director of Public Security Ministry of the Interior. In view of difficulties experienced in the north by career officials sent from Rome recently the names of the Questori suggested have been submitted to the President of the Council for concurrence, and this accounts for the delay in sending the officials to the north.

Copies of all the correspondence with the Ministry have been forwarded to R.C. Liguria and I have endeavoured to hasten matters by personal interviews with H.E. Ferrari. In fact to-day, the 28th August, we have received the names of three Questori approved by the President of the Council and R.C. Liguria is being asked by cable if he agrees.

The urgency of sending strong career officials to the north is fully appreciated and everything possible is being done to ensure the co-operation of the Ministry of the Interior.

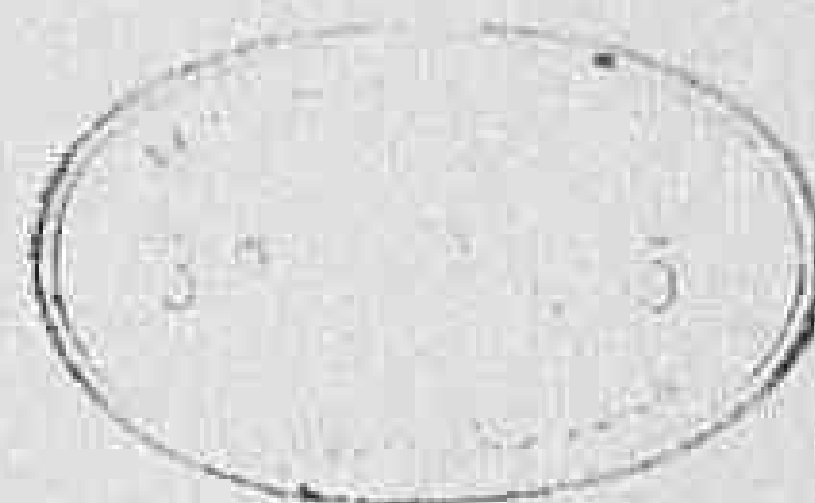

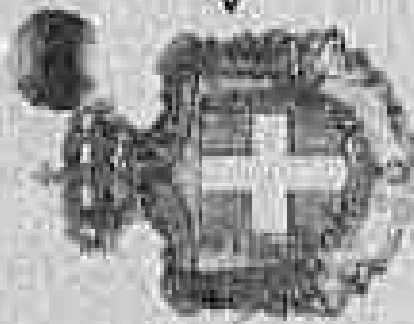
