Instead, for the Questura of Savona, left, as is known, without a titular, we appoint the Questore Restivo Giuseppe, actually at disposal.

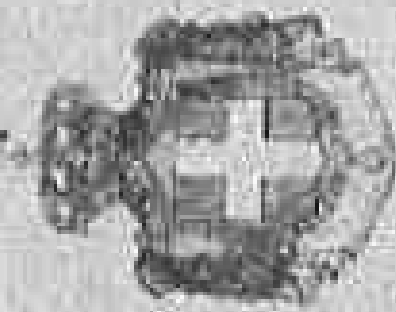

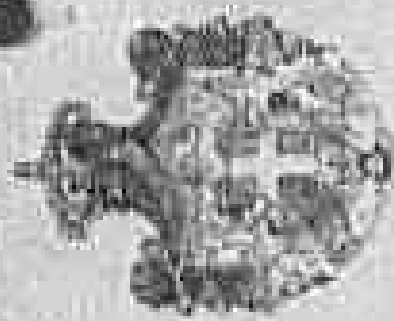
