2. Attached are biographical notes of the following Questori:-

3. Dr. Strina will be leaving Rome by air for Treviso on or about 11 June.

4. It is not possible to furnish Northern born career officials for the following reasons:-

- a) Most Government officials come from the Southern provinces, where there are fewer opportunities for industrial employment.
- b) The few existing Northern born Questori officials were mostly on duty in the North, and as practically all of them worked with the Fascist Republic, they are now unsuitable.

5. If you think him suitable, Col. Durante is in Rome and is ready to leave at short notice.
