Dr. CONSOLI Giovanni

Vice Questore

Born on the 1/9/1881 - Married - Two Children - Started his career on the 1/3/1907. Excellent up-to 1942. Good for 1943.

For several years on duty at Trapani, during March, 1943 he took over the direction of the Questura, showing himself capable.

After the liberation of the town, not having returned to his office, for reasons not depending from his will, he was in opposition with the Prefect De Antoni, who removed him from his appointment. For the same reason he has also been qualified as "good". He appealed against this qualification and the investigation is in course.

Appointed director of the Siracusa Questura, H.E. the High Commissioner for Sicily has reported that he is doing well, and that he is capable and still suitable for a good Questura direction.

In all qualification records the judgments have been always very good and he is said to have large experience in all services.

The Siracusa Prefect in a report made in January 1945, is proposing him for a promotion.

Nato il 1.9.1881 = Ammogliato con due figli = Entrato in Amministrazione il 1.3.1907. Ottimo fino al 1942. Buono per il 1943.

In servizio da alcuni anni a Trapani, nel marzo 1943 assume la reggenza della Questura, dimostrandosi tecnicamente capace.

Dopo la liberazione della città, non essendo rientrato in sede per cause indipendenti dalla sua volontà, si mise in contrasto col Prefetto De Antoni, il quale ne provocò l'esonero dalla carica. Per la stessa ragione ebbe ad attribuirgli la qualifica di 'buono', avverso la quale l'interessato ha prodotto ricorso, attualmente in istruttoria.

Nominato reggente la Questura di Siracusa, S.E. l'Alto Commissario per la Sicilia ha riferito che fa bene, definendolo colto, capace e tuttora idoneo a ben dirigere una questura.

In tutte le note di qualifica i giudizi analitici sono al superlativo e viene detto di larga preparazione professionale ed esperto in tutti i servizi.

Il Prefetto di Siracusa con rapporto del gennaio 1945 lo definisce in possesso dei requisiti per la promozione al grado superiore per merito comparativo.
