1. Reference your letter AC/14041/72/PS dated 24 July 45, Vice Questore TOSCANA Giuseppe is not known to me or to other Public Safety Officers in Genoa.

2. From enquiries made at the Questura it is understood that Toscana did serve in Genoa from 1935 to 1939 when he was transferred to Piacenza.

It is believed that he retired from Piacenza some years ago but unless some indication is given as to the present whereabouts of Toscana it will probably take some months to trace the individual and complete the enquiry.

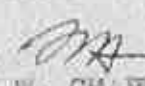
