TO : Ministry of Interior,
Direction of P.S.1. Reference your 333/9018 of 17 Nov. 45 and
333/9018-11 of 4 Dec. 45.2. Dr. Guglielmo, Michele, was recommended to
take over the Questura at Alessandria vide your letter
333/9018-11 of 15 Oct. 45. In the meantime Dr. Luigi
Aloatti had been appointed, and he (Aloatti) was consider-
ed unsuitable vide your letter 333/9018-11 of 24 Oct. 45.3. Dr. Guglielmo was therefore instructed by the
Regional Public Safety Officer to take over at Alessandria.
He has again been instructed and has left for Alessandria,
where he should remain for the present.4. The present acting Questore of Novara, Tacchella,
Luigi, has worked well under difficult circumstances, despite
local political opposition, and it is felt that he should
remain there until such time as the region passes to control
of the Italian Authorities, when his replacement or retention
will be a matter for your consideration.

SUBJECT : Questore of Novara
 TO : The Regional Public Safety Officer Piedmont Region
 FROM : The Provincial Public Safety Officer Novara Province
 DATE : 5 December 1945,

1. The following facts are brought to your notice regarding the position of the Questore of Novara.

2. You are aware of the reorganisation of the Questura Service which took place in this Province on the 8th August, 1945. Upon my arrival in this Province on the 8 July, 45 I found the Service to be controlled by political elements. I made careful enquiries and subsequently ordered the dismissal of two Vice Questore and a number of Commissari. One Vice Questore was a leading member of the local Communist Party and the other Vice Questore a member of the Socialist Party. It was acknowledged by the Provincial C.L.N., that the main administrative positions should be held by the various political parties. Accordingly upon liberation of the Provincial Administration were allocated. The Prefect of Novara is a socialist and all his actions are dictated according to the policy of either the Socialist or the Communist Party.

3. The present Questore of Novara is TACCHELLA Luigi who was appointed to the position in June of this year. He is an Army Officer and previous to taking up this position had very little police experience. He has however proved himself to be impartial and has carried out his duties efficiently and without fear of favour. He has met constant opposition from the parties of the Left and his regard for the application of law and order has gained him the respect of the population of this Province. He has had no assistance from the Provincial Administration and every opportunity is taken by the Prefect and his assistants to criticise and impede the work of the Questore.

Immediately after liberation the Questore of this Province was flooded with the worst type of Partisans and they became the force of Mescatelli and the two Vice Questore and their men acted upon the very whim and fancy of the noted Partisan Chief. Tacchella with my support resisted their efforts to set up a political force and eventually great concern was caused to the Leftists when the purge of the Questura was made. In this respect the Prefect fought me by every means in his power. He introduced every agreement to the Provincial Commissioner to evade the dismissal of his cronies. He brought pressure to bear upon the Allied Military Government by the Regional C.L.N. and subsequently by the C.L.N.A.I.

The men concerned were however dismissed. The Questore then set out to complete the purge and consequently he met great opposition from the Prefect. I found great difficulty in dealing with the Prefect

and it was only when I obtained the support of the Regional Commissioner and of your office was anything done for the police agencies of this Province.

Fornara is definitely a Political Prefect. He is not a good administrator and his decisions and his policy is dictated by his political friends. On a number of occasions the Allied Military Government of this Province have found illegal decrees which he has made. In every case the decrees have always been made in favour of either the Socialist or the Communist Party.

It is the considerate opinion of the writer that the direct and fair policy of the Questore does not agree with the political dictates of Fornara and his Communist friends.

Within the past few days the Prefect has submitted a letter to the Ministry of Interior complaining of the efficiency of the Questore. He accuses the Questore of inefficiency, lack of administrative ability and a low standard of discipline with the men under his command. The Prefect also alleges that the Questore is being petrol for his private pleasure and in that respect I can state that for the month of November 1000 litres of petrol was assigned to the Questore. This Province is peculiarly situated and the work entailed by this particular police agency it needs little explanation on the part of anyone to see the baseness of the charge made.

4. I have kept a careful check on the activities of the police agencies and I am quite satisfied with the efficient of the Questore. I am also well aware of the political activities of the Province and I can state without hesitation that such allegations are made by the perfect in response to political influence.

The Questore of Novara has done a very difficult job in a particularly worthy manner. There is no doubt that he has risked his life in performing his duties on several occasions. This Province is one of the "Reddest" Provinces in Italy and the influence of the Left Policy is found in every office and department of the Provincial Administrations. When one of their officials does not comply with that policy he or she must be eliminated. This is the campaign against the Questore. Up to the present time I have supported him in doing his duty.

5. I would respectfully suggest that the purport of this report be communicated to the Public Safety Sub-Commission, Allied Commission so that the report of the Political Prefect Fornara should be offset by the facts and that fair play and justice should be shown to the Italian Authorities.

1. Reference your report of the 3 Dec. PR/PS/6/67 on the above subject.

2. I have learned the following regarding the person referred to.

He was the Quæstore of Savona at the time of liberation. It is alleged that he has received many threatening letters and is now in fear of his life.

He is a very exacting official and is considered to be honest and quite efficient. A number of the officials at the Questura at Rome have worked under him and he is known personally to them.

3. He is married to a Novara woman and she and her family have good connections in this Province. He recently obtained a period of leave from his duties and he came to Novara and contacted many persons of influence. It appears however that he wishes to be transferred to Novara for family reasons. I have received information that his wife contacted the Bishop of Novara and the Prefect regarding her husband's position. She also contacted other persons that they could use their influence on her husband's behalf.

4. It is not known whether Di Guglielmo would carry out his duties in this Province in an impartial manner. If such a transfer were made it would be obvious that the social contacts of his wife would have a direct bearing upon his office. My husband and I can only suggest that her contacts at the present time would lead me to believe that his duties would be performed in relation to them.

He produced a telegram from the Ministry - ref No 36780/333/2867 dated 23 Nov 45 - which stated that "The Allied Authorities have appointed a Questore at Alessandria, therefore the transfer of Vice Questore Di Guglielmo Michele has been suspended, and the above official remains at the disposition of the Ministry".

4. As, on 29 Nov. 45, this HQ had received a firm approval from P.P.S.O. Asti and Alessandria, and had at once advised HQ A.C., the PPSO was telephoned to ascertain if there had been any change in the situation. It was found that there was no reason why Dr DI GUGLIELMO should not take up his position and, in fact, the Prefect and present Questore had that day been advised that he could be expected at any time. I accordingly directed DI GUGLIELMO to proceed to Alessandria and commence his duties.

5. A point of interest arose during the conversation: Dr DI GUGLIELMO asked repeatedly if he could be sent to Novara instead of Alessandria. Pressed for reasons he was evasive but stated that the Prefect of Novara and other Officials, and the Ministry were dissatisfied with the present Questore (who is not a career man) and desired his removal. In view of the position in Novara and the person's whereabouts in connection with the recent



1. Ref attached letter from P.S. Sub Commission.
2. Comm. Alloati was recommended for the post of Questore of Alessandria by the Prefect and C.L.N. who were aware of his past record. Since fulfilling this post he has given satisfactory service and whereas I fully agree of the undesirability of such employment, I should like his replacement to be deferred for a few weeks.
3. My temporary assumption of the duties of P.P.S.O. of Alessandria has not yet enabled me to get a clear vision of the whole of the police situation and it is for that reason I ask for this delay.






