The following letter from Allied Force Headquarters, subject as above, file AG 000.1/095 GEG-0, dated 17 February 1945, is published for the information, guidance, and compliance of all concerned:

"1. Members of the Allied Forces must refrain from any direct or individual participation in Italian politics. Strict compliance with this principle will become more important than ever as the Italian Government assumes an increasing measure of political responsibility over a more extensive area of Italy.

2. Casual attendance by Allied Forces personnel at political meetings, and even private conversations with Italians on political subjects, may lead to misunderstandings and will be avoided on all occasions.

3. All commanders will issue orders to all concerned to refrain at all times from any form of participation in Italian political affairs."
