NOTES OF MEETING BETWEEN COL. MONFORT, LT. COL. WILCOX
LT. COL. PERCILL AND LT. COL. THOMPSON, 23RD SEPTEMBER, 1944.

At 10 o'clock on the morning of 23rd September, I discussed with Col. Monfort the help to be given ^{by} AOC Representatives at HQ. AAI, ~~to~~ ^{to} SCAPOs in Army Areas.

It was agreed that technical instructions would be sent from Public Safety Sub-Commission to SCAPOs of Army Areas hitherto. This Sub-Commission would be solely responsible for policy. The functions of Col. Monfort's staff were to deal with any urgent problems where HQ. A.A.I. could give immediate assistance thus saving delay in corresponding with HQ. AOC.

From the Public Safety point of view the problems likely to be referred to A.A.I. were:-

1) Transport.

In the future groups of CO. RR will be moved from the replacement centre of Florence to newly occupied territory. If arrangements cannot be made at Army HQ, the assistance of A.A.I. may be sought.

2) Equipment.

Normally CO. RR are clothed and equipped by the Italian Army but in the early stages it may be necessary to apply for immediate assistance to A.A.I., especially as regards boots, blankets and mess-kits. Rations Some help might be needed until proper system was established.

3) Requisitioning.

In the past difficulties have arisen through Allied troops requisitioning Police Stations and Prisons. An agreement had been reached with A.A.I. that these buildings should only be occupied in cases of urgent military operational necessity. In any future instances of the seizure of Police Stations

2) Equipment.

3) Requisitioning.

In the past difficulties have arisen through Allied troops requisitioning Police Stations and Prisons. An agreement had been reached with A.A.I. that these buildings should only be occupied in cases of urgent military operational necessity. In any future instances of the seizure of Police stations **3011** Prisons it was hoped that A.A.I. would order their release at the first opportunity.

4) Conduct of troops.

Complaints of misbehaviour by Allied troops towards the Italian population were normally referred to the Provost Marshall. In some instances, notably with the French Colonial troops, inadequate action had been taken by the Provost Marshall and in such future cases the assistance of A.A.I. would be sought.

Colonel Monfort stated that these points would be noted and that he would take up the matter of transporting CC, RR into Army areas at once. Colonel Monfort added that a directive would shortly be issued defining the duties of the ACC staff at HQ, AAI and the channels of communication.
