3. Another matter in connection with 'promotion' has to be drawn to your attention: It has come to the knowledge of this HQ that in several instances members of the VGFF have been granted acting ranks without the authority of Chief of Police (now S.C.A.P.C.). This improper practice will cease forthwith and in future where it is deemed necessary to grant an acting rank a recommendation form will be forwarded to S.C.A.P.C. in the manner set out in 1(a) and (b) above. 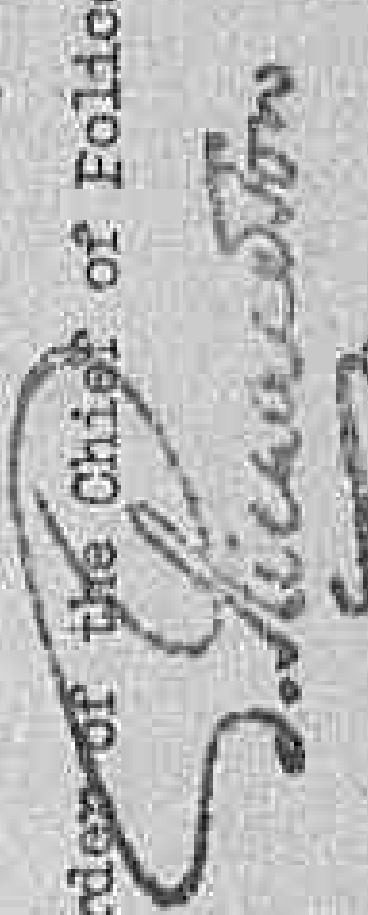

b) They will be allowed to enter again the rolls of the Arm only if their behaviour is according to the existing rules;

c) The service rendered to the above mentioned Police cannot be considered as the one rendered to the Arm. For those now at the service of the above mentioned Police, who want to enter the Arm, could ask the Ministry of War, only in case territory should be attributed to Italy.

In the meanwhile the parties interested which eventually succeed in re-entering the ranks of the Arm can apply to the above mentioned Ministry in order to obtain such acknowledgments;

d) The Military that at the date of the 8th September 1943 were already entitled to retirement treatment can solicit same by applying to nearest legion.
