SUBJECT: Identity Cards and Treatment of Italian V.I.P.

TO: AFHQ, G-5 Section.

- 1 An incident took place recently in which an Italian Minister was stopped by an Allied Military Policeman in Italian Government Territory and treated in somewhat cavalier fashion.
- 2 It is felt that such incidents are most undesirable and would not arise if the Military Police had a means of recognising Very Important Persons.
- 3 Would you agree to special identity papers being given to a very limited number of persons and the issue of suitable directive to the Military Police by AFHQ.
