To : A.S. Public Safety Sub-Commission - Rome.

Following Allied Control Commission's order of July last all officials who performed managing duties in the Rome prison institutions were removed from their positions and put at the disposal of this Ministry to be re-employed in territories not within AMG jurisdiction.

Such provision applied to Comm. Belfiore Salvatore, Censor of the re-education institution for minors in Rome, who was transferred to Palermo, Office, which he has not been able to reach, due to transport difficulties.

As this Official will soon leave this Administration for completion of 40 years of service, having started his career on the 6th August, 1905 and being in a special and delicate family situation, the Commission is requested kindly to re-examine his position in order to see, whether, as has already occurred in regard to others, it would be possible to revoke the provision adopted in his regard, so that he might continue to perform duties in a Office of the Capital.





SUBJECT: Prison Conditions -

The following pertinent information regarding Prisons of Lazio-Umbria Region is submitted.

1. REGINA COELI:

A) Population, including 177 in 3rd (CIC-Security) wing, is, as of midnite 25 Oct. 1944, 1511. The count of security prisoners is gradually being reduced. Common prisoner numbers are gradually but steadily rising, most arrests being for common crimes, such as robbery.

The population count, as compared with the capacity of the prison, is in far better position than during the recent disturbances. The 7th and 8th bracci will be ready to receive prisoners about the 1st of November and the present overcrowding will be greatly eliminated. Repair of locks, doors and the roof has progressed much faster than at first estimated.

B) Staff: Some transfers to and from Regina Coeli are being made by the Minister of Grace and Justice, according to an apparent plan to change the intire staff eventually.

The Director of the main prison of Naples is to be transferred to R.C. shortly. He is a "career" Director and should know prison administration. From all reports, he comes well recommended.

C) Investigations: A representative of the Minister of Grace and Justice is making what appears to be a thorough investigation of recent reports of corruption in the purchase of releases from Regina Coeli. He recently travelled to Padula to interview personnel who were involved. A report on his findings and action taken will be made in due course.

Investigations of reported smuggling of letters from the CIC (security) wing has resulted, to date, in one guard being sentenced to 2 years imprisonment in A.M.G. Superior Court and 4 guards interned as security threats by Allied Security Agencies. Various violations of prison censorship regulations by common prisoners have been handled thru the prison administration.

D) Regina Coeli is calm and orderly. However, with the growing population, the overcooming winter, no betterment of rations for either common prisoners or guards, and but little evidence that the Italian judicial Authorities are sufficiently cognizant of the dangers involved in slow judicial processes, the undersigned does not believe that Regina Coeli will get thru the coming few months without prisoner demonstration.

2. OTHER PRISONS

Information, either thru personal visits or from official reports from the Public Safety officers concerned, is on hand from all provinces, except Grosinone. The general picture is most discouraging and effective solutions are not in sight. The following points are submitted:

A. Population

Badly overcrowded in the men's prison in Perugia. The capacity is 250; the present population is 450. With Regina Coeli, this is the only critical case of overcrowding.

B. Food

The ration is below acceptable standards in every case, but the prisoners are getting what has been described as a "fair share of the food available". Fats, oil, and salt are universally completely absent, or available in such tiny quantities as to constitute a major cause for criticism and potential disturbance. Transport is not available to the great majority of prison administrations and the

food situation promises to become even more critical as winter approaches.

C. Sanitation

Medical supplies for sanitation and for treatment of inmates are almost universally lacking in the district (mardamenti) jails and insufficient in the larger penal and judicial prisons. Soap is not available in the majority of cases.

D. Utilities

Water and electricity are not available in a large number of both the district and main prisons.

E. Bedding - beds, etc.

A serious lack of bed covering is reported from many sources with almost complete lack of supplies from Italian agencies to correct the situation. Requests by the Directors are not being met thru their official channels. In the higher altitudes the situation must be considered critical.

RECOMMENDATIONS

1. That the undersigned be authorized to place his detailed records at the disposition of the Minister of Grace and Justice, by order to give an accurate picture of the situation to the responsible Italian officials.
2. That transport and other facilities be provided to Italian officials empowered to take executive action.
3. That Allied authorities make the strongest possible representations to responsible Italian agencies, and insure remedial measures through concrete contributions, wherever possible.

Subject: Dott. Carretta, Ex director Regina Coeli.

1. I am forwarding translations of documents pertinent to the plea of Ex-director Carretta of Regina Coeli, together with copies of my correspondence file on the same subject.
2. You may recall that I have consistently felt, and stated, that, in this single case, the removal of a prison director mitigated against the future success of the administration. This opinion was based not only on the known ability of Dott. Carretta, but on the apparent inability of all concerned to replace him with a suitable person. The scheda personale, the testimony (written and verbal) of many competent persons, and the opinion of the Supt. of Prisons, all indicated that this proposed removal was deserving of most thoughtful consideration.
3. I am well aware of the value of an all-embracing policy when considering the removal of heads of prison institutions in an entire area, and have expressed myself in this vein in official correspondence. I quite realize, too, that reinstatement of Dott. Carretta in Regina Coeli may be an unpopular move with the people of Rome and elsewhere. I cannot, however, in the face of the evidence at my disposal, agree that this director be unemployed or otherwise seriously penalized when it is highly probable that his record actually entitles him to more than usual consideration ~~in~~ the Allied hands.
4. The prison situation here, or elsewhere, can well use Dott. Carretta. For purely professional reasons I am requesting your best consideration in his behalf.

Subject: Proposed Removal of Prison Director.

1. Attached is file copy of result of investigation of Doctor Carretta, director of the Men's and Women's prison, Rome.

2. The undersigned assumes that all of these statements are true, in the absence of objective verification. He has, however, had ample opportunity to observe Doctor Carretta in his capacity as director for the past three weeks.

3. As superintendent of prisons since early in the morning of 5 June 1944, I am in a position to know that, during the critical early stages immediately following a general release of inmates of all prisons in Rome; when faced with such problems as mob violence, a prison to be made orderly and clean after the disorder of the previous day, the reception, processing, and security of various classes of prisoners arrested by many different agencies, insufficient light, water, telephone service, transportation, food, medicine, sanitary supplies, changing personnel; and the necessity of acceding to the demands of various military agencies, this director played an important part in a calm, efficient, professional manner. For over three weeks he has earned the respect of the GIC, M.P. and P.S. division personnel, who have seen him in his official capacity.

4. His attitude toward applicants, both inmates and otherwise, is considerate, sympathetic and professional. He has been in Rome only since November, 1943, and I am reliably informed that prison conditions

here have materially improved since he took over the administration.

5. It is the considered opinion of the undersigned that the removal of Doctor Carretta, after he has been allowed to work with and under Allied Military Authority for over three weeks, will do more harm than good to the occupational program.

6. It is therefore requested that reconsideration of the proposed removal of Doctor Carretta be made.

Subject: Director, Regina Coeli.

1. It is believed that your communication of to-day, pertaining to Col. Poletti's evident expectation that the Director of Regina Coeli should have already been removed, requires a statement of the situation insofar as the undersigned is concerned.

2. It will be recalled that Col. Poletti's first announcement on 25 June 1944 of a general policy concerning the removal of heads of civil institutions, admitted of some exceptions. The Supt. of Prisons expressed himself as not being able to recommend the Director's removal, on the basis of his observations and knowledge of Sig. Carretta's ability and history. In this connection he addressed a communication to Col. Poletti, enclosing his file as copy of the Director's history, describing his observations, and requesting reconsideration of the proposed removal. No reply to him this communication has been received.

3. During the visit of the Regional Commissioner and yourself to Regina Coeli, the undersigned stated that the removal of Director Carretta had been held in abeyance pending an expression from Col. Poletti. The Regional Commissioner then stated that both he and Col. Pollock would try to find a replacement for Sig. Carretta, and that the Supt. of Prisons would also be on the lookout for a substitute. No suggestions have been received by the undersigned to date. In the meantime he has selected Sig. Strazzera, President of the Visitation Commission for Rome prisons (and, for 2 yrs in contact with the better ideas of prison reform) as acting Director of Regina Coeli and the Women's Prison.

4. I have been informed by several officials that Col. Poletti has asked for representatives of the six political parties to present recommendations concerning the personnel of the various civil institutions. It is said that this Committee was making its report on Tuesday, 18 July 1944. No verification of this report from official sources has been received. 2855

5. Action taken to date:

Orders issued: (A) Removing Director of Regina Coeli and the Women's prison. President of Visitation Committee (referred to above) installed as acting Governor.

(B) Inspector General Comm. Marracino, Regina Coeli, removed. No replacement to date. Request suitable substitute be appointed

by higher authority.

(C) Marano Dott. Alberigo, Vice Director, removed.

(D) Comm. Morvillo, Inspector General of Boys' Reformatory, removed. Replaced by Rag. Spera Adolfo, accountant of same institution, with apparently clean record as acting director.

(E) Belfiore, Comm. Salvatore, Vice Director of Reformatory, removed.

(F) Comm. Sganga, Dott. Francesco, Inspector General in charge of the Center of Studi Penitenziari, removed.

6. Request that substitute personnel be considered by higher headquarters and that this office be informed of action taken.

By a measure dated 16 July 1944, on order of Col. Charles Poletti, formerly the Regional Commissary of Rome, You ordered, among other things, that I was removed from my function as a Director of the local judiciaire ~~prison~~ men and women prisons, and put at the disposition of the Department of Justice, in order to be appointed to another office.

That measure was ~~un~~^{un}expected and grievous, as my behaviour was always conforming with feelings of high and fervent patriotism. Therefore I believe on good grounds that this measure had been caused by some misunderstanding or inexact knowledge of the facts.

I was the Director of the Penal House of Civitavecchia since December 1941. There, even not bearing abuses or acts of overbearingness and contrary to the discipline from anybody, I tried to favour and facilitate the political inmates and their families, as much as it was possible according to the circumstances of time and social group.

In the fact, in opposition to what happened in the past, the families of the inmates, both common and political, could get, with their full satisfaction, to confer personally with the Director ~~as often~~ as they requested it, and to have often interviews behind the time and out of the term; even without showing the identity papers as by regulations and with prolongation of the regular time. Besides, in order to fulfil the wish expressed by most of the political inmates, to be admitted to the joint and

That measure was unexpected and grievous, as my behaviour was always conforming with feelings of high and fervent patriotism. Therefore I believe on good grounds that this measure had been caused by some misunderstanding or inexact knowledge of the facts.

I was the Director of the Penal House of Civitavecchia since December 1941. There, even not bearing abuses or acts of overbearingness and contrary to the discipline from anybody, I tried to favour and facilitate the political inmates and their families, as much as it was possible according to the circumstances of time and social group.

In the fact, in opposition to what happened in the past, the families of the inmates, both common and political, could get, with their full satisfaction, to confer personally with the Director as often as they requested it, and to have often interviews behind the time and out of the term; even without showing the identity papers as by regulations and with prolongation of the regular time. Besides, in order to fulfil the wish expressed by most of the political inmates, to be admitted to the joint and paid work, I forwarded the relative proposal to the Justice Department, in spite of the prohibition of working, existing for that category of inmates.

And in order that my proposal was accepted, I did not hesitate to pledge myself that no inconvenient would ensue from it.

As what concerns the disciplinary treatment, I cared at once for moderating the excesses due to the too strict system, taken up by the chief guard, a fascist prior 1922, "squadrista", "march on Roi me" and chief of the political investigation office, until I succeeded in obtaining his transfer, with the due prudences.

That is all that concerns the Penal House of Civitavecchia.

In October 1943 I was appointed on a mission to the Prisons of Rome, by order of the Department of Justice, and I kept this Direction from November 1943 to 18 July 1944.

During that period I cooperated actively with the various anti-Fascist parties and I had interviews, at Mr. Strazzer's, with Hon. Inssu, one of the most important leaders of the "Action Party" (= Partito d'Azione), and, at Dr. Monaco's, with Prof. Pertini, a member of the Working Committee of the Socialist Party and Peppino Graceva, chief of the underground military socialist organization. I gave precious news to the parties and I helped by any means the political inmates and their families. I hindered the nazi-fascist action in the ambit of the prison activity, preventing transportations to the North of political men and women inmates (among the latter Princess Gancia and the Hebrew sisters Astrologo) and also many Hebrew people, by opportune sheltering in the prison infirmaries and the various hospitals in town. Besides, of my own initiative and without the "nothing = prevents" of the competent authority, I provided for having them urgently sheltered in a civilian hospital. On that occasion, I ordered also the sheltering of other seven political inmates, who otherwise should have been transported to the North. At the last, according to a preventive agreement with the parties members of the Committee of National Liberation, on the morning of the 4th of June 1944, without any incident worth of significance and without shedding a single drop of blood, we got the liberation of all the political inmates, when the German troops were still in the prison. According to what I was told, I was looked for by German & Fascist SS, who luckily did not succeed in catching me, because I had placed myself and my family in safety, favoured by Patriots.

After Rome was set free by the Allied troops, I remained in charge for more than one month and a half still, cooperating actively and loyally with the Allied office of Superintendence.
