Caddeo Edoardo, director of the Bologna judicial prison, or to dott. Carissimi Cesare, superior director of the re-education establishment for minors in the same town.

It is, however, pointed out that this Ministry has no information in regard to both officials since Rome has been divided from the North and therefore, it will be the care of the Allied Commission to arrange investigations in regard to their activity during the period of occupation.
