Enclosure (A) is forwarded herewith with the request that the question of the movement of lire across the Adriatic be referred to the Commanding General of the Guardia di Finanza, observing that there is no Italian Coast Guard Service functioning at the present time. Representatives of the Ministry of Marine have indicated verbally that Guardia di Finanza is the Italian Government Agency which is competent to institute controls in the Italian ports for the purpose of curbing any illegal movement of lire or grain which may be taking place.
