SUBJECT : Rita Zucca.

TO : Public Safety S/C A.C.

With reference to your letter AC/14383/PS of 24th Aug 46. we inform you that Zucca Rita Luisa fu Costantino is still held in the Mantellate Prison.

In the sentence of the 2nd Section of the Special Assise Court of Rome, of the 19/8/46, she has been acquitted - art 247 C.P., from the accusation for which she had already been sentenced by the War Territorial Military Court of Rome, to 4 years and 5 months imprisonment, sentence dated 29/9/1945.

This sentence was cancelled on the 8/3/1946 by the Supreme Military Court.

On Zucca's release order it is stated that she will be released as soon as the order of the Allied Command is received thru the Procura Generale, which has directly turned the Allied Authorities.

1. The above named woman, who was a well known Broadcaster for the Germans, was sentenced by the Italian Courts to three years imprisonment for collaborating with the Germans.
2. It is understood that under the recent Amnesty Decree she was released from Italian custody. 4653
3. To assist the Allied Authorities in their investigation of her case, it would be appreciated if the Italian Police files relating to her case could be made available for inspection by the Allied Authorities.
4. If permission to inspect the files is given may it be stated please where such inspection may be made.
