SUBJECT : "CAMPO NAZIONALE DELLA MOTORIZZAZIONE"

As far as the "Campo Nazionale della Motirizzazione" is concerned, we inform you that :

- 1) The storehouse, which had not been damaged, was intact till 15th Juhe, when the evacuation of the city was disposed and it was no more possible to go there ;
- 2) after a few days of the Allied arrival and as soon as it was possible, I went to Pesaro . The storehouse was without roof because the occupation troops had brought away the tiles. For this reason all material was visible and a good part of it was carried away , not excluded the wood.
- 3) I provided immediately to settle part of the remained wood in a place of safety and to shut, as possible, the door which had been distorted. The shopman was charged to survey the storehouse. Nevertheless, the door has been found open.
- 4) It is a long time that the place where is the storehouse is considered "Military Zone" and for this reason entrance to civils is forbidden. The militaries living in the house and in the garden which are near the storehouse have been begged to forbid ~~that~~everybody may open the door and carry away the material without the presence of our representative . Besides that, as the ofice has been transferred to Urbino by order of the Prefetto, we have charged the shopman of the Seat to remain in Pesaro and to survey the material of the seat and of the storehouse.

With reference to your letter I4403/7/PS of 11 october, we beg to inform you that R.A.C.I. since January 1937 until august 1943 has carried out in all provinces, for the War Ministry, driving schools for young men who were about to be assigned to the motorised units of the army.

The driving schools took place by the Provincial Seats of the R.A.C.I. and in some localities through moving schools or the same Provincial Seats.

In the years 1941-42-43, in the months of july and august, the Italian Authorities organised in Pesaro a "Campo Nazionale delle Motorizzazioni" and invited the R.A.C.I. to carry out special schools for perfecting the motorists and adjusters. To these schools took part the young men who had been authorised to drive motorcars and who had followed favorably the school by the Provincial Seat of R.A.C.I. Every year 1000 - 2000 young men took part to this Campo Nazionale delle Motorizzazioni.

The Central Seat of the R.A.C.I. organised in Pesaro, by the Campo Nazionale della Motorizzazioni, moving laboratories : special school programs were organised and carried out by the best teachers. Special competitions for technical ability were organised about 800 young men.

With reference to your letter 14403/7/TS of 11 October, we beg to inform you that R.A.C.I. since January 1937 until August 1943 has carried out in all provinces, for the War Ministry, driving schools for young men who were about to be assigned to the motorised units of the army.

The driving schools took place by the Provincial Seats of the R.A.C.I. and in some localities through moving schools of the same Provincial Seat.

In the years 1941-42-43, in the months of July and August, the Italian Authorities organised in Pescara a "Campo Nazionale delle Motorizzazioni" and invited the R.A.C.I. to carry out special schools for perfecting the motorists and adjusters. To these schools took part the young men who had been authorised to drive motorcars and who had followed favourably the school by the Provincial Seat of R.A.C.I.

Every year 1000 - 2000 young men took part to this Campo Nazionale delle Motorizzazioni.

The Central Seat of the R.A.C.I. organised in Pescara, by the Campo Nazionale delle Motorizzazioni, moving laboratories : special school programs were organised and carried out by the best teachers. Special competitions for technical skillity were organised about 860 young men.

The Laboratories, which were manned by specialised engineers, were working during six hours one day and the motorcars too, which had been supplied by the army.
