1. Shortly after I assumed duty here on 26 October, 1944, I formed the opinion that R.A.C.I. had room for improvement.

2. About 20 Dec I instructed the director - Garrisi Ferruccio - that steps must be taken to reduce the number of motor car permits issued for the first four months of 1945.

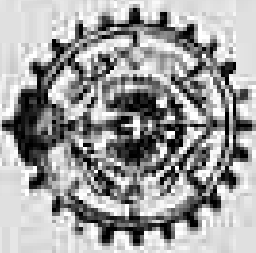

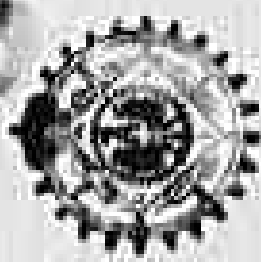

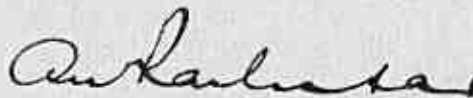
