1. With reference to your enquiry re the present position of R.A.C.I. premises. The permanent seat is still occupied by R.E.M.E. and they are using all the premises and not just the garage as quoted in the letter for the Commission Caracciolo.

It does not appear that they are likely to be free for some considerable time.

2. Great efforts were made at the time these premises changed from the 92nd Division to the 60 Sub Area, to have them released to R.A.C.I. but the Town Major refused to release them.

3. At the same time the Petrol Section of A.F.H.Q. had transferred to the NAFTA building in Genoa and were bringing considerable pressure to remove R.A.C.I. from the part of the NAFTA building occupied by them since 1945.

4. Eventually accommodation was found in the Gaslini building and R.A.C.I. have transferred their office. These premises cost 100,000 lire per annum, and is therefore a very heavy burden. This office began operating on the 6th August.

5. Any thing that can be done at high level to let RACI return to their proper offices would be appreciated.

The archives are still at their ^{original} ~~present~~ premises and great difficulty is encountered in giving access into this military establishment.
