SUBJECT : CC.RR wages

In reply to the above mentioned letter, we think it necessary to state the following:

- 1) The discharged carabiniere Spinazzi Luigi has already re-applied for the payment of what was due to him during the disbanding period viz. 14/9/43 - 22/6/44.
- 2) The request advanced along with others belonging to the CC.RR found to be in the same condition, could not be taken into consideration, according to the Min. of War because the payments in arrear for the period of disbandment are only allowed to Officers and to n.c. officers.
- 3) Troops (including CC.RR) could not have but a total amount of 1.000 lire for corporal majors and for CC.RR corporals; of 800 lire for corporals and for plain carabinieri, and of 700 lire for all soldiers in general.
- 4) This General Command has often stated to the Ministry of War that the CC.RR, having analogous status to that of n.c.officers, is entitled to the same economic treatment and therefore, for obvious reasons of equity, should have the assignment mentioned for the period of disbandment, during which period they had to sustain great sacrifices in order to avoid the oath of allegiance, adhere and collaborate with nazi-fascists, and to support each one's family.
- 5) The Ministry of War had favourable proposed the case to the "Ministero del Tesoro" for obtaining the said payments, but the mentioned Ministry did not adhere to the proposal.
- 6) An intervention of the Allied Commission for settling the case would be greatly appreciated.

1. In risposta alla lettera sopra distinta, si ritiene opportuno far conoscere quanto segue.

2. Il carabiniere in congedo SPINOZZI Luigi ha già presentato altra istanza per ottenere il pagamento degli assegni arretrati per il periodo dello sbandamento e cioè dal 14 settembre 1943 al 22 giugno 1944 data della liberazione della sua località di residenza.

3. La richiesta del suddetto militare, come quelle di tutti gli altri CC.RR. nelle sue condizioni, non ha potuto essere accolta perchè in base alle vigenti disposizioni del Ministero Guerra, gli assegni arretrati per il periodo di sbandamento competono soltanto al personale dei gradi di ufficiale e sottufficiale.

4. I militari di truppa (compresi i CC.RR.) non possono avere che un unico assegno globale di £.1.000 per caporali maggiori ed appuntati dei CC.RR.; di £.800 per i caporali e carabinieri e di £. 700 per i soldati delle varie armi dell'esercito.

5. Questo Comando Generale ha più volte fatto presente al Ministero della Guerra che i CC.RR., avendo uno stato giuridico analogo a quello dei sottufficiali, hanno diritto allo stesso trattamento economico e quindi per ovvie ragioni di equità dovrebbe

essere ad essi corrisposta la paga per tutto il periodo dello sbandamento, durante il quale hanno sostenuto gravi sacrifici per non giurare, aderire e collaborare con i nazi-fascisti e per mantenere le proprie famiglie.

6. Il Ministero della Guerra, a sua volta, ha rappresentato la questione, con parere favorevole, al Ministero del Tesoro, per ottenere la necessaria autorizzazione di pagamento, ma il suddetto Ministero non ha aderito alla proposta ed ha mantenuto invariata la contraria disposizione.

7. Si ritiene che un intervento a favore^{da parte} di questo Comando A.C. potrebbe essere molto utile ai fini della favorevole risoluzione della questione.--

Undersigned is SPINOZZI Luigi, a discharged CC.RR. of the 1903 Group. He begs to ask your Commission to issue a favourable opinion in order that he may obtain the payment of the allowances due to him for the period 14th September 1943 - 22nd June 1944, which he badly needs as his family is living in very poor financial conditions.

He points out that he was hiding himself for 9 months, facing the greatest dangers, in the woods of the MORO river, in order not to be compelled to join the Fascist Republican Government. He assures that his conduct during the German occupation is spotless and points out that his discharge is due to age limits and not to any collaborationism crime.

He was screened on the 29/6/1944 at the Bari Gathering Centre and was released on the 12/8/1944.

The allowances he is asking for are due to him according to Governmental dispositions.

He lives at CAPAGATTI - Ventignao Street - , district of the CC.RR. Abruzzi Legion, Chieti.
