1. It is considered by the FM Rome that the office accommodation used by him in the Via S. Vitale is still essential and cannot be vacated.

2. At the present moment the accommodation in this building is as follows:

a. Offices occupied by PM, Polish PM, SIB and Italian Liaison Section, number 18.

b. Offices returned to the Questura: 8.

3. As there are approximately 40-50 offices on each floor, and the building contains ground and 4 floors, it is considered by this Command that the occupation of 18 offices can in no way effect the regular functioning of the Italian Police Services.

4. It would be appreciated if all future requests for accommodation were sent to the office of the Chief of Cabinet to the President of the Council of Ministers.

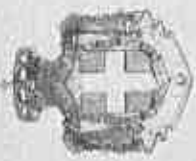
