

SUBJECT : Account Discrepancies as to Corpo Reale delle Foreste - Teramo.

In August 44, as a result of the competition fixed by decree of the Prefecture and approved by A.M.G., 30 auxiliary Forest Guards were employed by the "Corpo Reale delle Foreste - Gruppo di Teramo."

The funds necessary for those guards were estimated and sked for in the budget of the said "Gruppo" which was forwarded to you.

It was also fixed that the above said guards should have been given the sum of 2.000 lire as reimbursement of their clothing expenses. This amount was never given to them as the funds granted by A.M.G. were not sufficient.

Besides, since the 1st Oct. 44 our Office has no longer paid any money to the said "Gruppo" because as from 15 Oct. 44 Teramo Province has been handed back to the Italian Government.

Therefor the "Corpo Reale delle Foreste - Gruppo di Teramo" haven asked the Ministry of "Agricoltura e Foreste - Roma", for the funds needed to pay the october salaries to those auxiliary guards.

But the Ministry has notified that it does not want to pay such salaries as the auxiliary guards were employed by this Prefecture's decree approved by A.M.G.

Therefor the "Corpo Reale delle Foreste - Teramo" on the 15th Nov. 44 has discharged all the auxiliary guards employed as above.

But the same guards are entitled to be paid the salary for Oct. and 15 days of November, besides 2.000 lire for clothing indemnity.

The sumary expences amount to 218.000 lire which should be paid by out of A.M.G. funds, as it can not be paid by the "Ministry Agricoltura e Foreste" for the said reasons.

Therefor, we ask the Allied Finance Office for crediting the "Corpo Reale delle Foreste - Teramo" with the sum of 218.000 lire in orded to clear up the above said pendance, as the matter can be considered settled down before 15 Oct. 44, date in which the Province was handed over to the Italian Government.
