It is understood that in the case of number 2 he has a past political history and formerly served at Trieste, and there might be some objection to his appointment. Before reaching a decision in this matter, however, it would be appreciated if further information could be obtained from the Ministry regarding the past history of these two nominated officers showing where they served formerly, etc. and their positions as regards separation.
