The following extract from a letter received at this HQ from War Office, London, is sent for your information, together with the enclosure therein referred to:

"The attached photograph which appeared in the 'Leader' of 4th December 1943, has been sent to us by an Employment Exchange in London, together with some information concerning the man on the left of the picture. His name is OTEMIO PAGLIAI, and he was managing director of the firm of PAGLIAI & Co., 34/35 Gt. Sutton St., London, E.C.1. He was interned in this country on the outbreak of war and was known to be a member of Fascist organisations in London, and to have donated sums of money to Fascist funds. In 1940, at the request of the Italian Embassy, and by order of the Home Office he was released and returned to Italy. These facts have been confirmed by the Special Branch of Scotland Yard who recognised the photo.

"It appears from the photograph, which was taken on September 11th at NICASTRO, that this man has become a member of the Carabinieri, and is being employed to assist A.M.G.

"I am sure you will agree that he is a most unsuitable person for this type of work. We have consulted the Security Services who also consider that it is undesirable to employ this man in view of his known records."

Please report action taken to this Section as soon as possible.

With reference to the attached direction and photograph, on 26th January 1944, Lt. Marsh C.A.P.O., went to Nicastro, Catanzaro Province where he made enquiries at the G.C.R.R. Station and they failed to reveal any person of the name of OTENIO PAGLIAI having been or being a member of the G.C.R.R. at Nicastro or district.

In view of the variance in the uniform worn by the 2 men in the photograph by that of the Carabinieri, it is obvious that the men were of the Italian Infantry.

Lt. Marsh was informed that in September 1943, soldiers of the Italian Army had been used by a former C.A.O., in Nicastro to assist the Carabinieri.

The enquiry was continued at the 19th Infantry Regiment Troop Command where the two men in the photograph were identified. The one the subject of this enquiry is recorded and known as Corporal De Marzo Vito, a native of Bari.

Lt. Marsh before revealing to him the purpose of his visit, spoke to him in English, but he failed to understand or respond. Lt. Marsh was informed that he neither spoke nor understood English. He produced his Identity Card issued in Bari 8. 9. 38, particulars of which coincided with him, - he was described as a student, born 10 Jan 1919.

De Marzo informed Lt. Marsh that prior to joining the army he had never been to England, and that he had served continuously in the Army since 19th March 1943, checked with Army Records, correct.

De Marzo admitted that the photograph was of him, he strongly denied having had any connection whatsoever with the firm of Pagliai.

Although the photograph is of recent date it is not a good likeness, and it makes the subject appear much older than he is. The incident of the photography of these men is clearly remembered by a number of the troops in Regiment, as De Marzo and the other soldier were requested to pose for the photograph by a press photographer.

It is therefore apparent that this man is not Pagliai.
