With reference to the conversation between you and Signor BADOGLIO concerning Avv BENEDETTO DELLA CAMERA, Signi CASI RINALDO, and DELLI VENERI Pasquale at present in a concentration camp in TARANTO, I should like to say, as a native of the same province, that though they were Fascists, from 1930 till their arrest they never displayed any particular Fascist activity, and that the accusations against them by the inhabitants of MORCONE were inspired by jealousy and petty revenge which have no political foundation.

I have already passed on this information to Marshal BADOGLIO; I trust that the English Police will return at the soonest possible moment to their families these natives of my province, who are worthy of every respect and consideration.
