1. The above named was arrested. Category "B" by PSP at GKNH, Prov. Quang-Trung on 2 Dec 43, and interned with the recommendation that his case be reviewed after six months.
2. GSI(b) Eighth Army now recommends, and "A" Branch Eighth Army and this Authority agree, that he be released on the grounds of the dangerous illness of his daughter, and that he be subjected to house arrest at GKNH.
3. H.A. 2 district says he was evacuated from 368 PW camp to N. Africa on 18 Dec 43 and his present location is not known.
4. According to Para 2 (e) CMR/401/7/GI(b) of 2 Feb 44 "Internment of Civilians, Civil POW" he will now be returned to 574 Camp.
5. When that is effected it is requested that MARIO VECCHIO be released and instructed to report to the Civil Affairs Officer APO on arrival at GKNH.

Release from internment is recommended by A.M.C. *Subject* to house arrest in AGNONE.

Will you please order the release and notify this Headquarters when this has been done.

It would be appreciated if MARCO VECCHIO could be instructed that on arrival at AGNONE he must report to the Civil Affairs Officer there.

A pass to cross into FUGLIA and the Army Control Line will be issued at PARUTIA where he should report to the Control Officer q/o the PSS Section stationed there, showing his order for release and authority to travel.

3. G.S.I.(b), Eighth Army now request that he be released on the grounds of the dangerous illness of his daughter and that he be subjected to house arrest in AGNONE.
4. This Headquarters does not object.
5. He was passed through P.W. Channels after arrest.
6. It would be appreciated if the mans release from internment could now be effected, and this Headquarters informed.
7. G.S.I.(b) do not recommend that he be reinstated as a Municipal Policeman.
