SUBJECT: Unauthorized Attempt to Escape Sardinia.

TO : Deputy Chief of Public Safety, Sub-Comm., HQ, ACC. APO 394

FROM : Regional Public Safety Officer, ACC, Region 6, APO 397.

1. Under the direction of one, DE ROMANO and ANATRINI, parachutists from Sanluri, a group of seven members of the Italian "NEMBO" Paratroop Division was made up to leave this island for German-occupied Italy by means of an Italian submarine in the service of the Germans. DE ROMANO claims the presence of a German agent, who, by means of a radio-transmitter, was to arrange for the submarine to take this group off Isola Catalona, off the Gulf of Oristano.

2. At the instigation of DE ROMANO, the date of departure was postponed twice and then the whole plan was abandoned in favor of another to be arranged by DE ROMANO. The following named are now under arrest at Cagliari:

DE ROMANO
TEN. MEDICO BONELLI
TEN. DE SELLA
TEN. NICOLETTI
SOTTO TEN. BACCAZZI

ANATRINI is still at large, having deserted from his organization, a Depot Group at Iglesias. It is alleged he is carrying documents under the name of GORI.

3. The arrested men are being interrogated and results and additional information will be forwarded to your office.
