With regard to your request which we are returning herewith, I am informing you that the British subject HORTON Felix Lionel son of William and Emilie, born at Nairobi on June 27/1909, living at via Piemonte 39/4, captain of the British merchant service, on sick leave, ^{came} coming from Naples with his wife Casalucci Graniella and his sister-in-law Casalucci Anna, both born in Brindisi.

After having rent the apartment located at above said address, he left shortly afterwards with his family, for Brindisi. Most probably he will come back in January. His apartment is at present occupied by some British officers, intimate friends of his. On account of his short stay in Rome, no information can be given about his wife's behaviour and about the other items requested by you. It appears that during their brief stay in Rome, their behaviour was not liable to any remarks. It appears, however, that they led a luxurious life, engaging also a maid.

They do not have their name entered at the local Registrar office (Anagrafe) and their antecedents are free from any charge.

1. Reference to this HQ. letter PS/7 of 9th November 1944 requesting circulation of particulars of the above on behalf of the British Consul, Naples.

2. Reliable information has now been received at this Office that HORTON and his wife are residing at 39A Via Piedimonte, Interior 4, Rome.

3. At the time these two British subjects disappeared from Naples they were destitute, but it is said they are now living in luxurious circumstances and appear to be well supplied with money. If this is correct their activities must be open to grave suspicion and you may consider that an investigation should be conducted by Public Safety Division, Lazio Region, Allied Commission; thus, this report is forwarded for your information and decision.

4. This HQ. would appreciate a reply as to the action taken and the result in order that a suitable approach may be made to H.M. Consul General, Naples.

H.M. Consul-General, Naples, has asked assistance to trace a British Subject Lionel Fisher HORTON, 35 years, seaman, born at Nairobi, Kenya, and his Italian born wife - Graziella nee CASALUDI.

They were issued with British passports Nos. C 223078 and C 223079 respectively at Naples on 23 August 44.

Enquiries have been made at Naples, which indicate that the woman was a prostitute in the Docks area there, and left about a month ago, believed to join her husband at an unknown address in the Rome area. She is stated to be suffering from V.D.

Both these persons may be drawn relief from Official sources, and if located, H.M. Consul, Naples, requests information of the man's whereabouts, also that HORTON be requested to communicate with the Consul in connection with repayment of monies advanced to him.

1. Attached hereto is a copy of a letter from H.M. Consul General, Naples, in which he asks the assistance of Allied Commission to trace two British subjects, Lionel Fisher HORTON and wife - the letter has been acknowledged by this Division.

2. As a result of enquiries in the Naples area it has been learned that HORTON's wife is a prostitute suffering from venereal disease and for some time past has been frequenting the dock area here. It appears that at the beginning of October last she disappeared from her usual haunts and her associates say she left Naples with the intention of joining her husband at an unknown address in the Rome area.

3. The particulars have been circulated to all police agencies in Southern Region, but in view of the facts and the request by H.M. Consul General it is asked if enquiries to trace could be instituted in the other parts of liberated Italy through the medium of your Office.

A British subject named Lionel Fisher HORTON, born at Nairobi, Kenya, on 27th June, 1909, applied to this Consulate General for relief on 12th August last. He stated that he had been previously employed as a merchant seaman but had been paid off from a Norwegian ship as unfit for further sea service on 14th April last in Taranto, before the British Vice Consulate was opened. After he had been paid off he married an Italian girl named Graziella Casalucà. The marriage took place at Latiano, Brindisi, on 28th June 1944, before the local authorities.

2. British passports Nos. C.223078 and C.223079 were issued to him and to her respectively on 28th August last at this Consulate General. At that time he obtained employment at the Ministry of the War Transport Merchant Seamen's Transit Hotel at Naples.

3. As a result of certain incidents he left the above employment and efforts were made to find him a post on a ship, for which service he was again fit. These failed as both he himself and his wife were found to be suffering from venereal disease and he was sent to hospital. Now that he has been discharged from the 65th British General Hospital both he and his wife have disappeared.

4. I am giving you the above information for any action which you may see fit to take in the matter.
