after the 8th September 1943 served with the Republican guards, retreat- ing North in June 1944.

Although there is nothing against Ganfini, this office intends to have him examined by the police for his past activities.

It is therefore requested that he be released in order to be placed at the disposal of the competent Provincial Commission for routine police investigation.
