1. This table supersedes 13 Corps Body Disposal Ready Reckoner issued in May 1944, copies of which will now be destroyed.
2. The word "enemy" as used in categories 1 and 2 is defined as meaning German or Japanese employed.
3. AMG Proclamation No. 1 for VENEZIA GIULIA, already issued to FS Sections through I(b) channels, is only current authority in the provinces of GORIZIA, TRIESTE and ISTRIA. In the province of UDINE, AMG proclamations as used throughout ITALY are posted. FS Sections will note that offences in the two sets of proclamations are under identical reference e.g. in both sets of proclamations possession of arms without a permit from Allied authorities will be prosecuted under Proc 1, Part II, Art IV, Sec 5.
4. Any suggestions of extra categories to be added to the present publication or for inclusion in a future edition will be welcome.
