SUBJECT: "Unione Nazionale Reduci d'Italia"
(National Union of Italian ex POWs).

The Unione Nazionale Reduci d'Italia has been formed in this city with office in Via S. Giuseppe n. 86. Its aim is to morally and materially help the ex POWs; up to now there are a few hundred members.

The leaders are :-

- 1) President - BALESTRA Enrico di Luigi and di Mazzarella Elvira, born in Avellino on 17.2.1892, resident in Naples, Vico S. Mandato n.21, married, a pensioned Colonel of the Italian Army. He joined the Fascist Party in 1925.
- g) Vice President - LIETTA Arturo fu Giuseppe and di Campisi Giuseppina, born in Catania on 30.1.1900, resident in Naples in Via S. Gregorio Arsene n.24, married and has children, formerly he was a street peddler. Until 1935 he was under vigilance as a subversive person, he does not appear to have joined the Fascist Party. From our penal records it appears that:-
 - a) In 1921 he was declared bankrupt by the local Tribunal.
 - b) On 15.5.1926 acquitted by the Naples Court of Appeal for fraud whilst bankrupt (insufficient proof).
 - c) On 20.1.1927 before the investigating magistrate at Naples he was acquitted for insufficient proof of illegal possession.
