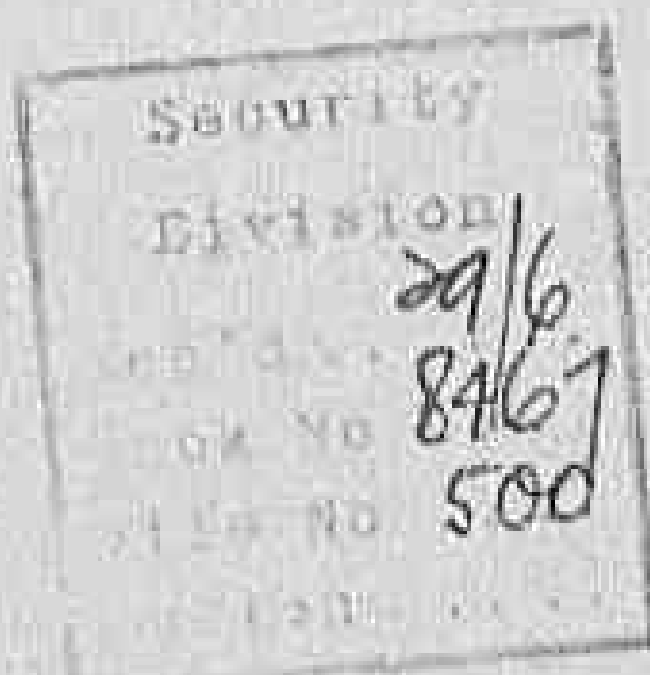

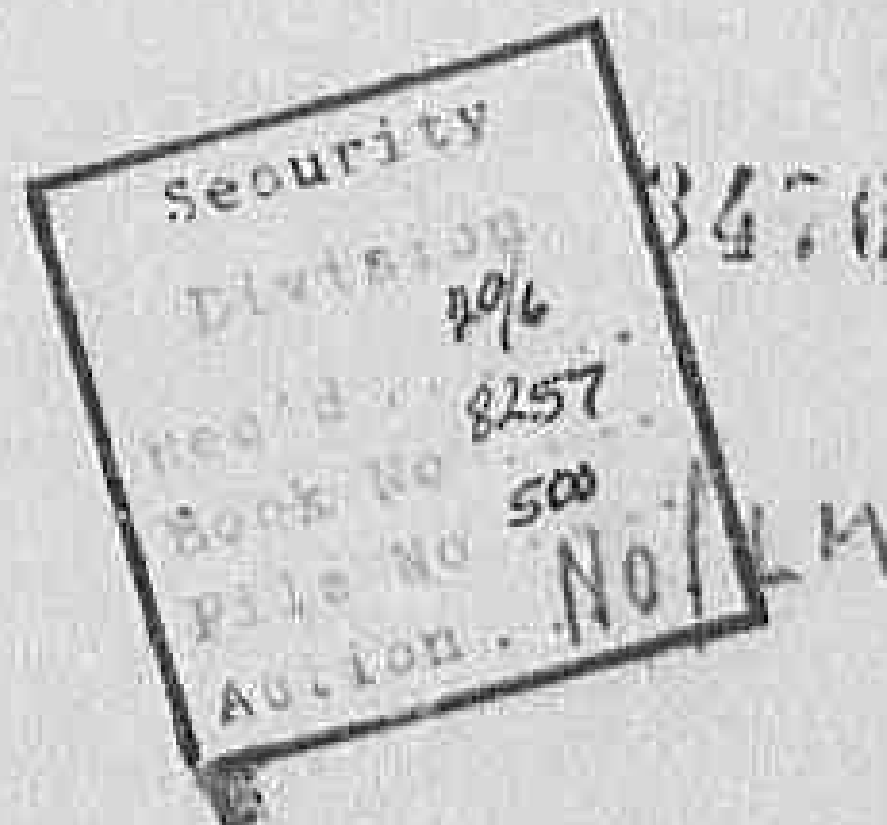

1. As the result of preliminary enquiries into the above named, facts have been revealed which would seem to preclude his participation in Banks sponsored by the Allies.
2. He was a member of the Fascist Federation of Bankers and of the Fascist Federation for Credit and Insurance. In 1943 and 4 he lived in Rome at the Excelsior Hotel, which was the residence of the German Headquarters, with whom he was said to be in close touch.
3. He was living in Milan from 1928 until 1943 and the records in that city will contain further information.
4. A supplementary report will be submitted when further information comes to hand, but unless something strikingly different from the information now at our disposal is forthcoming, I must agree with Lombardia Region that ALVINO be regarded as "persona non grata".

Dear Mr. Schott:

In reply to your letter of 28 February 1945, File P/505/HA, the undersigned has reconsidered the case of Mrs. Maria Haas, formerly employed by this organization as housekeeper at the Hotel Hassler.

The dismissal of the above individual was made for reasons which officially have not been disclosed. After a thorough investigation and interviewing all concerned, it is felt that the services of Mrs. Haas are not desirable in her former capacity as housekeeper of the Hotel. You also stated that Mrs. Haas was an essential person to the management of the Hotel. The undersigned feels that the above individual was not an essential person in that capacity, and after consulting with Mr. Wirth, a Swiss citizen and proprietor of the Hotel, it is felt that the decision of dismissing the individual is justified. Mr. Wirth further stated that whatever our decision was in this matter it would be satisfactory with the civilian management.

In the past the Air Transport Command has hired and released civilian personnel as it deemed necessary, the reasons of which it has always kept as a matter pertaining to this Command. However, after receiving your very kind letter the case of Mrs. Haas was given very serious consideration and a thorough investigation, the results being that it is felt, for the best interests of all concerned, that the individual not be retained as a civilian employee of this organization.

I trust that the above decision does not cause you any embarrassment. If at any time in the future there are any questions with reference to this case our complete file will be placed at your disposal. 3461

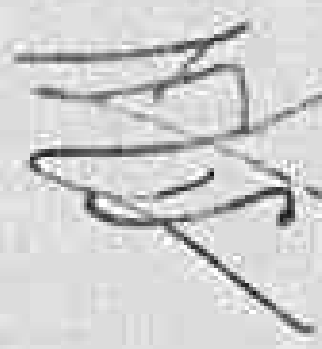

From 1937 to 1940, he was appointed Air Corps General, holding the command of the 2nd. Air Corps in Padova.

After the 8 Sept. 1943, he refused to cooperate with the Fascist Republic, but he continued to get his benefits.
After the 4 June he was expelled from the Military Service because he had taken part in the political life of the Fascist Party.

3. While there is no direct security objection to his employment by the American Division, caution should be exercised and subject should not be in a position to handle or see confidential documents.

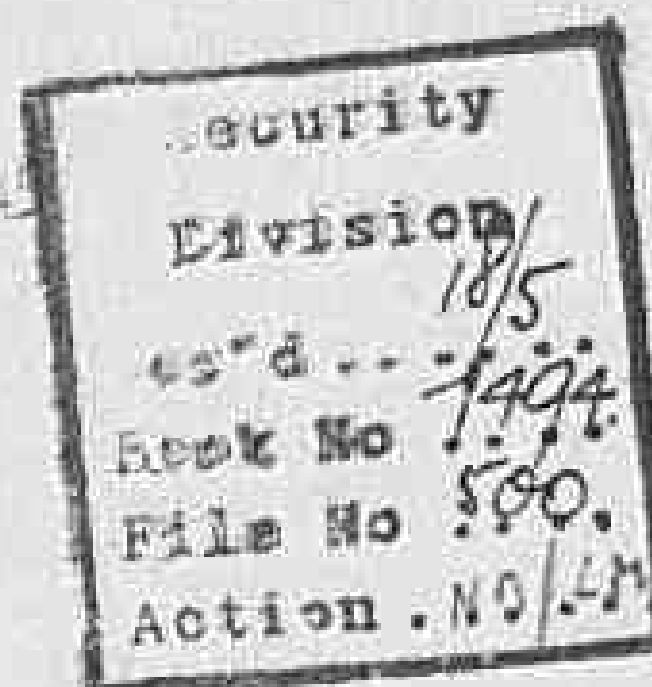

The office of DESPAX is in Corso d'Italia.

He is ^{said to be} of the equivalent rank of Colonel in the Allied Commission of which he seems to be a member.

In the past he was consul in French Marocco for two years where he collaborated with the military authorities to facilitate the landing of the Allied troops in this territory.

It seems that DESPAX has been interested by an high American officer of Leghorn in the sale of 200 new American vehicles, which are in a depot at Leghorn, if possible, only to diplomats and wealthy persons. These vehicles are to be sold because the American HQ has decided not to take them back to America.

After the collapse of the Wiener Depositenbank in 1924 DRUCKER committed suicide, but it was much commented at the time that he had been able to leave a considerable part of his wealth to his wife by fraudulent transfers. From 1939 Subject and Mrs. DRUCKER were together in France and were seen in Algiers as early as Nov. 42.

"10. It should be re-emphasized that the above accounts are still in the process of verification.

"11. Upon termination of Subject's service with OSS, it was known that he was in close touch with the French Intelligence Service in Rome.

"12. In your reply to Major Heath, RSO, AMG, Lombardy Region, please make clear that OSS takes no responsibility for any of Subject's activities. And further, that none of the information contained in this memorandum should be used as the basis of action against Subject."
