Owing to the neormous difficulties and hardships which life imposes today on nearly everybody, many people would find some solution to their problems if they could temporarily go to other places where they have friends who are willing to help them, as alien subjects, under the present regulations, are not allowed to work and are therefore unable to fend for themselves.

We would appreciate very much to know whether there is any possibility to waive the above order in exceptional cases and allow needy persons to transfer themselves temporarily to some other town.

This information has also been asked from the competent Italian authorities, which suggested to us to approach you on this question .

The two undersigned men of the Anti-Nazi Socialist League have asked the Allied Control Commission to certify their organization as they are performing their duties in office.

Reasons:

We already have correspondences in Allied Commission in Rome and Hq. Caserta and leaders of the organization have already worked together with Allied officers for over 1 year-- the PWB, CIC, FSS, SOI, G-2, G-5, and RAAC.

We were established as secret organization in 1942 and received on 29 June 1944, through Allied Control Commission, permission for establishing office in Rome. Announcement to the effect published by Allied Government in paper called "Courier de Roma".

The political aim of organization is to carry out program named in letter.

For administrative reasons it was necessary that German office be established under leadership of signers of letter. This office also approved by Allied Commission and announcement published 3 February 1945 in all Italian newspapers.

Chief aim of German Bureau was at first that all Germans in Italy register (without regard for political viewpoints of this organization) and all Germans not willing to call on Swiss Legation because Swiss Legation operated by order of Nazi Government.

Since May 1945, German Government no longer exists and Swiss Legation will regard it as finished and said to Germans that they must call on German Bureau for help, because it is only agency of Germans and undersigned called on Col. Fisher, RAAC, and obtained his agreement and called on Italian Government for official recognition which was granted on 21 July 1945-
 No. 40716/34182/15.2.

It was agreed between German bureau and Italian Gov. that the undersigned men establish throughout Italy with Rome as Hqs.

We hope that these establishments agree with the rules of Potsdam conference and Allied Control Comm.

The personnel of all the offices and their political past as examined by competent authorities, Italian and Allied, I have the trust of the Allies and after one year of work ask that they be recognized officially by the Allies and that the undersigned be appointed as officers by Allied Authorities.

We hope therefore that proper diplomatic steps will be taken so that we will be recognized in order to better facilitate the keeping down of Nazi movements and restorations in Germany.

Auch das "Deutsche Büro" wurde von den zuständigen alliierten Kontrollbehörden Gutgeheissen und dessen öffentliche Bekannmachung wiederum mit deren Erlaubnis (bestätigt durch das OIC mit Datum vom 5. Februar 1945) in allen italienischen Tageszeitungen geschehen ist.

Hauptzweck des "Deutschen Büros" war zunächst der, alle jene Reichsdeutschen in Italien zu registrieren und zu betreuen (und zwar ohne Rücksicht darauf, ob sie die politischen Voraussetzungen für die Mitgliedschaft zur D.A.V. erfüllen oder nicht), welche nicht gewillt waren, sich bei der Schweizer Legation, Abteilung für deutsche Interessen, zu melden bzw. sich von ihr vertreten zu lassen, da dieselbe im Auftrage der Naziregierung amtierte.

Seit Monat Mai ds. Jahres, nämlich seit dem Nichtmehrbestehen einer deutschen Reichsregierung betrachtete die Schweizer Legation ihren Auftrag als erloschen und verwies von da ab die Reichsdeutschen an das "Deutsche Büro". Nunmehr als einzige Mittelstelle oder Vertretung der Deutschen verblieben, stellten die Unterzeichneten nach Vorbesprechung mit dem RAAC (Col. Fischer) und mit dessen Einverständnis Antrag bei der italienischen Regierung auf offizielle Anerkennung. Die amtliche Bestätigung erfolgte auf Beschluss des italienischen Ministerrates durch Mitteilung vom 21. Juli 1945 unter der Nr. 40716/ 34182/ 15.2 .

In weiterer Ausführung dieses Ministerratsbeschlusses wurde zwischen uns und der italienischen Behörde (Questura bzw. Innenministerium) vereinbart, dass die Leiter der Zentrale Rom des Deutschen Büros, fungierend in Form von kommissarischen Generalkonsulen in lokaler Selbstkontrolle für Italien, eine Gesamtkontrolle sämtlicher zur Zeit in Italien befindlichen Reichsdeutschen organisieren und zu diesem Behufe in allen wichtigen Zentren Italiens Zweigstellen errichten, welche von Vertrauensleuten der Zentraleitung Rom geleitet werden. Die durch uns vorgenommene Personalprüfung, Ausstellung von Dokumenten und sonstige Betreuung geschieht in engstem Einvernehmen mit den italienischen Behörden. Zwischen den anglo-amerikanischen Sicherheitsbehörden und uns besteht seit langem eine Abmachung- welche selbstverständlich auf die Zweigstellen erweitert wird- wonach ihnen von uns die Personalunterlagen aller neu Registrierten jeweils zur Überprüfung vorgelegt werden. -

Da diese Gesamtregelung dem Sinne der Potsdamer Beschlüsse entsprechen dürfte, glauben wir hierfür auch die endgültige Zustimmung

Da selbstverständlich schon vor Erteilung der jeweiligen Erlaubnisse Personalien und politische Vergangenheit der unterzeichneten verantwortlichen Leiter, aber auch die ihrer massgeblichen Mitarbeiter von allen kompetenten Stellen auf das Genaueste überprüft wurden und uns ferner von allen alliierten wie italienischen Behörden nach über einjähriger Zusammenarbeit vollstes Vertrauen geschenkt und vollste Zufriedenheit mit unserer Arbeit ausgedrückt wurde, zweifeln wir nicht daran und ersuchen darum, dass das Deutsche Büro der D.A.V. nunmehr von der zuständigen alliierten Kontrollbehörde offiziell anerkannt und die unterzeichneten Leiter in der vorbenannten Eigenschaft entlich beauftragt und beglaubigt werden. - Wir glauben dies umso mehr, da es sich ja keineswegs um eine diplomatische Position, sondern um eine lokale konsularische Tätigkeit, ähnlich der Eigenschaft einer provinziellen Selbstverwaltung in Deutschland handelt, wofür ebenfalls zuverlässige Antinazi als Verantwortliche berufen worden. NEW ANTINAZI GERMAN ORGANIZATION IN ROME

" Having the task of settling the actual and future position of German and ex German subjects, who have remained in Italy we beg you, as soon as possible, to call at our Office in Piazza di Spagna No. 35 (courtyard on the left) bringing all your personal documents."

Calling time: From 9.30 to 13 hours.

Extract from enclosed printed circular):

" The D.A.V., founded over 2 years ago by the German Committee Consisting of Dr. Willi NIK, C.B. TODD, Prof. VOLBACH, Dr. MUNCH, L. MUCKERMANN and others opened its first official bureau in Piazza di Spagna 35 on the 1st of July 1944, with the consent of the local Allied Authorities in Rome." The D.A.V. gives a brief report on its activities during the first 6 months and at the same time presents to German subjects who do not yet belong to the Association, a prospectus as to its future purposes and aims."

MEMORANDUM FOR THE OFFICER IN CHARGE:

Subject: DR. WILHELM NIX (NIX Von Lilien-Welöma)
Chairman, Anti-Nazi Group, Rome.
Viale Spagna No. 35, Rome.

1. Pursuant to request Floyd C. Snowden, Chief, CIC Detachment, RAAC, investigation of above Subject was conducted, following receipt of information this office that Subject was a political security threat.

2. Subject's description is the following: age 38, height 5' 7" weight 130 lbs; dark hair; blue eyes, wears spectacles; temperment, highly nervous. Subject at present is residing in Villa San Francesco, in Viale Martiri Eroeisti, Rome.

3. Personal history of Subject: born January 14, 1906 in Sel-ingen, Germany to Dr. NIX VON LILIEN-WELÖMA; attended elementary school at Herford-Westphalia; Gynasium in Osnabrueck, where Subject graduated in 1925. From 1926-31 Subject was a medical student at Goettinger and Moonster Academy, Berlin; in 1932 Subject became editor of the cultural monthly review "DIE ANKER", later suppressed by Nazi Government in July of 1933. According to Subject and confirmed by Lt. R. S. HATTING (correspondent and intelligence representative to French General Command, Rome) Subject was ordered arrested by SS in August of 1933 whereupon Subject fled to Austria where underground Subject worked for the Austrian Propaganda Service directed by Dr. ERNEST HAUSER, Manager of the "VIENNA LISTUNG", an anti-Nazi periodical, also later suppressed by Nazi Government. From 1934 to 1937 Subject broad-casted on the Austrian radio on social questions. In December of 1937 sub-ject states he was arrested by the Gestapo and interned at the SS concentration camp at RECHENBERG, Germany and held for high treason. In May of 1938 Subject was transferred to the concentration camp at MATHHEIM and in July of 1938 Subject was confined to SACHSENHAUSEN, near Berlin Oranienburg. Subject in August 1938 escaped to Austria and came to Italy in latter part of 1938. In 1940 in Italy, by decree of German Embassy Rome, Subject was deprived of his German citizenship. From 1936 to July 1944, Subject engaged in medical work at various religious institutions in Rome and together with Monsignor ROBERTO and Monsignor O'PLACENTY and Royal Legation RAAC

Subject: NIX, Dr. (Cont'd).

Rome, Subject gave his entire medical help to English, American and Yugoslavian prisoners of Rome who endeavored to escape from German camps stationed outside Rome. On April 10, 1944 Subject's residence at Via Palestro No. 49 was searched by SS Via Tasso unit Rome. Subject at time was residing in extra territorial house of Nuns (Suore dell'Addo Lorata Via Borgo S. Spirito No. 41, Rome).

4. The following named individuals have known Subject in both Germany and Italy and have substantiated the above personal history of Subject: Cardinal TISSERAND, Vatican Prelate associated with Harold TITMAN, American Charge d'Affairs in help of American prisoners of war; Professor VOERAGE, Vatican; Mrs. Myler PRAZ, stepdaughter of D.L. MURRAY, editor of Times Literary Supplement; Monsignor O'FLAHERTY, Campo Teutonico; Monsignor MOSCATELLO, Charge d'Affairs at Holy See for Yugoslavia.

5. Attached hereto and marked "Exhibit #1" is a copy of original letter sent by Cardinal Tisserand to Major Battersby, AOC, on behalf of Subject. After investigation by Major Battersby's office Subject was permitted to open his German office of Assistance, located at Piazza Spagna No. 35, Rome. Exhibit #11 attached hereto is a report on Subject and his committee prepared by W.L. MURKIN, German Political Intelligence, EMB, WAAC, who states that both Subject and his group are useful as sources for political intelligence and contacts thus far have proved useful. Exhibit #111 attached hereto is a personal statement of Dr. NIX and G.B. to the Bohrer Section of Anti-Nazi Group, Rome.

6. On 21 September 1944 these Agents had Lt. P.A. MARTINE, of French General Command, Rome in this office, who stated that he knows Subject personally and had attended on behalf of his French Command many of the meetings of Anti-Nazi Group Rome. According to Lt. Martine there is no security threat attached to Subject.

7. On 2 November 1944 these Agents interviewed Captain KERR, SOI Rome relative to security status of Subject and security of operation of Anti-Nazi Group Rome. Captain Kerr stated that he knows Subject and most of members of Anti-Nazi Committee Rome; that neither Dr. NIX nor Anti-Nazi Group presented any immediate security threat. Captain Kerr further stated that the British Agents attached to their service are members of committee and have daily contact with both Subject and his organization; that the organization is used for certain work in connection with German Embassy to Holy See. Captain Kerr saw no reason for interfering with either group or Subject, at this time.

RECOMMENDATION:

Summary

For the present time, it is recommended that both Subject and his group be allowed freedom of activity. ECI are closely in touch with Subject and his organization and suspicious activity on part of either Subject or his group can be more intelligently controlled through operations in the open rather than forcing such movements to disband and to operate in separate houses.

It is recommended that this case be closed.

 - C. That the aims of D.A.V. are not known, and are possible mischievous.
