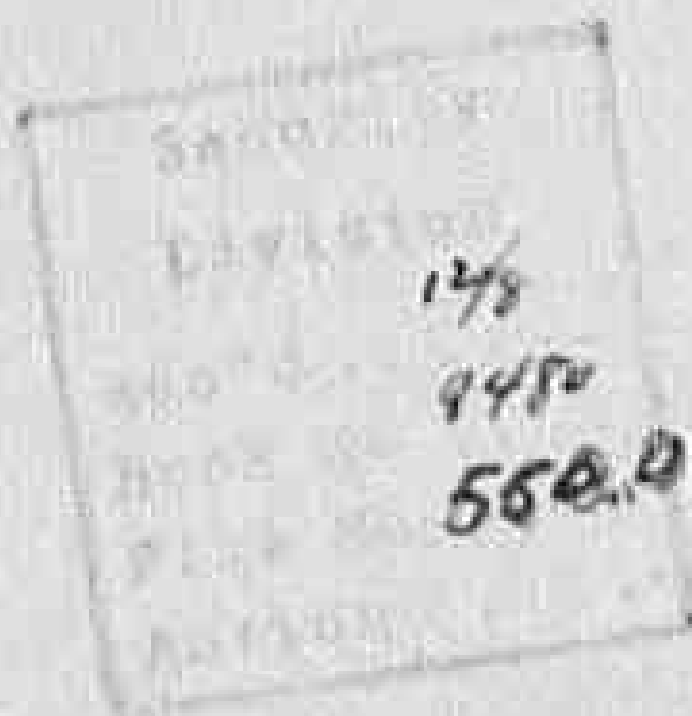

1) GIORGIO DE SEBASTIANI (or Sebastianis) - witness in the penal proceedings against Del Vecchio who is accused for having collaborated with the Germans.

2) Avv. DIANA MARIO.

3) MAYER SILVIO - witness in the penal proceedings against Republican soldiers accused for espionage.

4) PISCITELLI NICOLA - witness in penal proceedings against De Martino Emilio and others.

550.09-10 { 5) ROTUNNO ANTONIO DI NICOLA - accused for making alcohol clandestinely.

6) D'AMORE VITO - German police agent, witness in the penal proceedings against Di Censo accused for collaborating with the Germans.

7) WURSBURGER MARIO - accused for collaborating with the Germans.

8) POLVERELLI GAETANO DI G. BATTISTA - accused for fascist Crimes.

9) CAVIGLIA PIETRO FU GIOVANNI - Accused for malversation.

10) CAFOLLA ANTONIO di Augusto - accused for robbery.

11) COREA NICOLA fu Antonio - accused to be false.

In addition I asked you for the release and delivery of MARCIANO ARMANDO fu Pasquale who is to be arrested because accused for fascist crimes and collaboration with the Germans.

The a/m letters have remained without an answer. Fearing that such letters have been lost for postal disguidance I repeat the request begging your Commission to give the necessary instructions to the Camp "A" Commander for the interrogation and also for the delivery of the prisoner Marciano Armando.

Being that the proceedings mentioned above are against arrested persons the definition is very urgent and we therefore beg your Commission to kindly give us an answer as soon as possible.

Dear Colonel,

I am enclosing herewith copy of a letter of the Public Safety
Sub-Commission concerning Visconti Luigi.

While I was Regional Commissioner of Aquila, the above-named
was interned, and, contrary to the letter, was later released
by the Italian Authorities and given a plain "go out". The
letter in question was apparently overlooked by the Questura.
He was subsequently rearrested and, pursuant to the letter
herein mentioned, returned to the custody of the Allied Authori-
ties. This man is still detained.

The family have communicated with me. It seems as though no
one in the Italian Government know of any reason why the man
should be detained and that there are no charges against him
as far as the Italian Authorities are concerned. He was in
a camp at Terni. This camp has now been dissolved and he
has been moved to another location.

It looks as though the man might be detained without any ac-
cusation being lodged against him. I feel it would be just
if you would have somebody look into the matter and advise
the prisoner if he is being detained at the request, or on
behalf, of the Allied Authorities or whether he is being de-
tained at the request of the Italian Government.

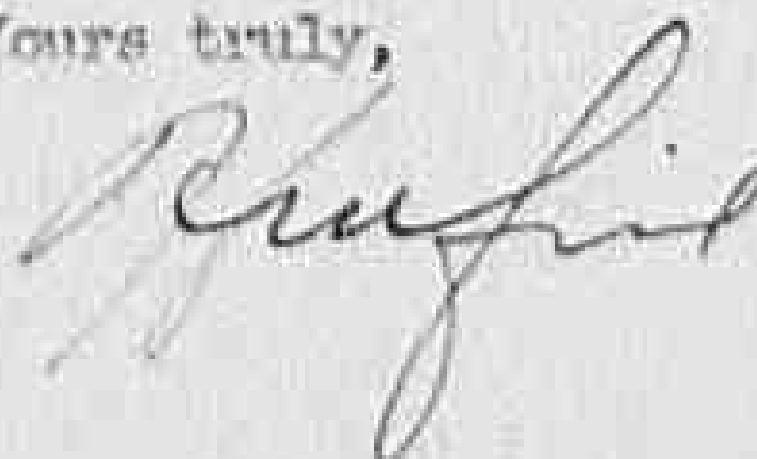
I think it is highly prejudicial to the goodwill of the Allies
to have this man in jail or in a concentration camp without
even knowing whose prisoner he is.

If you would be kind enough to do this general rumour concern-
ing his detention unjustly could be allayed.

I have no interest in this case except that on my visit to
Aquila last week I noted it was the subject of wide discussion
and I felt that as an American officer I should bring the mat-
ter to your attention.
