

1. As directed, I have seen Col. E.B. Nichols, A.C. of S., G-2, AFHQ., on the matter of the Gaming House at Campione d'Italia. He has sent a report to G-5 for a decision as to whether or not the order closing the house should be rescinded. G-5 has replied that, as they only have the G-2 angle it would not be proper for them to give an opinion, especially as the matter had not been referred to them by the Regional Commissioner concerned, through this Headquarters.

2. I informed Lt. Col. Seagrave, G-5 of your knowledge of the matter, and he said that it was a matter with which you yourself could deal, or, if you preferred, refer to G-5. I promised to let him know the decision.

3. The whole of the papers in my possession are attached. Briefly the position is that at CAMPIONE D'ITALIA, in the province of Como, is a well known gaming house situated on the shores of Lake Como. It is surrounded by Swiss territory, and special steamers run across the lake from Lugano taking Swiss nationals who wish to play. Before the war it was run by a Company S.A.I.T., the most prominent member of which was a certain BELLONI, but speculation in currency and contravention of Italian laws regarding foreign moneys caused it to close shortly before the start of the war.

His son was the Air Attache at Madrid for the Fascist Republicans from March, 1944 until the end of hostilities. Col. Poletti had been approached by BELLONI, and subsequently made an order closing the casino under its present management. This order has not been put into effect, through the intervention of the intelligence agencies, who see their efforts on the verge of frustration. It is doubtful if Colonel Poletti knew the full facts when he made the closing order.

6. The present position is that the Provincial Commissioner of Como has instructed the Prefect to close the casino, but in view of further developments to take no action if for technical reasons the premises have not yet been closed down, in fact.

7. The issue really boils down to which of the two interested parties will run the house. That it will in fact operate in the future is certain, as the finances of the Commune depend upon it. The Allied interest is in keeping the place open from a long term intelligence point of view. On the other side it has the duty of closing undesirable gambling haunts; the R.F.S.O., however, states there is no objection to this place from a Public Safety point of view.

8. Col. Nichols is not interested in which party runs the Casino, so long as it is open. He does point out however, that if BELIACI or his associates are in charge it is almost certain that his schemes will not come to fruition.

9. In a short time the role of the Allies will be purely advisory in this area. The solution may be found in merely not enforcing the closing order if the present Regional Commissioner is reluctant to override the decision of his predecessor in so short a time, and I think Allied interests will best be served if the premises are permitted to remain open under a trustworthy and cooperative management, such as the new one.

SUBJECT: Gaming House.

TO: Public Safety S/C (Attn. Security Division).

Col. HANCOCK, Regional Commissioner LORRAINE Region, phoned me this afternoon at 1600 hrs on the following subject:

A Gaming House has been opened in COMO Province at a place called CASINO DE ITALIA. To get to this Gaming House one has to go through SWITZERLAND.

Col. POLINI, late Regional Commissioner, wrote a letter to the Provincial Commissioner, in full agreement with Col. HANCOCK, ordering that the Gaming House should be closed as Gaming Houses were not allowed in AIT Territory.

While this was going on it transpired that a British Intelligence Unit known as SOI had some particular interest in getting this place opened. When SOI heard that AIT were trying to close the place down they wrote to AFHQ and have since got the letter back endorsed by AFHQ that the house should remain open.

It is understood that Col. E.S. NICHOLS, G-2, AFHQ has been handling the matter.

Col. POLINI, who is at present in ROE had, previous to Col. HANCOCK, taking it over, dealt with it personally and knows all the details so Col. HANCOCK suggested it might be a good thing to get hold of Col. POLINI but this may be difficult.

Col. HANCOCK wants to get the matter cleared up and he does not propose to cancel the closing order unless he gets instructions from this Headquarters. In the meantime he is marking time.

Can we take the matter up with AFHQ and get the matter settled?

SUBJECT : Gaming House - Como.

TO : HQ. A.G. Public Safety Sub-Commission
(Attn. Major Harvey).

1. Attached is a copy of a report submitted by the R.S.O. with regard to the Casino at Campione, which was prepared after a meeting between Major Smith, the R.S.O. and myself.

2. Col. Nichols G.S.C. Asst. AC of S.G-2 asked that action be suspended until Maj. Smith could obtain a further decision through A.F. HQ.

3. The Regional Commissioner has asked V.P - C.A. for instructions after acquainting him as to the facts. Meanwhile the P. C. of Como has instructed the Prefect to close but in view of latest developments to take no action if for technical reasons the Casino has not yet in fact closed down.

4. There is no objection to this place from the Public Safety Division point of view.

SUBJECT:- Campione Casino - CAMPIONE (Prov. of COMO)
TO:- Regional Commissioner

1. During August 1945, this R.S.O. was informed by Maj. SMITH, C.O. N°3 S.C.I. Unit., that it was hoped that the Casine at Campione would shortly be opened under new management and with the knowledge and support of Allied Security, more particularly his Unit and the S.I.M.

2. Maj. SMITH added that arrangements had already been made to introduce selected agents into the management or staff of the Casino. He stated that the main advantage to Security was to apprehend German or other enemy agents, some of whom were known to be in Switzerland and would conceivably be enticed to Campione, well known for its gaming and other attractions. He added that there would be no threat to Allied Security and that no Italians, other than the local residents - entirely dependent upon the Casino and other amenities for their livelihood, would be admitted. This would be a very simple matter in so far as the Commune of Campione is entirely surrounded by Swiss territory. Moreover, the play would be in Swiss Francs.

3. In conclusion, Maj. SMITH asked me to explain this matter to the Regional Commissioner if the question were ever raised - he would be prepared to give a full

explanation of the Allied Security interests in the re-opening of the Campione Casino.

4. On Wednesday last week, Maj. SMITH called to say he had been informed that the Casino, which had been opened for several days and which had necessitated considerable expenditure and trouble on the part of the promoters, was to be closed by order of Col. POLETTI. ~~It was closed by the Italian Authorities and the contract terminated.~~

5. Subsequently, you will recall Maj. SMITH and I discussed the matter with you. I understand that the case was submitted to AC HQ. for a decision.

6. It has been reported that the Company which previously ran the Campione Casino ceased to function prior to the outbreak of war owing to speculation with currency and contravention of Italian Laws concerning foreign moneys. Certain names have been referred as being concerned with this Company and include :

Avv. RIBOLDI - Rag. ZANOTTI - Sig. PAPA - and a certain Sig. BELLONI - the latter a former managing director of the San Remo Casino.

These men - more particularly BELLONI - were compromised with Fascism and I believe that in the case of BELLONI, he was publicly thanked for a donation to the Republican Fascist cause. I believe the document is in possession of Maj. SMITH.

7. Irrespective of any litigation between interested parties, in my opinion it would be desirable to allow, or at any rate not prevent, the Campione Casino to operate. As far as the Police regulations go, I understand that the R.P.S.O. is submitting a report to you.
