1. The above named was arrested in MILAN for stealing a bicycle and was acquitted by the Italian Courts on 7 May 46.
2. The Italian Authorities have now informed the Public Safety Liaison Officer, MILAN, that PACCIO is to be detained at Allied disposition as he is alleged to have escaped from a concentration camp at POTENZA.
3. May this HQ be informed if you have any record of subject being wanted by Allied authorities or can he be released.
4. This HQ is informed that there are many prisoners in jail at MILAN who have been dealt with by the Italian Authorities and acquitted by are detained at disposition. Liaison Officer, MILAN is being requested to obtain a detailed list which it is proposed to submit to your HQ on receipt for disposal instructions.

he escapes from Concentration Camps at  
Pinerolo.

Paietta Chief of Communist Party, have  
applied for passport to go to France, and  
he is being given passport tonight.
