Subject: Supervision for unloading Coal at CIVITAVECCHIA.

1. A certain Sign. FIANZI of the Ministry of Communication called on this Section, stating that as a result of certain conferences held by the Ministry and Col. QUAY of your sub-commission, it was desired to issue passes to four men which would enable them to enter the port of CIVITAVECCHIA to supervise the unloading of coal in that port.

2. In this connection reference is made to a telephone conversation held by the undersigned with one of your officers yesterday.

3. It is confirmed that this Section does NOT issue passes for entry into CIVITAVECCHIA port. However, in order to assist your sub-commission, the four men in question have been vetted.

4. There are no security objections on record against,

GIULIO Carlo fu Cesare, Via Appia Nuova 349, Rome, or
DE MARINIS Alberto Mario fu Giovanni, Via Treviso, 43, Rome.

5. The other two men, via :-

were both members of the Fascist Voluntary Militia and have accordingly been disincriminated. They are NOT to be employed by any allied organization.

6. Attention is drawn to the fact that in the normal course, vetting of civilians employed by A.C. is done through the Security Branch, A.C. (Int. Army).

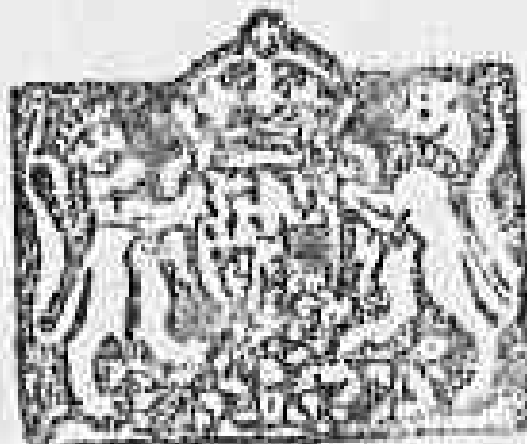

Part I. - General Staff.

366. Use of Long distance telephone facilities in Italy.

1. There are now several large naval, military and air force HQ established in ITALY, which are distributed over a comparatively narrow but very deep area. This has produced many problems in connection with the "long distance" telephone service. The term "long distance" includes direct long line circuits between the switchboards of major headquarters, and is not limited to calls placed through the NAPLES, ROME, or BARI long distance exchanges.

2. In order to obtain the maximum efficiency from the available telephone facilities, it is essential that all telephone users should co-operate. The following will be brought to the notice of all concerned:

(a) "Long distance" facilities are limited and will not be used when the subject could equally well be covered by a message.

(b) If a "long distance" call is essential, it must be as brief as possible. Notes should be made before-hand of the subjects to be discussed in order to prevent waste of time. When a call has been booked, the caller must remain immediately accessible to the telephone, or the call must be cancelled.

3. All telephone users are notified that a monitoring service is being established. Violation of the above principles will be reported to the commanders concerned for corrective action.

367. Demands for vehicles and G(SD) controlled stores.

1. All demands for vehicles and G(SD) controlled stores made to 2 District dated prior to 20 Aug 44 will be considered cancelled as from 20 Sept 44.

2. With reference to 2 District GS Instruction No 11 dated 4 Jun 44, no demands for vehicles or G(SD) controlled stores will be rendered on either 20 Sept or 30 Sept 44. A demand will be rendered on 25 Sept 44 and afterwards as ordered. NO interim demands will be considered unless operationally urgent.

3. Releases will continue to be made against all demands up to 20 Sept 44, and after 20 Sept 44 against demands subsequent to 19 Aug 44 only.

2404/G (SD2)

368. Civilian Passes.

1. If the security control of civilians is to be effectively exercised, it is essential that civilian passes should be issued on a uniform basis.

2. There are three standard pass forms in use in this theatre, viz.

(a) The ACC/AMG Pass - (See para 3 below).

(b) The Brown Military Permit. This is for strictly limited use by intelligence staffs of higher HQ to persons employed on special intelligence duties. Application for such permits should be made to G.S.I. 2 District.

(c) The White Military Permit. This is for issue to Allied civilians, employed with the Allied Forces (e.g. EFI or CVWW, etc). Applications for such permits should be made to GSI 2 District.

3. (a) Passes for civilian movement, exemption from curfew, circulation of motor vehicles, etc, will normally be issued by ACC/AMG.

(b) The latter will be the ONLY issuing authority in respect of passes required by civilians for private, business or civil administrative purposes.

(c) If any responsible Allied military authority has occasion to employ a civilian or group of civilians on a particular operational or intelligence task requiring the issue of a pass, and if it is impracticable, owing to the time factor or other circumstances, for the appropriate ACC/AMG pass to be obtained, the military authority concerned may make out a temporary pass for the purpose.

(d) Any such pass must:

(i) Be properly identified with the person to whom it was issued: i.e., the latter's name, identity card number and signature must be shown on the pass.

(ii) State precisely what the holder may do and where he may go.

(iii) Bear the legible signature of the issuing officer.

(iv) Show the limited period of validity.

(e) ACC/AMG passes issued to public utility workers, etc., may be endorsed either by the issuing officer or by the unit employing them, to cover any particular aspect of their work, as may be considered requisite.

4. All irregular passes already issued will be withdrawn and, where necessary, replaced by others issued or made out in accordance with this order.

369. Staff Equipment Tables.

1. With reference to GRO 464 of 1944, large numbers of demands for G(SD) controlled stores have since been received by the OS Branches of Area and Sub Area HQs.
2. Formations and Units are reminded that staff control of equipment is maintained for certain items because they are in short supply, and so as to ensure that available stocks are diverted into the channels where they are most needed. Indents for G(SD) controlled stores will NOT therefore be submitted purely on grounds of entitlement, but only when there is a genuine need of the items concerned for operational or other essential purposes.
3. Attention is also drawn to the fact that where there is a difference of entitlement shown in the Staff Equipment Table and the latest published War Establishment or G 1098 scale, the Staff Equipment Table is the operative document. Stores rendered surplus by the publication of Staff Equipment Tables will be returned to Ordnance within 10 days of receipt of such tables by units concerned.

Capt. CROW of Tunis Sub District, in charge of removal to Africa of P.O.L. stores in Lampedusa, requested during his permanence in the Island, the release of BETTELLA Bruno (mechanic) whose services were needed aboard the vessel MARIANTINA which was transporting the said P.O.L. In view of the fact that BETTELLA Bruno might go home (MILAN) at some future date, I was also requested a travel permit which I was assured would not be used until such time when either Leghorn or Milan would be freed from German hands. Evidently their promise was not kept.

A certain number of Italian civilians, not employed by this Camp, are going to be given passes to enter the Camp for such purposes as attending to fruit trees, collecting laundry etc.

Each man will be given a pass, written in both English and Italian and signed by the Adjutant. This pass will be valid for one month from the date of issue, and it lays down the hours between which its bearer may be in the Camp. It also orders the bearer to report to the Guard Room when he arrives and departs.

These passes will be made out in duplicate, the second copy being sent to the Guard Room, which they will retain for reference, and from which the N.C.O. i/c Regimental Police will compile a register of Pass-Holders.

To ensure, therefore, that only permitted civilians enter the Camp all Wings will check up from time to time the passes held by civilians seen in their lines, and the N.C.O. i/c Regimental Police will report immediately to this H.Q. any civilian, holding such a pass, who fails to comply with the regulations contained therein.

1. Reference is made to 316/76/CA of 26 April 1944 (a copy of which is attached for easy reference).

2. Para. 4 (f) of 316/76/CA is hereby amended to read as follows:

" (i) Government Officials of the Central Italian Government.

The method of issuing passes to Government Officials of the Central Italian Government will be as follows: the official will apply to the corresponding ACC Section, Sub-Commission or Branch for a pass. If approved, Sub-Commissions or Branches of the Admin, Economic and R.C. & M.G. Sections will forward the passes in duplicate through their Sections to the Secretary-General for signature. In the case of the Political Section, Independent Sub-Commissions and Public Relations Branch, passes approved by them will be forwarded direct to the Secretary-General for signature. All passes in duplicate will be on the standard A.C.C. yellow and blue forms and will bear the following endorsement, before they reach the Secretary-General:-

'The facts set forth in this pass have been verified and the provisions of letter no. ACC, file 316/76/CA 26 Apr 44 have been fully complied with.'

(ii) Special passes for Ministers of the Central Italian Govt.

Special passes will be available for Ministers of the Central Italian Government. Such passes will be issued by the Sub-Commissions concerned in duplicate and forwarded through their Section to the Secretary-General for signature. The passes will be on the ACC yellow and blue forms only and will be made out to cover movement anywhere south of the Army Control Line. They will

Government Officials of the Central Italian Government

The method of issuing passes to Government Officials of the Central Italian Government will be as follows: the official will apply to the corresponding ACC Section, Sub-Commission or Branch for a pass. If approved, Sub-Commissions or Branches of the Admin, Economic and R.C. & K.G. Sections will forward the passes in duplicate through their Sections to the Secretary-General for signature. In the case of the Political Section, Independent Sub-Commissions and Public Relations Branch, passes approved by them will be forwarded direct to the Secretary-General for signature. All passes in duplicate will be on the standard A.C.C. yellow and blue forms and will bear the following endorsement, before they reach the Secretary-General:-

'The facts set forth in this pass have been verified and the provisions of letter HQ. ACC, file 316/75/CA 26 Apr 44 have been fully complied with.'

(ii) Special passes for Ministers of the Central Italian Govt.

Special passes will be available for Ministers of the Central Italian Government. Such passes will be issued by the Sub-Commissions concerned in duplicate and forwarded through their Section to the Secretary-General for signature. The passes will be on the ACC yellow and blue forms only and will be made out to cover movement anywhere south of the Army Control Line. They will be for a period of three months and will bear the following endorsements:

'S..... (designation of office) is hereby authorised to proceed to any part of Italy south of the Army Control Line. He should be given every facility and courtesy.'

After signature by the Secretary-General the passes will be forwarded by him to HQ. AAI G.S.I. (b) for counter-signature.

1. Introduction.

It is evident that the enemy intends to continue his efforts to introduce espionage and sabotage agents into Southern Italy on a considerable scale. In order to meet this threat and to neutralise as far as possible the activities of such agents, it has been decided that a wider and more effective system of control of civilian movement will be introduced.

Allied Control Commission Officers are therefore requested to accord the Military Security Services every possible assistance, and to see that the restrictions referred to herein are properly and strictly imposed.

2. Restrictions.

(a) Army and Corps Areas.

In the Army (and Corps) areas the existing regulations will continue to apply whereby civilians are forbidden to travel more than 10 km. from their own homes without a valid pass.

Those civilians who wish to proceed into such areas will require to obtain a special pass which will normally be issued by the Army authority of the area into which they intend to travel.

(b) Territory under AMC.

In Territory under Allied Military Government in rear of the Army (and Corps) areas, restrictions on inter-provincial movement is to be relaxed forthwith, i.e., civilians in this area will be forbidden to travel from one province to another without an APC pass.

(c) Italian Administered Territory.

There will be no restriction on movement within that part of Southern Italy which is administered by the Italian Government, nor within Sicily and Sardinia. An Allied control Commission pass will, however, be required for movement between Southern Italy, Sicily and Sardinia, and also for all

(c) Italian Administered Territory.

There will be no restriction on movement within that part of Southern Italy which is administered by the Italian Government, nor within Sicily and Sardinia. An Allied Control Commission pass will, however, be required for movement between Southern Italy, Sicily and Sardinia, and also for all movement from AMG territory into Italy's Italy and vice versa.

Check Posts.

(e) In Restricted Areas.

In Army (and Corps) areas and in territory administered by Allied Military Government every effort will be made to enforce the above restrictions by means of a widespread system of 'spot' check posts, which will be established for a few hours daily at irregular times and at varying points. The responsibility of arranging such checks will rest with U.S.S. or C.I.C., units.

The object of these check posts will be: (i) to turn back those seeking to move outside the prescribed limits without a pass, (ii) to take action against those who have committed serious and flagrant breaches of the regulations, (iii) to question or detain for investigation persons whose conduct or "story" is suspicious.

(b) In Unrestricted Areas.

In territory administered by the Italian Government a similar system of 'snap' check posts will be established. In this instance, however, the objects will be limited to (1) briefly questioning those passing the point with a view to discovering suspicious individuals who should be subject to further interrogation, and investigation, and (2) instilling a sense of insecurity in the minds of agents or other undesirable individuals so that they may hesitate to move about or even abandon their mission.

(c) Organisation and Composition.

This system of check posts will be organised by Army, Corps, District and Base Section Headquarters and NOT by AMG/ACC, both AMG and ACC territories.

These check posts will normally be manned by appropriate combinations, according to circumstances of N.S.P./C.I.G., S.I.L. (C.S.), CC.RR and Guardia di Finanza.

Every effort will be made by Allied Control Commission officers to ensure the fullest co-operation of the Italian Police in connection with these duties.

4. Passes.

(a) Army Areas and Foggia.

In the case of persons wishing to move North-Westwards across the "Control line" (which follows the general line of the Rivers Biferno and Volturno) or to enter Foggia Province, the existing procedure will normally be followed whereby they must first obtain (through their local AMG/ACC representative) a pass issued by the appropriate AMG authority in the area of their destination.

This system of check posts will be organized by Army, Corps, District and Base Section Headquarters and NOT by AMG/ACC, both AMG and ACC territories.

These check posts will normally be manned by appropriate combinations, according to circumstances of V.S.F./C.I.C., S.I.M. (S.S.), CC.RR and Guardia di Finanza.

Every effort will be made by Allied Control Commission officers to ensure the fullest co-operation of the Italian Police in connection with these duties.

4. Passes.

(a) Army Areas and Foggia.

In the case of persons wishing to move North-Westwards across the "Control Line" (which follows the general line of the Rivers Biferno and Volturno) or to enter Foggia Province, the existing procedure will normally be followed whereby they must first obtain (through their local AMG/ACC representative) a pass issued by the appropriate AMG authority in the area of their destination.

(b) AMG Provinces.

The procedure described in para (b) above may be employed in cases described in (a) above when, for urgent administrative, economic or other reasons, the procedure described in (a) would be impracticable owing to the time factor. In such cases, the passes will be issued by the Provincial Commissioner or by a member of his staff on his behalf who will immediately forward details of the issue of such passes to the SCAG or PC of the area of destination.

(d) Reasons for Travel.

It is essential that the issue of passes to cross the "Control Line" or to enter Foggia Province be strictly limited to those cases where the journey will benefit the Allied cause, or where there are important administrative or economic reasons, or in exceptional cases, where there are urgent compassionate grounds. The issue of other passes will be limited to persons who show good and genuine reason why they wish to travel, whether on official matters, business or family grounds.

(e) Issue of Travel Tickets.

Allied Central Commission officers will ensure that transport tickets will not be issued by the railway authorities or other travel agencies to places within restricted areas unless the persons applying for tickets are in possession of a proper pass to their intended destination.

(f) Italian Government Officials.

Passes for Italian Government officials will be issued by this Headquarters and signed by the Secretary General or by the Deputy Secretary General, Allied Control Commission, and will be issued after application has been received from the Government Department concerned or from Italian Liaison Section, Allied Control Commission, and considered by the appropriate Sub-Commission who will be responsible for examining the application as to actual necessity for the proposed journey. Such passes will be prepared for signature by the Sub-Commission concerned.

(g) Italian Military Personnel.

The movement of members of the Italian Military Forces is unrestricted providing they are on duty and in possession of proper credentials. The Italian Military Forces when not on duty, e.g. when on leave, are subject to the same restrictions as civilians.

(h) Issuing Officers.

It will be within the discretion of the Provincial Commissioner to authorize specified and approved officers of the Quastore or CC.HF. to issue passes for inter provincial travel. It is emphasized, however, that passes permitting persons to enter the Army areas or Foggia Province must be issued by AAW/ACC officers.

(i) Semi-Permanent Passes.

In the case of persons living near a Provincial boundary and whose place of employment is in, or partly in, and adjoining Province or Provinces, a semi-permanent pass may be issued and such passes shall expire on 31 March, 30 June, 30 September and 31 December annually, and then become renewable upon further application. Such passes may also be issued to all persons who have sufficient reason for frequent travel between Provinces.

(i) Semi-Permanent Passes.

In the case of persons living near a Provincial boundary and whose place of employment is in, or partly in, and adjoining Province or Provinces, a semi-permanent pass may be issued and such passes shall expire on 31 March, 30 September and 31 December annually, and then become renewable upon further application. Such passes may also be issued to all persons who have sufficient reason for frequent travel between Provinces.

(j) It is suggested that when an application for travel into an Army area or into Foggia Province is received in AMC/ACC territory that the officer concerned completes the pass on behalf of the applicant (provided he is satisfied with the sufficiency of reasons for such travel) and forwards it to the SCAD/PC of the destination for approval; signature and return.

5. It will be seen that in future, Provincial Commissioners will be authorized under certain circumstances to issue passes for entry into Army areas or Foggia Province without prior permission from the point of destination (vide 4 (c) and further that the movement of members of Italian Military Forces is unrestricted, (vide 4 (E)).
