The speaker is Captain GIULIETTI himself.

I have been accused of having encouraged war, and that my aim was not only a fascist one, but that of making money. I have also been accused of having accepted a salary by the police or by MUSCOLINI. If these accusations were true, I should be indeed unworthy of being your representative, because I should have betrayed your Federation, its program, its traditions; I should have betrayed you and your families; I should have betrayed the "Garibaldi" all the seamen, the memory of those of you who are dead and of the ex members of my family who are also dead; I should have betrayed the future and the honour of my children....."

In the statement, the members of the Seamen's Federation state that they are aware of the accusations made against Captain GIULIETTI, and express their solidarity by confirming him in his job.....

The assembly approves also of the amounts paid to GIULIETTI by the "Garibaldi" Federation and the seamen's Federation, since the 1st of July 1944, for the private expenses (a little over 1300 lire per day), and protests against the measures taken in order to deprive GIULIETTI of this financial help.
