1. A letter has been received from Signora Celluci Olara, wife of subject, asking to be informed of his position.

2. Subject is in Pesaro Prison under sentence of death for espionage, but the result of the review of the sentence is not yet known.

3. There is no security objection to her husband, but it is requested that PG Pesaro be advised in order to make the necessary arrangements for the interview which must be in the presence of an Allied FS Officer or MCO.
