SUBJECT: Monarchic Movement of Liberated Italy - Committee of the South.

The 'Monarchic Movement of Liberated Italy' has its office in this city in Corso Umberto I N. 311, which was formed by the initiative of monarchic persons, up to now there are a few hundred adherents.

The president is GRAGNANI Pasquale fu Carmine and fu Nicola Erudiva, born in Atella (Avellino) on 3.4.1897, resident here in Via Pacella at Rettifilo N. 6, graduated in medicine; formerly belonged to the fascist party. The following appears against him in the R. Questura files:-

- Ob 15.1.1930, pardoned by the Pretore of Naples for the denunciation of the lack of delivering pawned articles.
- Cn 3.2.1930, pardoned by the local Pretore for the crime of insults.
- Cn 17.3.1930 " " " " " "
- Cn 20.3.1930 pardoned by the Pretore of Lagonegro of the crime of illegal possession.
- On 18.11.1930 pardoned by the Naples Tribunal of the crime of swindle for insufficient proofs.
- On 4.2.1931 sentenced by the Naples Tribunal to 1050 lire fine for contravening tax regulations.
- On 8.11.1932 pardoned by the Sarno Pretore of the crime of swindle.
- On 8.1.1933 pardoned by the Naples Pretore for the lack of delivering pawned articles.
- On 20.11.1936 sentenced by the Avellino Pretore to 20 lire fine for contravening the Law of 22.2.1934.
- On 20.5.1937 pardoned by the Avellino Pretore for contravening Law of 29.5.1928.
- On 9.4.1937 pardoned by the local Pretore for falsification of a public document.
- On 9.6.1937 pardoned by the local Pretore for the crimes of usury and swindle.
- Cn 22.6.1937 pardoned by the local Pretore of the crime of swindle.
- Cn 7.4.1938 sentenced by the local Pretore to 100 lire fine for not having delivered pawned articles.
- Cn 8.5.1940 pardoned by the Cignano Pretore of the crime of insults.
- On 18.3.1940 arrested by the Naples C.C.R.R. and denounced for clandestine and fraudulent trading of drugs.
