SUBJECT: Italian National Party.

The Italian National Party has been formed in this city with temporary office in Piazza Dante n. 25, with the aim to collaborate with the Government for the moral and material reconstruction of Italy. Up to now it has shown no political tendency; there are a few hundred members.

The leaders are:-

1) CARLO FEDERICO fm Federico and fu Scapa Maria, born in Naples on 4.2.1894, resident in Via Pignasecca n. 13, a widower and has children, a communal employee, he was a member of the Fascist Party, no penal records in our files;

2) MILIT Fausto fu Oreste and di Boemio Rosa, born in Naples on 29.9.1917, resident in Via Concordia n. 5, bachelor, a communal employee, formerly a member of the Fascist Party;

3) PEPITONE Giovanni fu Giuseppe and fu Fedele Concetta, born in Naples on 8.12.1895, resident in Via Carlo de Cesare n. 47, married and has children, unemployed, he was a member of the Fascist Party since the foundation. The following appears in the R. Questura files:-
