SUBJECT: Undersecretary of Education.

TO: HQ A.M.G., Naples.
(Attention of Chief of Staff).

1. Reference letter RCA/N52/6, dated 22 December 43 of which a copy was forwarded to you by RCAF, Region II.
2. A report has been received from Educational Director, Region II of which a copy is attached. This contains several references to the Under secretary for Education and the Badoglio Government, to which it is desired to draw attention.
3. If there is, in fact, the likelihood of officials appointed by A.M.G. being removed from office on the Badoglio Government taking over, it is suggested that they should be legally protected.
4. Reports on Signore Cuomo by officers of this Division who have met him have been unfavorable and suggest that he is a lethargic and weak man who is out of touch with reality and unlikely to be successful in his office.
5. Immediately after completion of the work which is drawing to an end in Sicily it will be essential to carry out a tour of Region II including Salerno as it is clear from Reports from this Region that the educational position concerning the removal of Fascists is not satisfactory despite the excellent work being done by Captain VESSELO. It would be convenient and economical of transport and fuel to carry out this inspection on the way from here to Naples and if you approve of this it is suggested that the rear party of Education, consisting of Lt. Colonel GAYRE, Major SHERWOOD and one clerk be allotted a car from the rear pool and make their way independently to Naples on the conclusion of the Sicilian work, completion of which is expected about 10th January.



Reference ECA/42/72/B of 21/12/43:

As stated in the above order, the old Scuole Medie Uniche have been abolished, and four types of Scuole Medie Inferiori are replacing them. A specimen syllabus covering all four types, but allowing for variations in detail between one type and another, has already been forwarded to you, and further copies (approximately one per teacher) will follow.

In relation to the organization of these new Schools, the following points should be observed:

- (1) Each new School will be considered as independent, and under its own Preside.
- (2) In general, each old Scuola Media Unica will be converted into one or another of the four new types, whichever is most suitable for the locality.
- (3) In special cases, conditions may arise where it is desirable to convert an existing School into more than one of the new types (e. g. where only one Scuola Media Unica has been in existence in a large town which has both a Liceo Superiore and an Istituto Magistrale Superiore: in this case it will be ^{probably} desirable to convert the old Scuola Media into both a Liceo Inferiore and a Magistrale Inferiore). In such cases, the necessary division should be made, but the new types may temporarily continue to function side by side in the old single building and under one Head, until such time as more normal conditions are established and it becomes possible for the two Schools to find separate buildings and to have separate Heads.
- (4) Schools which include more than one grade of instruction (eg. Asilo, Elementary, Scuola Media) may continue to function in the old way, provided that the Scuola Media section be altered in accordance with para 2 above.
- (5) A report must be made of all changes which are contemplated in accordance with the above, and this report forwarded to the Regional Director of Education for approval (through the S.C.A.O.)

Con riferimento alle "Norme e Istruzioni per la Riapertura e il funzionamento delle Scuole" (MOA/42/72/B della data 21/12/1943).

Come dichiarato nel suddetto documento, le Scuole Medie Uniche vengono abolite, e quattro tipi di Scuole Medie Inferiori le sostituiscono. Un programma d'esemplare, unico in base per tutti i quattro tipi, ma lasciando la possibilità di variare i dettagli fra un tipo ed un'altro, vi è già stato mandato, e ulteriori copie (alla rata di una pro insegnante approssimativamente) seguiranno.

In quanto all'organizzazione di queste nuove scuole, i seguenti punti devono notarsi:

- (1) Ogni nuova Scuola sarà considerata come indipendente, sotto un proprio Preside.
- (2) In general, ogni vecchia Scuola Media Unica sarà cambiata in uno od un altro dei quattro nuovi tipi, qualunque sia il più adatto per la località.
- (3) In certi casi, le circostanze possono esigere cambiamento da una Scuola esistente, in più di uno dei nuovi tipi (per esempio, quando c'è stata una sola Scuola Media Unica in una grande città dove ci sono un Liceo Superiore ed un Istituto Magistrale Superiore: in questo caso bisognerà probabilmente cambiare la vecchia Scuola Media in un Liceo Inferiore e un Magistrale Inferiore, tutti e due). In tal caso, la necessaria divisione deve farsi, ma i nuovi tipi possono temporaneamente continuare a funzionare accanto l'uno all'altro nell'unico edificio di prima e sotto un solo Capo, finché si stabiliscano condizioni normali e divenga possibile che si trovino due edifici separati e due Capi separati per le due Scuole.
- (4) Scuole che a presente danno più d'un grado d'istruzione (per esempio quelle che contengono Asilo, Scuola Elementare, Scuola Media), possono continuare a funzionare come sono, purché sia cambiata la parte Scuola Media secondo il paragrafo n. 2 di sopra.
- (5) Dovrete fare un rapporto di tutti i cambiamenti che contemplate secondo quanto sopra, e mandarlo al Direttore Regionale dell'Educazione (per mezzo dello S.C.A.O. della Provincia) per la sua approvazione.

1. Attached is a copy of a letter delivered to the Provveditori agli Studi of Matera Province on or about 2 Dec, ordering a certain Dr. Nicola Minervini to assume the presidency of the Liceo Sismario of Matera on 1 Jan. This order was issued without prior consultation of any sort with any AMG official in Region II. It is one of a series of similar actions taken by various officials of the Saloglic Government.

2. Because of the number of these incidents, I am forced to the conclusion that these officials are either totally ignorant of the fact that Allied Military Government, rather than the Saloglic Government, is in charge of public administration within Region II, or they choose deliberately to ignore that fact.

3. I will be obliged if you will inform the Saloglic Government that all communications from it with regard to public affairs in Region II must be handled through the S.C.A.O. of Region II if they expect the slightest attention to be paid to them. Any official acting upon instructions received directly from the Saloglic Government will be severely punished.

4. The order in question will be ignored, as have all those which have preceded it, and Dr. Minervini should be informed that if he enters Matera Province, he will be escorted back to Apulia.

Subject: Appointment to positions on Badoglio Government of Persons
dismissed by AMG

To : Educational Adviser, HQ., ACC-AMG

Reference your letter (not at the moment in my hands) on above
subject.

(1) In forwarding to you reports that I had heard of dismissed personnel being appointed to positions on the Badoglio Government, I deliberately abstained from giving names, or sources of information, or from making any comments, as I did not know if you wished me to make any investigations, and was expecting to hear from you on the matter. As you now say that the matter is being taken up on a higher level, I feel that it is necessary for me, in order to avoid misunderstanding, to explain the matter further.

(2) The allegations, with names and specifications, were made to me by an Avvocato Milillo, who is sometimes employed by the Legal Staff here, and considered by them as a very reliable source, during the course of an official conversation on other matters. He stated the allegations as facts, which he said were causing much unrest locally. I made no comment whatever to him, but took a note of the statements after he had gone.

(3) In the one case which pertained to my field, I later made further investigations. I discovered that the dismissed Provveditore of Matera (by name Cassano Vito Felice) had returned to Matera for his belongings and had stated to the Provveditorato Staff, including the new Provveditore, Luciano Nello, that he had interviewed the Ministry of Education of the Badoglio Government and that he was about to be put on the Ministry of Education himself. He stated this as a fact.

(4) I have made no further investigations, since I did not know if I was authorized to do so. I did, however, pass the reports on to you for your information, in a Personal and Confidential letter.

(5) Will you please say if you wish me to take any further action.

Subject: Report on a tour through Calabria

To : Lt. Col. E. R. Gayre, AEC, Educational Adviser, HQ, ACC, AMG.

1. Route Followed.

On Nov 26 at 0700 hrs I left Matera for Cosenza, where I arrived at 1400 hrs. On Nov 27 at 1400 hrs I left for Crotona (Compartimento HQ) which I reached at 1900 hrs. On Nov 28 at 0900 hrs I left for Catanzaro, returning the same evening to Crotona. I remained at Crotona on 29th & 30th Nov. Early on 1st Dec I left for Reggio, stopping at Catanzaro on the way. I arrived at Reggio at 1930 hrs, remained there during 2nd Dec, and on 3d Dec at 0615 hrs left for Crotona again (again stopping for a short while at Catanzaro). I arrived at Crotona at 1530 hrs. At 0730 hrs on 4th Dec I left for Cosenza. I left Cosenza at 1900 hrs. Owing to a breakdown I spent the night in Tarsia and arrived in Matera on 5th Dec at 1800 hrs.

Distance travelled, approx 1000 miles. Number of vehicles used, fourteen.

2. Persons interviewed.

- (a) All relevant AMGOF personnel, including the SOAC and his 2 i/c and all Provincial Officers.
- (b) The Prefect of Catanzaro and Cosenza.
- (c) The Provveditore of Cosenza.
- (d) At Cosenza, the Col of Carabinieri and various other persons, at Catanzaro, the Questore.
- At Reggio, the Questore, the Sindaco, & the Capo Gabinetto (All these persons were interviewed for information)

3. Facts obtained.

(a) Compartimento System

I understand that this system is likely shortly to be revised. To date, it has operated rather differently in Calabria from elsewhere. Compartimento HQ is at Crotona, where are stationed the SOAG, the 2 i/c, and a group of Specialist Officers. PCAGs were abolished a few weeks ago, and in each Provincial Capital is merely a "Liaison Officer", the functions of CAOs being carried out by travelling officers, who report back frequently to Crotona as a base. The idea is in part to overcome the shortage of suit-

3. Facus obtained.

(a) Compartimento System

I understand that this system is likely shortly to be revised. To date, it has operated rather differently in Calabria from elsewhere. Commandamento HQ is at Crotona, where are stationed the SCAO, the 2 i/c, and a group of Socialist Officers. PCAOs were abolished a few weeks ago, and in each Provincial Capital is merely a "Liaison Officer", the functions of CAOs being carried out by travelling officers, who report back frequently to Crotona as a base. The idea is in part to overcome the shortage of suitable officers by referring everything back to a central HQ.

From the educational point of view the system presents difficulties. I was compelled to treat "Liaison Officers" as though they were fully-employed PCAOs.

(b) Education proper.

(1) Provveditori

The Provveditore at Cosenza is an ex-Professor of 1008 from Bari, moved to Cosenza, so he says, for political reasons. He is named for by the Prefect (a Socialist) but I should say that the Provveditore has no strong political complexion and I am acting on the principle that he is to be retained.

The Provveditore at Catanzaro has Fascist connexions, and is reputed to be incompetent. I have had views on him from the Prefect at Cosenza (of which he is a native), from the Questore at Catanzaro, and from various others. I am waiting for a report on him from the Colonel of Carabinieri at Cosenza. There has been a violent Press campaign raging against him in Cosenza. I am investigating the case carefully, in order not to be unjust, but it is likely he will have to go.

The Provveditore at Reggio has also had Fascist connexions, but reports (from the Questore, the Sindaco and the Capo Gabinetto at Reggio) suggest that his Fascist background is less important than it seems and that he is quite efficient. If final investigations are satisfactory, I am prepared to retain him, and for the sake of speed am treating him provisionally as approved. (Reggio Province in general is a difficult case, and there are allegations that it is still Fascist-ridden).

(ii) Committees

No committee had been set up in Cosenza. I obtained a list of suggestions from the Prefect, and provisionally ratified them.

A Committee had very recently been set up in Catanzaro, with the Prefect at the head (this system had also been mooted for Cosenza).

Reggio had a skeleton Committee of three, the Prefect, the Provveditore, and a Senior Teacher.

Lt.Col. Rodd (SCAO, Calabria) had put forward the idea of a Compartimento or even Regional Committee instead of Provincial ones. His objection to the Provincial ones was that they might become instruments of patronage. I said that I could see no objection to a Central Committee in addition to the others, but that my instructions were to institute Provincial ones in any case. I also stated objections to the idea of having the Prefect at the head of each committee, and it was agreed that the Provveditori, as soon as appointed, should take over Presidency of the Committees; also that the Reggio Committee should be enlarged to a reasonable size. I am getting one or two respected bourgeois on each of my Committees to watch the interests of the Community, and am suggesting the inclusion of a good medico for the question of hygiene.

I approved of the Prefect taking an interest in each Committee, and recommended that he should attend meetings whenever possible as an observer.

(iii) The Church

There is a feeling at Crotona that the church in some parts is politically suspect. The Archbishop at Cosenza is said to be reliable, but reports say that the Bishop at Catanzaro is unreliable, and Churchmen in Reggio are said to be directly supporting Fascist movements (I cannot vouch for any of this).

(iv) School Buildings; Examinations; Schedules

I have now obtained a completed questionnaire from Reggio and am awaiting answers from Cosenza and Catanzaro. In Catanzaro the buildings are least damaged. In Cosenza and Reggio there is a fair amount of damage to the schools, and this will naturally delay resuming classes.

(iv) School Buildings, Examinations, Schiede

I have now obtained a completed questionnaire from Reggio and am awaiting answers from Cosenza and Catanzaro. In Catanzaro the buildings are least damaged. In Cosenza and Reggio there is a fair amount of damage in the capitals, and this will naturally delay reopening in some cases. A system of staggered hours is contemplated.

In Catanzaro and Cosenza examinations are in progress. In Cosenza, owing to shortage of buildings, the examinations will last until early February. In Catanzaro they are all being held together.

In Reggio, no notification of examinations had ever been received. I gave permission for them verbally, and stated the conditions. 1007
6,000 Schiede had been sent from Matera to Calabria. I carried about
time of my leaving Crotona they had not been received, and I now have them with me a small number of Schiede, which I distributed, and I now have them completed for the Provveditori of Cosenza and Catanzaro among others.

I have been demanding completion of Schiede from all Educational personnel, but not from the Committees, provided they are vouched for by Prefects and CAOs. If you wish for Schiedas from Committees too, I shall be grateful if you will so direct me.

(v) Institutes of Higher Learning.
There are no Universities in Region 2, but at Cosenza there is the Accademia Cosentina (founded in the 15th Century), consisting of 24 fellows, and at Reggio there is the R. Deglutazione di Storia Patria per la Calabria e la Lucania. In both cases I have demanded lists of names, Salaries and details for approval.

Of the Accademia Cosentina there are 11 pre-Fascist Fellows remaining (including the President). I have approved a system whereby these Fellows are given the task of reconstituting the membership. As soon as I have details of the President in full, I will forward them to you for your approval.

(vi) General

Delays in communication between Matera and Calabria are tremendous. It is hopeless to expect a reply to a letter in less than a fortnight. Some letters never arrive at all. Dealing with Calabria through the post is therefore next to impossible. Only personal messages really accomplish anything, and I have several times had the experience of repeating personally (verbally or in writing) points that I had sent out ten days or more earlier, but which had never arrived. The Compartimento system, which centers all responsibility at Crotone instead of in the Provinces, does not relieve matters.

Finally, I should like to add that I have received all facilities from the IGAD, who has helped me a great deal and given me full scope.


SUBJECT: School Programs.

TO : Educational Adviser, HQ, ACC, ASD, AFM 394

Ref HQD 312 of 25 Nov 1943 from Major G. W. Jackson.

1. It is regretted that this letter arrived without a copy of the order mentioned therein. It is assumed that the order gives permission for the Scuola Media Unica to continue, under the name Scuola Post-Elementare, and without the Fascist text books. I have already transmitted this order verbally (not yet in writing), and have also ordered that Presidi of such schools shall be suspended until investigations have been made into their background.

2. With regard to School Programs in general, it is not known whether there will be sufficient paper to undertake a large-scale printing, as in Sicily, but I have prepared enough typed copies of such Programs (based, with certain modifications, on the Programs submitted by the Matera Educational Committee) to be sent provisionally to all Provveditori, who can then if required make further copies, at least for Heads of Schools. They will be directed not to undertake full distribution until the printed copies are received from you for comparison, checking, and any necessary amendments.

Dear Colonel,

I have just returned from a hectic 10-day tour of Calabria, on which I am preparing a detailed report which should reach you a day or two after this. The experience I have gained since I first came to Matera has been invaluable, and should help greatly at a late stage.

As a result of my travels, and in view of the exceptionally difficult conditions which obtain here at the moment, Col McLaffey has decided that he needs more Education Officers, to work under my direction. He ~~has~~ is therefore sending out a letter to HQ, AMG stating the full case and asking for one officer per Province in addition to me.

Although this letter will be addressed to HQ, AMG, I presume that it will automatically be routed to you. It is ~~however~~ phrased in such a way that it will be possible for you to hand it on as it stands, together with whatever recommendations you think fit, to the relevant authorities. I expect you will want to suggest specific modifications.

For your information, a Proveditore whom I dismissed here on very clear grounds (he had written a book on Fascist Pedagogy) has been given a post by Badoglio on his Ministry of Education at Bari. A Vice-Prefect of Matera whom Col McLaffey had dismissed has been given a high post on Badoglio's Council of Ministers. The dismissed

Procuratore del Re of Matera is parading as a Magistrate
at Bari. A Major of Carabinieri recently sacked from
Matera as a notorious Fascist is also with Badoglio.

I give the above facts without comment.

Under the present Civil Affairs organization for the Region, each Compartimento is headed by an SFCMAO (Lt Col Nicholas (B) for Inconia, and Lt Col Rodd (B) for Calabria. Salerno has an SFCMAO of its own, Lt Col Robertson (B). Under the SFCMAO come the Provincial CIAO's, who are Captains. Man-power in general appears to be very limited.

3# Education before my arrival.

On my arrival all the old Provveditori were still in office. One Province only had formed an Educational Committee, Matera. This Committee had been chosen by the Prefect (now gone elsewhere) and had very few professional Educationalists on its strength, and one or two dubious personalities. It had performed one very useful function, in preparing a detailed syllabus for the use of schools in the early stages, (a modification of the old printed syllabus). This syllabus was strongly approved by Major Washburne, who took the principal copy away with him. I have, however, now ascertained that the syllabus was the work of two members of the Committee only.

Major Washburne also gave a general permission for the annual October examinations to be held in the near future.

The RSCMAO had given permission for a local Church School (girls), with 150 pupils, to be re-opened with certain limiting conditions.

AMGOT/8874/B/ED of 14 Sep 43 had been sent out, (presumably to all Provinces except Salerno) but no satisfactory answers had been received. A limited number of Schedas had been sent out, but no answers had yet been received.

Major Howe, the Legal Officer (a very useful man) had sent out instructions on the appointment of Provveditori and other Educational personnel, detailing also some of the essential duties of a Provveditore. No answers had been received.

4# Steps taken since my arrival.

(1) On arrival I sent out another copy of AMGOT/8874/B/ED of 14 Sep 43, to all Provinces (including Salerno) with a covering page giving explicit details about the functions of Educational Committees. I then made close inquiries into some of the leading Educational personalities in Lucania. As a result, it was first found necessary

to order the dismissal of the Provveditore at Matera, and then, after I had spent a week-end at Potenza, to order the dismissal of the Provveditore there. In the case of Matera, the Provveditore was found to have written a strongly Fascist book about the Educational system, and to have carried out certain minor persecutions. In the case of Potenza, the Provveditore was incompetent, and had also carried out certain minor pro-Fascist persecutions. In both cases the Civil Affairs Staff is in complete agreement with my actions.

(ii) With the aid of the Regional Legal and Intelligence Officers, in conjunction with a series of close inquiries in the locality, I have been able, with considerable backing, to put forward names for two new Provveditori. Both should be in office in a day or two. I have interviewed both Prefects on the matter. I have also put forward details, with specific names, for the remodelling of the Matera Committee and the formation of a Committee in Potenza. Both should be in operation in a matter of days. In Matera I have also appointed two Directors of Schools.

(iii) I have now obtained answers to the questionnaire about schools, teachers and pupils from both Matera and Potenza. Once the question of personnel has been properly dealt with, it should be possible to take the further necessary steps for the re-opening of schools with little delay.

(iv) Only two important difficulties remain. (a) Allied troops have just moved into the towns of Potenza and Matera, taking over the best school-buildings. The staggering of school-hours may be a partial solution to this. (b) The normal state of hygiene of many of the minor schools (which are usually no more than single rooms) is so bad that even with improvements it will not be possible to raise them to any reasonable British or American standard before re-opening. Further, the criteria in the minds of local officials in these matters are so dubious that it may not be possible to get satisfactory data without organizing at least an official inspection by the Civil Engineer, working with a suitable directive from us. I am considering this question carefully.

(v) Nothing has yet been heard from Salerno, and I have not yet been able to go there. I shall probably leave it till last as I believe that local conditions there are not yet greatly favourable to re-opening of schools.

(vi) In Calabria the position is a delicate one. There appear to have been general difficulties in the organization of the Province, and as far as I am aware nothing has yet been done in

I am considering this question carefully.

(v) Nothing has yet been heard from Salerno, and I have not yet been able to go there. I shall probably leave it till last as I believe that local conditions there are not yet greatly favourable to re-opening of schools.

(vi) In Calabria the position is a delicate one. There appear to have been general difficulties in the organization of the Province, and as far as I am aware nothing has yet been done in Education beyond arranging for the delayed October examinations to be held. I am proposing in two days time to visit Cosenza, where there appears to be considerable unrest, and the other Calabrian Provinces after it.

(vii) Arrangements have been made to hold examinations all over the Region, starting in a few days, and I have issued instructions limiting the possible questions in certain subjects (e.g. - no History after 1915). I have also issued instructions, on the lines of Region I, about the conditions limiting the re-opening of Church Schools. The Church School in Matera town (referenced to in (3) above) will be open on Dec 1st. I have had two conversations with the Archbishop.

5. Items of Method

(1) One thing is clear. Unless a specific Education Officer is actually on the spot in each key-place, very little is likely to be accomplished under the present conditions. It is absolutely

essential for the Education Officer to pay personal visits to each particular Province, staying as long as possible. On these lines, two Officers would seem to be the minimum necessary allotment for a Region.

(ii) I have found one contact especially useful in making inquiries into people's backgrounds. That is the local Legal Officer. Both in Matera and Potenza this officer has been able to put me in touch with Italian lawyers who have a thorough knowledge of the population and who have been able to produce exceedingly useful information.

(iii) Another interesting point is that the Educational profession here seems to have a considerable propensity for going into print. This provides evidence (usually against them) which is not given even by the Scheda Personale.
