SUBJECT : Education Personnel for Italian Occupied Territory

TO : *Cof D* Executive Commissioner
Allied Control Commission /To: Regions I, II, III,

1. The urgency and the difficulty of opening schools in the wake of our rapidly advancing armies have forced this Subcommission, with its limited personnel, to withdraw all full-time education officers from Italian government territory.

2. The services of this Subcommission will still be available to these regions. Major G.R.Koopman, formerly Regional Education Officer in Region I, will represent the Subcommission in all Italian government territory visiting regions, ironing out difficulties, reporting conditions through this Subcommission to the Italian Minister of Public Instruction. This arrangement has merits all its own since our operations in Italian territory must be in accord with Italian law and must be carried out by Italian officials. Nearly all problems arising in this territory must be taken to the Minister himself for adjustment.

3. All policy matters will be handled through you and your executive officers unless you direct otherwise. Please feel free to call upon the Subcommission office for such educational aid as you may require.

4. The recent report on educational conditions in your region was very encouraging.

OUTLINE OF BASIC IMPROVEMENTS NEEDED IN THE ITALIAN EDUCATIONAL SYSTEM

I. EDUCATION OF TEACHERS

A - Preparation of elementary teachers

1. Increase of length of training
2. Supervised practice teaching
3. Relation of courses in education to observation and practice teaching

B - Preparation of secondary School teachers

1. Required work in Magistero
2. Supervised practice teaching
3. Relation of courses in education to observation and practice teaching

C - Preparation of Directors, Prezidi, Inspectors, and Provveditori

1. Basic courses in Magistero as in B
2. Graduate courses in supervision and administration and underlying principles of modern education

D - In service education

1. Democratic organization of groups of teachers, supervisory and administrative officers.
 - a) Submission of policies and problems, with pertinent facts, to them and transmission of considered opinions to ministry
 - b) Origination of policies and problems by them and transmission to ministry
2. Development of teachers' associations with conventions for interchange of thought; professional journals; committees on various problems; organised influence on legislation.
3. Summer courses for teachers and school officials
4. Travel fellowships to UK, US, USSR, etc.

E - Decentralization to give much greater scope to local initiative and responsibility.

C - Much closer relation between theory and practice

youth, worked out locally by youth with adult help but not domination; co-ordinated and implemented by provincial, regional, and national committees

IV. ADMINISTRATIVE REORGANIZATION

On the above bases the total administrative organization and school program needs to be reconsidered by competent Italian commissions, in contact with such groups and organizations as are mentioned in I. D-1 and 2. Almost no Italian educators having had contact for over twenty years with educational movements and findings in non-axis countries, help and counsel should be sought from non-axis education.

SOME METHODS OF IMPLEMENTING BASIC IMPROVEMENTS IN ITALIAN EDUCATION.

1. Commission on teacher education: Minister already requested to appoint a provisional one - agrees to do so.
2. Organization of teacher groups and preparation of problem bulletins for them: preliminary plans made, and crude start made toward gathering first problems.
3. Commission of Youth Activities: local one established in Naples and actively functioning; provision made for national implementation of local youth groups in schools, and decree promised by Minister; playgrounds under way; steps taken toward scout organization.
4. Commission on Adult Education and Recreation; organized in Naples and beginning to function as experimental center; broad outline of functions prepared on national scope; preliminary steps taken toward re-organizing Rotary - local committee formed and application made for charter; classes in English, typewriting, etc., being organized.

Preliminary Activity:

Survey being made of Italian Education
Survey completed of old Dopolavoro
Investigation being made of GIL activities

Housekeeping Activity:

Text-books for elementary schools published and to be re-published.
Text-books for secondary schools and universities being selected for publication.
Programs for all levels of elementary and secondary schools published, except Avimento Professionale.
School lunch problem studied and a little progress made.
School supplies being ordered - some paper and quaderni already supplied.
Machinery for defascistization organized and limping along.
Administrative machinery cleared up to point of effective (more or less) operation of schools and universities.
New and greatly improved and partially decentralised administration badly needed, but no real steps taken toward ~~323~~ ³²³ commission to study this vaguely planned.
School building situation improved but still intolerably bad.
Being largely left to local and regional initiative and Italian government, but with active regional and national help from ACC.

SUBJECT: Dissolution of Fascist Organizations.

TO : Legal Subcommission.

1. Reference your ACO/4032/1/1, dated 30 June 1944.
2. This Subcommission agrees with the Council of Ministers that:
 - A. The Associazione Fascista della Scuola (I, iv) has no place in a non-Fascist regime.
 - B. The Dopolavoro (2, vii) may be used, should be used, and is being made into a non-political institution. It can be a useful organ in any type of society.
 - C. The Giovani Italiani (2, viii) can be made neutral or democratic, and, so long, is useful to maintain. It will require watchful care. But its location in the Ministry of Public Instruction is proper and the Minister of Justice speaks surely (2, xvi) of its possibility.
 - D. This Subcommission is pleased to note the Council's viewless for the fact that the Federazione Universitaria Cattolica (2, x) has never been fascist but indeed helpful to those who suffered from Fascism.

PROCEDURES AS RETARDS DECLASSIFICATION:

- (1) In territory under control of Allied Military Government, scheda Personale for all administrative officers will be issued by the Regional Education Officer through the Provincial Commissioner and the provveditore agli Studi.
- (2) Scheda will be examined according to Regional procedures by the C.I.C., F.P.R., or Public Safety Division and dismissals or suspensions carried out by the Regional Commissioner on advice of the Regional Education Officer.
- (3) On a form provided by the Education Subcommission, the Education Officer will submit a card for each person dismissed or suspended and will keep the scheda for such persons on file in the regional office.
- (4) In territory under control of the Italian government, either the Regional Education Officer or the Provveditore agli Studi may request a scheda personale from any teacher or administrative officer whose employment or retention is under consideration.
- (5) The Regional Education Officer will submit information of all persons recommended for dismissal or suspension on cards provided by the Education Subcommission. Accompanying each card will be a file for the individual concerned including details of suspension or dismissal, scheda, etc. This data will be submitted to the Minister of Public Instruction.
- (6) The Regional Education Officer will also submit a card for each of those falling within the categories for dismissal, but retained, with accompanying data and supporting data on cards provided by the Education Subcommission. These cards, with accompanying materials, will then be forwarded by the Education Subcommission to the Minister of Public Instruction.
- (7) Notification will be sent to the Education Subcommission when an appeal has been made by a dismissed or suspended person. If an appeal is sent to the Regional Education Officer he will forward the same to the Education Subcommission.

PROPOSED PROCEDURE FOR TRANSFER OF TEACHERS:

- (1) Applicant will apply in writing to the Provveditore agli Studi in the province where he is.
- (2) Provveditore, if he approves, will endorse the application and forward it as indicated below and will notify his Regional Education Officer to this effect.
- (3) Applications originating in Italian Government Territory will be channelled from the Provveditore agli Studi to the Ministry of Public Instruction, endorsed by him and passed to the Education Subcommission for forwarding to the Regional Education Officer of the Region concerned in the transfer. He in turn will pass it on to the Provveditore concerned. If the last named approves, approval will be sent through the same channels in reverse to the Provveditore in the province of origin and the transfer will become immediately effective.
- (4) Applications originating in Military Government territory will be channelled from the Provveditore through Regional Education offices, Education Subcommission, and Ministry of Public Instruction to the Provveditore agli Studi in the province concerned. If he approves, approval will be transmitted back through the same channels to the Provveditore in the province of origin and will become immediately effective.
- (5) Objection can be made to any transfer by any of the officers to whom application is channelled, regardless of point of origin. In such case final decision will rest with the Minister of Public Instruction and Director of Education Subcommission, except that in Military Government territory the Regional Commissioner retains at all times the right to refuse a transfer into or out of his region.

It is understood that the Minister in his territory, as of course, the Allies in their territory, may shift teaching personnel as seems appropriate.

PROCEDURE AS PERTAINING TO DISMISSALS

- (1) In territory under control of Allied Military Government, scheda Personale for all administrative officers will be issued by the Regional Education Officer through the Provincial Commissioner and the Provveditore agli Studi.
- (2) Scheda will be examined according to Regional procedures by the C.I.C., F.D.R., or Public Safety Division and dismissals or suspensions carried out by the Provincial Commissioner on advice of the Regional Education Officer.
- (3) On a form provided by the Education Subcommission, the Education Officer will submit a card for each person dismissed or suspended and will keep the scheda for such persons on file in the regional office.
- (4) In territory under control of the Italian government, either the Regional Education Officer or the Provveditore agli Studi may request a scheda personale from my teacher or administrative officer whose employment or retention is under consideration.
- (5) The Regional Education Officer will submit information of all persons recommended for dismissal or suspension on cards provided by the Education Subcommission. Accompanying each card will be a file for the individual concerned indicating details of suspension or dismissal, scheda, etc. This data will be submitted to the Minister of Public Instruction.
- (6) The Regional Education Officer will also submit a card for each of those falling within the categories for dismissal, but retained, with accompanying data and supporting data on cards provided by the Education Subcommission. These cards, with accompanying materials, will then be forwarded by the Education Subcommission to the Minister of Public Instruction.
- (7) Notification will be sent to the Education Subcommission when an appeal has been made by a dismissed or suspended person. If an appeal is sent to the Regional Education Officer he will forward the case to the Education Subcommission.

Dear Phil,

Thank you for your letter of 9 June. Is there any hope of getting the Rotary International to reconsider the policies named in your letter?

These policies were inevitably made without any knowledge of what the situation in Italy will be. The underlying assumptions are, therefore, at least inaccurate, if not downright contrary to facts. May I state briefly the situation, as I know it to be, after working in all parts of liberated Italy since early October, and on the basis of close contacts with both Italian Government and higher authorities in the Allied Control Commission?

1. The present Allied military dominance of Italy, south of Military Government Territory, is practically negligible. It is true that should the Italian Government violate the terms of the armistice or be unable to suppress serious disorders, we would intervene. Actually, however, the Italian Government is not only permitted but encouraged in every possible way to manage its own affairs. It is as nearly a representative government as is possible until all Italy is liberated and a free election is held. The members of the Government are not puppets chosen by us but a cross section of representatives of the various anti-fascist political parties ranging from Communists on the Left to Liberals and Christian Democrats (Catholic Party) on the Right. In free caucus these parties chose their own representatives and the Allies did not interfere, even subtly.

2. The Italian Government, encouraged by the Allies¹²⁷⁸, is allowing great freedom of press and assembly except where (as is true in United States and Britain) military

security prevents. There is nothing, therefore, in the attitude or decrees of either the Italian Government or the Allied Control Commission, which will interfere with the full normal functioning of Rotary Clubs.

3. One of the greatest and mostimmediately urgent needs of the Italian people today is to form themselves into voluntary groups to participate in an organized manner inthe reconstruction of their devastated nation. There are in every city persons of intelligence, goodwill and ability, who, when organized, can be of immeasurable help in the necessary reconstruction. There are many among the former Rotarians who have never been fascists and who would make an ideal nucleus for new Rotary Clubs. The Allied Control Commission has ample means for supplying information as to whether proposed organisers or officials of a Rotary Club have been active fascists. And I believe we can make sure under the proposal I sent to you in my letter of 29 May that the leading people for each Rotary Club authorized are men whom we can trust.

4. I believe Rotary International will be missing a supreme opportunity to help in the vitally important work of economic and social reconstruction in Italy, if it does not encourage the immediate reopening of Rotary Clubs in liberated Italy at least where this is under Italian Government jurisdiction. I would include Naples, also, partly because I know that the situation there is thoroughly ripe, and because it will probably be Italian Government territory by the time I receive your reply. The same may bettrue of Rome.

5. Before receiving your letter, and with the consent of the Regional Commissioner involved, I had authorized the Naples group to organize themselves into a provisional Rotary Club pending word from you as to whether ornot it might receive its charter. In true Rotary spirit the group immediately found a meeting place and began their meetings. I believe they are holding meetings regularly. I do not want to stop their good work and give them a feeling Rotary International is not back of them by sharing with them your letter of 9 June. They are, therefore, continuing to hold their meetings as a provisional Rotary Club until I receive a reply to this letter with the definite action on the part of the Executive Committee of the Rotary International either stating that it wishes this group to cease to consider itself a provisional Rotary Club or giving definite

consent to its present status, or best of all granting it a charter.

If the members of the Executive Committee could live as close to the situation as some of us have been doing, they would recognize the great service that Rotary International would do to Italy by cutting red tape and stimulating rather than impeding the immediate rebirth of Rotary in Italy.

PROPOSED PROCEDURES FOR DEFASCISTIZATION

1. Determination of policies of defascistization are the function of the Education Sub-Commission in consultation with other Sub-Commissions and the Italian Government. As with all inter-regional policies, these must be submitted to R.C.'s for criticism and suggestions before being made finally effective.
2. Execution of the policies is strictly a regional responsibility. Therefore the Education Sub-Commission has no part in examining schedas and judging individual cases, except in the matter of rectors and titular professors in universities and higher institutions.
3. Since Military Government Territory will ultimately pass to the Italian Government, lists of persons suspended and of those who have been investigated and approved in each region will be sent with the monthly reports to the Education Sub-Commission for cataloguing and ultimate transmission to the Minister. Schedas will be retained in such regions until the turn-over.
4. Transmission of recommendations from R.E.O.'s to the Minister of Education is a Sub-Commission function. So, too, is the follow-up to see that the Minister of Education carries out the policies of the Allied Control Commission. Therefore schedas and recommendations from R.E.O.'s in Italian Government Territory will be sent to the Education Sub-Commission for cataloguing and transmission to the Minister.
5. In each region, in both Italian Government and Military Government territory, the method and personnel for defascistisation will be worked out by the R.E.O. and his R.C. and Public Safety Officer. Use of C.I.C. P.S.S. or Public Safety Personnel for determining whether or not a person is or has been an active fascist is entirely permissible and often advisable.
6. Suspension by categories or by examination of schedas is permissible and often essential, but should always be clearly subject to appeal and full investigation. Such investigation and action in case of appeal is an Italian function in Italian Government Territory. In M.G. territory, machinery for investigation and appeal is the responsibility of the R.E.O. and his R.C. In either I.G. or M.G. territory the R.E.O., with the approval of his R.C., may establish means for investigation of individual cases before recommending suspension, and such investigation may supersede automatic suspension by category or scheda.
7. Persons suspended will immediately cease to receive salary for active service but will continue to receive family allowance. Any such person who is reinstated following investigation or appeal, will be entitled to back pay for the period of suspension.
8. It is recommended that in M.G. territory persons who fall under given categories or whose schedas indicate active fascism be suspended rather than dismissed outright, pending personal investigation of their cases, and that no person be dismissed outright until after an opportunity has been given for ^{3/27} a partial hearing of his individual case. Authority to follow or to refuse this recommended procedure rests, of course, with the R.C. in each region.

Technically, it should have the approval of R.C.'s, etc. Actually it's a purely formal setting down of logical - indeed inevitable - procedures. I should think it could be issued by you directly with copies in Italian for Provveditori. You may want the formal OK of Albeggiani or Omodeo, and in their territory they should send it to the Provveditori.

1. We must differentiate between Italian officials encountered during our present forward advance and those who we found in office during our initial occupation of Southern Italy.
2. North of the line where operations required static for several months Italian officials have been serving the Republican/Popular Government throughout a period when liberated Italy under a properly constituted Government was established.
3. It is to be anticipated that many of these officials will flee before our advances but a proportion will doubtless remain and these should all be dismissed from their posts automatically and replaced by anti-Fascist personnel. As we move North the possibility of finding suitable anti-Fascist personnel should be dismissed greater than it has been hitherto.
4. A list is being prepared and will be issued very shortly showing names of following categories who may in which Italian officials encountered during our advance should be disposed of:
 - (a) Officials who will be arrested and interned.
 - (b) Officials who will be dismissed but who will be allowed to retain their Government.
 - (c) Senior officials who will be arrested and handed over to the Italian liberators.
5. Pending the issue of the list referred to in para 4 and subject to the following conditions all Italian officials encountered during our advance taken only in the most exceptional cases:
 - (a) To the above instructions at their own discretion but only in circumstances of any fascist tendencies or that his temporary retention in office is absolutely essential from the war effort angle. It is emphasised that such action should be taken only in the most exceptional cases.
 - (b) In which they are convicted either that the individual concerned is definitely free or that they are condemned either that his temporary retention in office is absolutely necessary or that his temporary retention but only in circumstances of any fascist tendencies or that his temporary retention in office is absolutely necessary.
6. Pending the issue of the list referred to in para 4 and subject to the following conditions all Italian officials encountered during our advance

It is to be anticipated that many of these officials will flee before our advances but a proportion will doubtless remain and these should all be dismissed from their posts automatically and replaced by anti-Fascist personnel. As we move North the possibility of finding suitable anti-Fascist personnel should become much greater than it has been hitherto.

4. A list is being prepared and will be issued very shortly showing under the following categories the way in which Italian officials encountered during our Northward advance should be disposed of:
- (a) Senior officials who will be arrested and handed over to the Italian Government.
 - (b) Officials who will be arrested and interned.
 - (c) Officials who will be dismissed but who will be allowed to retain their liberty.

5. S.C.A.O and Regional Commissioners are authorised to make exceptions to the above instructions at their own discretion but only in exceptional cases in which they are convinced either that the individual concerned is entirely free of any Fascist tendencies or that his temporary retention in office is absolutely essential from the war effort angle. It is emphasised that such action should be taken only in the most exceptional cases.

6. Pending the issue of the list referred to in Para 4 and subject to the latitude allowed in Para 5 all senior officials encountered during our advance will be arrested and held in custody.

(Agreed by Minister of National Education and Director
of Education Allied Control Commission)

Procedure for transfer of teaching personnel between Italian Government Territory and Allied Government Territory will be as follows:

1. Applicant will apply in writing to the Provveditore agli Studi in the province where he is.
2. Provveditore, if he approves, will endorse the application and forward it as indicated below.
3. Applications originating in Italian Government territory will be channeled from the Provveditore agli Studi to the Ministry of Education, endorsed by him and passed to the Education Subcommission for forwarding to the Regional Education Officer of the Region concerned in the transfer. He in turn will pass it on to the Provveditore concerned. If the last named approves, approval will be sent through the same channels in reverse to the Provveditore in the province of origin and the transfer will become immediately effective.
4. Applications originating in Military Government territory will be channeled from the Provveditore through Regional Education Offices, Education Subcommission, and Ministry of Education to the Provveditore agli Studi in the province concerned. If he approves, approval will be transmitted back through the same channels to the Provveditore in the province of origin and will become immediately effective.
5. Objection can be made to any transfer by any of the officers through whom application is channeled, regardless of point of origin. In such case final decision will rest with the Minister of Education and Director of the Education Subcommission, except that in Military Government territory the Regional Commissioner retains at all times the right to refuse a transfer into or out of his region.

It is understood that the Minister in his territory, as of course the Allies in their territory, may shift teaching personnel as seems appropriate.

A On the change from A.M.G. to A.C.C. conditions it will be your duty to see that:

(1) Notorious Fascists are removed from office; where this has not been done to draw the attention of the appropriate Italian Authorities to the fact, and when necessary inform HQ A.C.C.

(2) The antecedents of persons newly appointed are checked to ensure their suitability.

(3) No fascist literature is issued or used in the schools, colleges, academies and universities, and, where it is, to take similar action to that under Section (1) above.

(4) Any assistance which can be given by way of advice or in any other practicable manner is afforded the Italian educational officials.

B You will not issue orders to academic institutions; make appointments or removals from office; alter the forms or types of schools; prepare or print new text books.

C You will take the following steps to wind-up all A.M.G. business in hand:

All committees for text revisions, educational committees and commissions for appointments will be placed immediately under control of the appropriate local authority, such as the Provveditore agli Studi, or where the appropriate body is the Ministry of Education, you will send a full report to the A.C.C. HQ.

D In order to carry out the functions set out in Section A above you will regularly inspect universities, colleges, schools and other educational institutions and report upon any failure to carry out the eradication of fascists.

1. Reference is made to your letters MGS. 350 dated 19th and 21st February 1944.
2. A comprehensive report on the activities of the Educationa Division and Sub-commission from September 1943 to February 1944 is attached. This contains the list of personnel requested. Lt.Col. T.V. Smith has now assumed the direction in succession to Lt.Col. G.R. Gayre.
3. Copies of Plans of Study for teachers (some in proof form only) are also attached. These have been fully discussed before publication, with representatives of the Church and are in conformity with their recommendations.
4. Touching the specific points raised in your letter of 19 february:
 - a) Religious teaching in schools continues unchanged. The only teaching reforms which have been made in material are those involving the elimination of fascism;
 - b) New text books are in conformity with Catholic principles. It was found unnecessary to change, add to or subtract from any of the religious teaching contained in the old books. Books are being forwarded to you on publication, in accordance with your previous request.
 - c) Without the aid a complete survey of the religious principles of teachers, a formidable task which has not been undertaken, the attitude of teachers to the Church or to religion in general cannot be stated with any accuracy. However, the proportion of teachers replaced is small, and therefore the general body of teachers may be assumed to hold the same religious beliefs as they did before the Allied occupation.
5. The points in your letter of 21st February are answered below:
 - a) The curricula remain essentially unaltered. The teaching of Fascism has been prohibited, and from the text books have been expunged such things as the glorification of fascism and Mussolini, references to Abyssinia and the Empire generally, the glorification of war, and similar items essentially of fascist teaching;
 - b) No courses have been eliminated in the schools. In the universities the three chairs of Diritti Corporativi, Storia e Dottrina del Fascismo and Cultura Militare have been abolished.
 - c) No new courses have been instituted in the schools. In the universities

the Faculty of Letters at Messina University, which was abolished in 1924 has been re-instituted and an Institute of Social Anthropology attached to; the Faculty of Letters has been created at Palermo University.

- d. No modification has been ordered or suggested in religious courses.
- e. The local educational committees, many of whom include priests, have worked closely in all educational matters with the Allied Officials engaged in the work.

6. It would seem that the apparent unceasiness of the Apostolic Delegate and the Holy See are the result of inaccurate information, and it may be apposite to record that the warmest expressions of approval of the work of the educational officers of this organization have frequently been made by such people as Cardinal Lavitrano of Palermo; the Arch-bishop of Mazara del Vallo, who is especially concerned with education in his arch-diocese; Father Gliozzo of the Society of Jesus, who is the head of an important school in Palermo, and whose advice was constantly used in the preparation of Plans of Study; and Cardinal Scalesi of Naples.

VISION OF RESPONSIBILITY

Education Subcommission and Regional Education Officers

The following division of responsibility between the Education Sub-commission ACC, AAC and Regional Education Officers, applies to all regions while they are under Allied Military Government. It also indicates the general lines of responsibility for advice and assistance to be given to Italian officials in territory under the Italian Government and ACC.

Responsibilities of the Education Sub-Commission will include the following:

1. Establishment of general policies, applicable to more than one region, in regard to:
 - a. Conditions of appointment or approval of all school personnel.
 - b. Conditions under which schools and universities may be opened or closed.
 2. Matters of school programs, text books, and organization.
 3. Any alterations in the existing types of schools.
 4. Production, approval or disapproval of all text book or parts thereof.
 5. Appointment and approval, in all universities and institutions of university rank, of:
 - a. Rectors and heads;
 - b. Presidents of faculties;
 - c. Titular professors, all members of the senatus academicus, and personnel of equivalent rank.
- Responsibilities of Regional Education Officers will include the following:
1. Approval and appointment of all provveditori, inspectors, directors, teachers and other personnel for schools below university rank, subject only to HQ policies as to conditions affecting appointment.

 - c. Rectors or heads of such institutions;
 - d. Presidents of Faculties;
 - e. Titular professors, members of the senatus academicus and persons of corresponding rank subject only to HQ policies as to conditions affecting such appointments.
3. All local provincial or regional administrative matters connected with universities, and other higher institutions, elementary and secondary schools, kindergartens, and out-of-school youth and adult education programs, within the General framework of headquarters policies.

4. All arrangements for covering "ordinary" expenses of educational institutions, heretofore paid on a provincial level.
5. All arrangements for covering "extraordinary" expenses for repair of bombed or damaged buildings, etc., subject to approval of this plan by the CFO.
6. The opening of state and church schools, under general policies of HQ.
7. The opening of establishments of new state or church schools subject only to conformity with HQ policies.
8. Determination of dates of opening and closing schools, (HQ to be kept informed)
9. Same for opening and closing of universities (Names to be added).

PROPOSED PROCEDURES FOR DEFASCISTIZATION

1. In territory under control of the Allied Military Government, Schede Personali for all administrative officers will be issued by the Regional Education Officer through the Provincial Commissioner and the Provveditore agli Studi.
2. Schede will be examined, according to regional procedures, by the C.I.C., F.F.S., or Public Safety Division and dismissals or suspension carried out by the Regional Commissioner on advice of the Regional Education Officer.
3. On a form provided by the Education Subcommission, the Education Officer will submit a card for each person dismissed or suspended and will keep the scheda and/or other supporting evidence on file in regional office.
4. In territory under control of Italian Government, either the Regional Education Officer or the Provveditore agli Studi may request a scheda personale from any teacher or administrative officer whose employment or retention is under consideration.
5. The Regional Education Officer will submit a card for each person recommended for dismissal or suspension on a form provided by the Education Subcommission. Accompanying this list will be a file for each individual concerned including details of suspension or dismissal, scheda etc.
6. The Regional Education Officer will also submit a card for each of those falling within the categories for dismissal but retained in service, with accompanying scheda and supporting data, on forms provided by the Education Subcommission. These cards with accompanying materials will then be forwarded by the Education Subcommission to the Minister of Education.
7. Notice will be sent to Subcommission in the event of appeals. A Regional Education Officer may act as forwarding agent for appeals, sending them to the Minister through the Subcommission.

- 5) Qualsiasi funzionario è ufficiale, ai quali pervengono tali domande può, senza tenere conto delle provvidenze, sollevare difficoltà. In tal caso la decisione finale finirà di competenza del Ministro dell'Istruzione Pubblica e del Direttore delle Sottocommissione dell'Educazione, eccezione fatta nel territorio del Governo Militare, dove il Commissario Regionale ha sempre il diritto di rifiutare un trasferimento nella o fuori della sua regione.

Si sottintende che il Ministro nel suo territorio, cioè 3253 gli alleati nel loro, può procedere al trasferimento del personale insegnante secondo le necessità del caso.

PROCEDURES FOR DISMISSAL

Adopted at June, 1944 meeting
of the Education Subcommission.

1. In territory under control of the Allied Military Government, Schedule Personnel for all Administrative officers will be issued by the Regional Education Officer through the Provincial Commissioner and the Provveditore agli Studi.
2. Schedule will be examined, according to regional procedures, by the C.I.C., I.P.S., or Public Safety Division and dismissals or suspension carried out by the Regional Commissioner on advice of the Regional Education Officer.
3. On a form provided by the Education Subcommission, the Education Officer will submit a card for each person dismissed or suspended and will keep the schedule and/or other supporting evidence on file in regional office.
4. In territory under control of Italian Government, either the Regional Education Officer or the Provveditore agli Studi may request a schedule personnel from any teacher or administrative officer whose employment or retention is under consideration.
5. In Italian Government territory the Regional Education Officer will submit a card for each person recommended for dismissal or suspension on a form provided by the Education Subcommission. According to this list will be a file for each individual concerned including details of suspension or dismissal, schedule, etc.
6. In Italian Government territory the Regional Education Officer will also submit a card for each of those falling within the categories for dismissal but retained in service, with accompanying schedule and supporting documents, on forms provided by the Education Subcommission. These cards with accompanying materials will then be forwarded by the Education Subcommission to the Minister of Education.

4. In territory under control of Provveditor Segli Studi lay the Regional Education Officer or the Provveditor or teacher or administrative officer whose employment or retention is under consideration.

5. Request a schedule personnel from any teacher or administrative officer will submit a card for each person recommended for dismissal or suspension on a form provided by the Education Sub-commission. Accompanying this list will be a file for each individual concerned including details of suspension or dismissal, service, etc.

6. In Italian Government territory the Regional Education Officer will also submit a card for each of those falling within the categories for dismissal but retained in service, with accompanying schedule and supporting note, on forms provided by the Education Sub-commission. These cards with accompanying lists will then be forwarded by the Education Sub-commission to the Minister of Education.

7. In Italian Government territory notice will be sent to Sub-commission in the event of appeals. A Regional Education Officer act as forwarding agent for appeals, sending them to the Minister through the Sub-commission.

In Military Government territory it is recommended that a carefully chosen commission be set up in each province to hear individual cases and to recommend for or against dismissal:

- a) when a person dismissed by category asks for a hearing
- b) when the provveditor or the Education Officer desires counsel in regard to a specific person whose possible dismissal is contemplated.
