Dear John:

We're sending you to Venezia Giulia as REO. I'm signalling WAGSTAFF to go to Genoa at once to replace you. Please brief him on your Region, get him around to the provinces, and come down to Rome as quickly as you can without sacrificing Liguria. I'll keep you here a day to talk over the Venezia Giulia situation, then have you fly up there. Colonel BOWMAN has sent an urgent message asking that you come immediately. So I want to move things as fast as is compatible with fairness to WAGSTAFF and Liguria. If you get here in the afternoon, we may be able to settle things during the late afternoon and evening and get you on a plane the next morning.

Better drive to Torino and take the plane to Rome. Make your reservations ahead of time -- or ask Sam NOR to do so -- and let me know when to expect you.

If you have too much kit for the plane, ship it across to Trieste direct, addressed to yourself as REO, AM Venezia Giulia (not Venezia Giulia Region; not XIII Corps just AM Venezia Giulia). Your office will be in Trieste in the Casa del Popolo (formerly Casa dei Pasoi) -- nice buildings; and you'll be living in the Hotel Regina probably.

I enclose a copy of my report on Venezia Giulia.

10. 1st Lt. SIMONI has worked, successively, as Education Officer in Education Subcommission Hq., in Region 4, in Region 5, in Marche-Umbria Region, and in Liguria Region. He did swift, pioneer work in organizing the opening of schools in the badly devastated province of Frosinone; he assisted and then succeeded the Regional Education Officer in Marche-Abruzzi Region. First as a 2nd Lieutenant then as a 1st Lieutenant he carried the full responsibility of a Captain or Major, overcoming the handicaps of low rank by sheer efficiency and tact. He entered Liguria Region as soon as it was opened and rapidly and effectively set all phases of education going. He has been loyal, devoted, intelligent and able in his work and has obtained the liking and respect of all with whom he has dealt.
11. 1st Lt. SIMONI has carried responsibility, far above his rank, has opened schools in badly devastated areas, overcoming great difficulties, has shown energy, initiative and devotion beyond the demands of duty, and has obtained the liking and respect of all with whom he has dealt.

1. 1st Lieutenant JOHN P. SIMONI, O-1798303, CMP, has been in grade since 7 November, 1944. His promotion from 2nd to 1st Lieutenant was delayed far longer than either his ability or his responsibility justified.
2. As Regional Education Officer he has been carrying the responsibility which, in every other case, is carried by a Captain or a Major.
3. I need not tell you how efficient, loyal, hard-working, and generally competent he is. I am sure you agree with me that he is fully deserving of higher rank.

3. 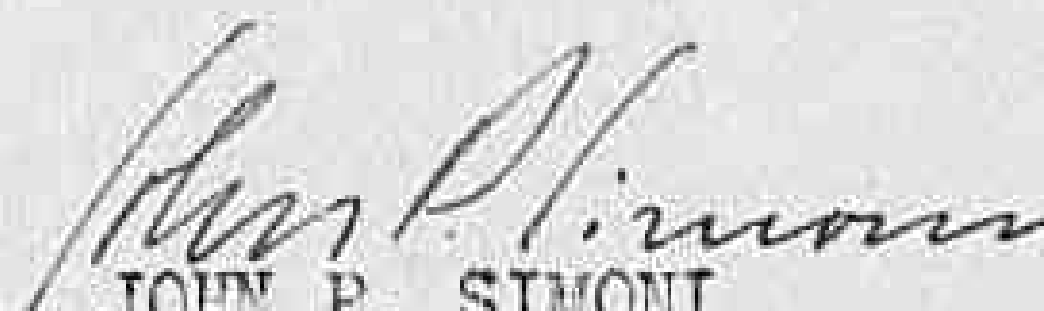
