1. It is requested that an interchange of cars be made between the Education Subcommittee and the Education Division of Lazio-Umbria Region for the following reason :

2. When the present A/Director of Education was Regional Education Officer for old Region 4, in June, 1944, he was requested to help requisition cars for the Regional Hq. Recognizing the urgency of transport, he for the time being sacrificed his proper work and found and requisitioned a large proportion of the Region 4 Hq. cars. From these he was allowed to select a suitable car for his own official use.

3. The car selected, and used by him ever since with great satisfaction, is a 7-passenger Lancia, known as No.5.

4. When most of the old Region 4 Hq. staff went forward as Region 12, part of its transport was taken with it; part was turned over to the Lazio-Umbria Region. At the request of the Regional Education Officer, No.5 was transferred to Lazio-Umbria Region, where the present A/Director of Education continued to use it as Regional Education Officer for Lazio-Umbria.

5. When he was designated A/Director of the Education Subcommittee on 2 October, he arranged informally with the new Regional Education Officer of Lazio-Umbria, Major Gregory, who officially became the possessor of No.5, to allow him to continue to use it, the A/Director in exchange putting his AC Hq. car at the disposition of Major Gregory. This worked to the satisfaction of both officers concerned.

6. Now, however, Major Gregory has been ordered to turn his car into the Lazio-Umbria Hq. pool, making the former informal arrangement impossible. 4067

7. It is desirable for the A/Director of the Education

Subcommission to continue to have Car No.5, for the following reasons :

- a) It is appropriate in appearance for calls on the Minister, embassies, etc.
- b) It is large enough to make possible the transportation of the Hq. Education staff, Italian committees working with the Education Subcommission, etc.
- c) It has been continuously driven and cared for by an expert chauffeur, selected last June by the present A/Director of Education. 



SUBJECT : Return of Requisitioned Motor Vehicle

TO : Regional Commissioner,  
Lazio-Umbria Region.

Reference your MRO/157 of 28 December.

1. The requisitioned car (No.5) assigned to me when I was Regional Education Officer in Lazio-Umbria Region was turned over to Major Gregory when he became Acting Regional Education Officer and I became Acting Director of the Education Subcommittee. I have had an Allied Commission Hq. car ever since. Car No.5 is in Major Gregory's possession and, as always, is kept in the Lazio-Umbria Hq. garage.
2. When Major Gregory's car has been laid up for repairs, or he has for any other reason needed my AC Hq. car, I have been glad to lend it to him for a few hours or a day at a time. He has been equally obliging when I have needed his car. We work in close cooperation in all ways, as witness, for example, the fact that when you were unable to furnish him an Enlisted Man I lent him, indefinitely, one of the two enlisted men assigned to my subcommittee; this Enlisted Man (Ed Marco) has been with him continuously from 2 October.
3. Except for a car which I requisitioned last summer for the use of the Provveditore agli Studi, and which Major Gregory is sometimes able to use for his assistants, Car No.5 which I turned over to him, is the only car assigned to your Regional Education Officer. As A/Director of the Education Subcommittee I strongly recommend that Major Gregory be not deprived of this car. In every Region we have found that one car assigned for the exclusive use of the Regional Education Officer is an absolute minimum for his effective work.

TO : A/RC, Lazio-Gabriele Region.

1. Major Washburne tells me that you have asked him to turn into our Garage the car (No. 5) he formerly had.
2. This car was turned over to me by Major Washburne when I became Acting Regional Education Officer. It is my only car for regular use. There is one other car in the Division, but it was requisitioned by Major Washburne last summer for the use of the Provveditore agli Studi, who cannot carry out his functions without transport. When the Provveditore is not using this car, it serves as a second car for this Division, used by my assistant.
3. Through a personal arrangement between Major Washburne and me he gives me the use of his headquarters AC car and uses my car part of the time, my car being one which he personally found and requisitioned, and being driven by a chauffeur he found and who has driven him for the last six months. I am glad to extend this personal favor to Major Washburne, since it in no way interferes with my work. His Headquarters car serves my purposes equally well, and when I need my own larger car, Major Washburne is always willing to make it available to me. I am the official custodian of car No. 5; it is driven by a Lazio-Gabriele Region driver, and is kept in our garage. Officially and actually this is the only car assigned to me and is essential to my work.
4. If the Education Division is to be deprived of one of its two cars, the one requisitioned for the Provveditore agli Studi is the one. I should turn in to the pool, not my No. 5. But it will be a serious handicap to the educational work of the Region-particularly of Rome Province, if this car, used both by the Provveditore and my staff, is taken away.
5. You are therefore requested to allow the present arrangement to stand.

Statement of Capt. Joseph Vincent VELLA, General List 30L892

-----  
On Monday 6th November, 1944, at 14-35 hours I parked a motor car, Lancia Aprilia, No. ROMA 66722, HQ. AC. No. 521, in Via Molise, close to the Headquarters of the Allied Commission. The car was secure. This vehicle is allotted to the Education Subcommission of my Headquarters and used by me in the course of my official duties.

In consequence of what I was told, at about 16-30 hours, I went to Via Molise and after making a search failed to find the car. I informed immediately my Headquarters and both Military and Civil Police.

On Sunday, 19th November, 1944, I went to San Vito Romano with some Italian civil police officers and in a garage there I saw a Lancia Aprilia, AC. HQ., No. 521. I identified the car as the one which I had left in Via Molise on the 6th November, 1944. The AC. HQ. markings had been painted over but could still be clearly seen under the surface.

I took possession of the car and returned with it to my Headquarters. No person had authority to take this car without my permission and which was not given by me on the 6th November, 1944.
