SUBJECT : Derequisitioning University of
Pisa Medical Buildings.

TO : G-5, AFHQ.

1. Pisa University Medical School has been requisitioned by M ABC No.6. If this medical school is not immediately derequisitioned the Faculty of Medicine of the University of Pisa will have to close.
2. The need for this Medical School cannot be too strongly urged. There are about 230 senior students, 60% of whom are expected to qualify in the present academic year, and a further 300 students in the first four years of their medical course. Only essential war exigencies should be allowed to interfere with these studies. Italy requires young doctors who will be free from the political bias and corruption of the Fascist regime.
3. An interview of 9 October between Captain Keller MFAA Officer, AMG Fifth Army, and Colonel Cole and Major Caswell of the unit concerned was followed by a statement from Captain D.R.B. Myers, G-2,3, AMG 5th Army, that, as directed by the Chief of Staff, he had telephoned General Tate about the requisition, and that the General said he would have the Air Corps moved out. Then, on 18 November the HEO was notified that the requisition was "on" again.
4. A signal and letter just received from AMG Toscana region indicate that while there are a number of empty buildings on the south side of the river that would be suitable for Depot space (the purpose for which the Air Corps require the school), there are no alternative locations for the library, laboratories, dissecting rooms, etc., of the medical school.
5. The buildings are not as yet occupied by the military unit, but the requisition stands and the University is not allowed to use them.
6. You are therefore requested to take such steps as are necessary toward having the Medical School buildings of the University of Pisa derequisitioned.





SUBJECT : University of Pisa Medical Buildings.

TO : G.A. Section.

Reference (C).

1. Following your request I telephoned Captain NOE, Regional Education Officer for Toscana, and received the following replies:
2. The Air Force officer who stated finally that the Medical Buildings of the University of Pisa could not be released from requisition was Colonel COLE.
3. The last AMG officer to discuss the matter with Colonel COLE was Major MAKENZIE of Public Health.
4. The only reason given was "Military necessity".
5. Colonel WALTERS, Provincial Commissioner for Pisa is the one who states that the available buildings south of the river would be suitable for the purposes for which the Medical Buildings were requisitioned.
6. Captain NOE feels that in view of the present tenseness of the military situation north of Pisa it is inadvisable to take any further steps or undertake any conversations for the moment. He recommends waiting at least a week.
7. When he considers the time ripe he will either talk with Colonel COLE himself or ask the Regional Commissioner to do so and will report results to this Headquarters.

Reference G-5:000.3 of 8 February.

1. The communications enclosed appear to be somewhat out of channels!
2. The general policy laid down for Zone A in Venezia Giulia is that Italian law prior to 8 September 1943 shall be effective except where for Military Government reasons special decrees by AMG provide otherwise. (See Proclamation No.1, Part I, Article III). Reference to old Austrian legal provisions therefor has no bearing on the matter.
3. The Educational Policies, approved both by the Allied Commission and by the SCAO, 13th Corps, in accordance with general policy stated above, provide that the programs of the Slavic and Italian schools in Zone A shall be the same as those in Italy with the following exceptions:
 - a. Instruction will be in the mother tongue of the students.
 - b. Courses in Slovene will be offered to Italian-speaking children, and courses in Italian to Slovene-speaking children.
 - c. A course in Slavic history and culture will be included for both Slovene and Italian children.
4. The Italian governmental programs for secondary schools (except the Istituto Magistrale) provide one period a week for religious instruction. This is the same allotment of time as before 8 September, 1943. There is the same provision in the programs of both Italian and Slovene schools in Venezia Giulia.

5. Since the course in Slavic history and culture, and the elective course in Slovene or Italian, in Zone A schools, are in addition to the already heavy program of the secondary schools of Italy, the proposed increase in time given to religious instruction is not practicable.

6. I am conveying the above information direct to Mr. Cowen for the information of the Vatican.

Some time ago, the school authorities in Poland raised the question whether university students from the Alto Adige could continue their studies in Austrian Universities.

The question was referred to AFM for decision.

On the 18th January AFM replied to this office that the conditions of food and housing in Austria have made it obligatory to refuse admission to the United States zone and to Vienna of all new residents whose presence is not necessary for the accomplishment of the mission of the United States Forces in Austria.

Further to that, British authorities at Vienna state that the University of Graz is severely over-crowded at present and that they will advise local military government authorities not to approve the request in so far as students from Graz are concerned at the present time.

AFM suggests that the request be resubmitted in six months.

1. Reference is made to your ED/2A/1.0/AG of November, 1945, and paragraph 3, our G-5: 350 of 23 November 1945, subject as above.

2. Information relative to the subject request has been received as follows from the local authorities of the areas concerned:

a. Condition of food and housing in Austria have made it obligatory to refuse admission to the United States Zone and to Vienna of all non-residents whose presence is not necessary for the accomplishment of the Mission of the United States Forces in Austria.

b. Authority, therefore, cannot be granted for these students to attend schools at Vienna and at Salzburg.

c. It has been suggested that this request be resubmitted in six months.

d. British authorities at Vienna state that the University of Graz is severely overcrowded at present and that they will advise local Military Government Authorities not to approve the request insofar as students from Graz are concerned at the present time.

Dear Admiral Stone:

My predecessor studied the matter of instituting courses in educational psychology and practical pedagogy in our teacher-training schools.

In Italy, for the past twenty years, there have been no opportunities for university professors, who should be in charge of such courses, to acquire the necessary specific preparation.

I therefore find it necessary to entrust to Prof. Guido De Ruggiero, former Minister of Public Instruction and now Vice-President of the Superior Council on Education, the commission of going to Switzerland (Geneva in particular) to visit the Jean Jacques Rousseau Institute, recognized as one of the best in Europe, to investigate the possibility of sending a small number of selected professors there to take a special course. He will also examine the large collection of books in the International Bureau of Education, in Geneva, and select those text-books which might be adopted in Italy.

But since Prof. De Ruggiero is not a specialist in psychology and pedagogy, I desire that Lt.Col. Carleton W. Washburne, Director of Education for the Allied Commission, accompany him as consultant.

Col. Washburne, a noted specialist in the preparation of teachers and fully cognizant of the situation in Italy, is well acquainted with the Director of the Jean Jacques Rousseau Institute and thus could give valuable help to De Ruggiero.

I would be grateful if you would be so kind as to authorize Col. Washburne to go to Geneva with Prof. De Ruggiero as soon as possible.

1. LOCAL GOVERNMENT -

a) Officials - Prefect of Udine: Avv. Agostino CAVOMINI.
The appointment of all Italian Government officials including the Prefect of Udine remains the responsibility of the Provincial Commissioner ASG.

In view of the possible hand back of Udine Province within the year, it will frequently be desirable to secure agreement with the Italian Government in respect of the more important appointments.

I suggest that this be done by direct correspondence, between P.O. ULLINE and the Italian Ministry concerned, copy to VJ Copy.

b) Elections -

It is probable that administrative elections will be held in the last week of February, and elections for the Costituente on the first Sunday in May. It is most desirable that Udine Province follow, in respect of elections, the exact pattern laid down by the Italian Government in the rest of Italy. For the purpose of these elections Udine forms part of the second "collegio" in the Veneto, comprising Venezia, Treviso, Udine and Belluno. Members required by the Italian Government in respect of the preparation of electoral lists should be forwarded by the Prefect, through P.O. ULLINE, direct to the Ministry of the Interior, Rome.

2. LEGAL

All proclamations issued heretofore under ASG in Udine will remain in force. These include General Orders 1, 2, 18, 20, 24, 25, 27, 29, 33, 35, 35A, 39, 35A, 44, 45; Regional Orders 1, 2, 3, 4, 5, 6, 7, 9, 11, 12, 13, 14, 16, 17, 18, 19, 20, 21 and such Provincial Orders as may from time to time have been issued.

The power of making Provincial Orders for the Province of Udine will continue to lie with the Provincial Commissioner. It is however, suggested that issue of Provincial Orders be limited to matters of real urgency and that necessary

b) Elections

These include General Orders 1, 2, 4, 20, 21, 25, 27, 29, 33, 35, 35a, 35, 39a, 41, 45; Regional Orders 1, 2, 3, 4, 5, 6, 7, 9, 11, 12, 13, 14, 16, 17, 18, 19, 20, 21 and such Provincial Orders as may from time to time have been issued.

The power of making Provincial Orders for the Province of Udine will continue to lie with the Provincial Commissioner. It is however, suggested that issue of Provincial Orders be limited to matters of real urgency and that necessary local administrative action be taken by Prefect's decrees, endorsed by ASD. It is most desirable that proclamations issued in Zone "A" in the light of the special circumstances obtaining there should not be also made applicable to Udine.

b) Legislation

All Italian legislation hitherto implemented in North Italy ^{§ 4465} prior of the Chief Commissioner has automatically become law in Udine. It is possible that in future, there may be no Royal Sub-Commission in Rome to carry out this function of forwarding and implementing Italian legislation. It therefore appears desirable that a copy of each Gazzetta Ufficiale be sent direct by the Ministry of Justice to the Provincial Commissioner Udine, in order that he may at once carry out the procedure implementing the D.L. contained therein. A more simple method, which contains a certain derogation of ASD powers but possesses several practical advantages is to say that all D.L. as they are passed by the Italian Government become automatically law in Udine, unless expressly excluded from implementation by the Provincial Commissioner.

c) AMG Courts -

Udine Province will have on present plans two experienced Legal Officers. Cases involving violations of AMG Proclamations and Orders can therefore be tried by AMG Courts.

It must however be realized that with the possible disappearance of the Legal Sub-Commission there would be no reviewing officer. It is suggested therefore that authority to review cases should be vested in the Provincial Commissioner or such Officer as may be designated by him. At the same time jurisdiction to try violations of AMG Proclamations and Orders should be conferred on Italian Courts subject to the supervision and observation of the AMG Legal Officers.

It is my experience that except in respect of the infliction of the death penalty, Italian Courts are as severe in their sentences as any Allied Court would be likely to be.

I suggest that the Provincial Commissioner should be empowered to convene AMG General Courts and the Senior Officer of the Province authorized to act as President.

d) Italian Courts

Appeals from Tribunals are to Court of Appeal, Venice and from Extraordinary Courts as laid down in D.L. 702.

e) Extradition

To continue on the lines and subject to the control by AMG indicated in recent directives from G.I. Section.

The provincial Italian Patriot Liaison officer here already, in ASG territory, been placed under the orders of the Prefect. This course should be followed in Udine. Their work now depends from the Ministry of Post War Assistance.

PROVINCES OF BELLUNO, TREVISO, VERONA

Also: MONZA, NOVARA, VIGEVANO, VERONA, TREVISO.

6. A small Liaison Group (under command Lt.Col. P.O. Maria (A)) will be established at Treviso, with general Liaison functions over the eight provinces above named.

A similar group will be established at Bolzano.

9. Instructions defining the functions of these Liaison Groups will shortly be issued by the Allied Commission. In general, however, that these groups exist to assist the Allies and thereby the Ambassadors, of the conditions in the provinces also to assist in every way possible relations between the Allied Military Authorities and the Italian civil administration.

10. The groups will, however, have no executive status and the Italian Government will have full sovereign rights in the above named provinces (except in respect of a few specially reserved matters affecting Allied troops).

1. A number of important matters related to the work of the Education Subcommittee can be handled with much greater effectiveness and dispatch by personal contact between the Director of Education, AFHQ, and the persons and institutions concerned than by correspondence or signals.
2. At the present time the following matters require such contact in the United States:
 - a. An attempt to obtain fellowships for professors of education and psychology from Italy - these subjects have been lacking in Italy for over twenty years and the Italian Government has adopted a new program for teacher training which necessitates special preparation of a group of professors.
 - b. Arrangements for a mission from the Italian Ministry of Public Instruction to spend some weeks in the United States studying the educational system and methods.
 - c. Arrangements for student interchange between the United States and Italy.
 - d. Arrangements for cultural interchange of concert artists between the United States and Italy.
 - e. Conferences with the American Library Association and others in regard to the obtaining of scholarly publications to rehabilitate university and other libraries in Italy.
 - f. Exploration of the possibility of interesting Italo-American organizations and others in sending technical and scientific apparatus to Italy to replace the materials destroyed by war and essential for the economic and scientific rehabilitation of Italy.
 - g. Selection of literature requested by various Ministerial commission and others to help them with their work of educational reconstruction; pending requests include literature on the training of physical education teachers; technical and vocational education; the teaching of psychology and education; the organizations of Parent-Teacher associations; the education of handicapped children.

3. In two or three weeks of direct contact with appropriate persons and institutions and access to libraries, the Director of Education can accomplish far more than would be possible in several months of correspondence. Since these matters all are urgent and since there is not certitude as to long continuance of the Education Sub-Commission and its ability, therefore, to give the help desired by the Italian Government, it is desirable that the Director be sent to the United States to accomplish this mission.

4. The British Council in Rome requests that the Director of Education discuss analogous matters with the British Council in London.

5. It is therefore requested that travel orders be authorized for Lt. Col. Carleton H. Washburne, O-918352, Director of Education, AC, to proceed to the United States on or about 15 December for a period of approximately three weeks, returning by way of the United Kingdom, travelling by air transport, with per diem and air rail transportation allowances. Travel in the United States will be to Washington, D.C., New York, Boston, Chicago, and Atlanta. Travel in the United Kingdom will be to London and such other cities as are necessary for the mission.

6. Since the early return of Lt. Col. Washburne to this Headquarters is urgent, it is requested that he be given a travel priority of 2.

SUBJECT: University of Perugia.

21 May, 1945

TO: G-5, AFHQ
(Att: Col JACKMAN).

Confirming telephone conversation of 15 May.

1. I have gone through the draft agreement for the hire of part of the University of Perugia, in careful detail, with the Rector of the University.
2. He and I agree with the terms therein set forth, with a few very minor corrections or additions as indicated below.
3. In the title, introduction, and paragraph 1, the name of the university should read: "R. Università degli Studi di Perugia".
4. In paragraph 2, it should be made clear that the scientific apparatus and materials in the Pharmaceutical Institute (Item 1 in schedule 1) may be removed and retained by the University. This is in accordance with verbal agreement with Lt. Col. W.A.R. SMITH.
5. Paragraph 5, second sentence, should be made a little more flexible by adding, after the words "on the conclusion of each day's session", the following: "or on the conclusion of each consecutive period of use".
6. Provision should be made for payment, by the British army, of janitors and laboratory assistants for the days they serve the British Army school in the rooms of Schedule II, and for the payment of janitor service, etc., full time, in the rooms of Schedule I.
7. Provision should be made, either in the contract or in a supplementary letter, of assurance, for the following two matters:
 - (a) The use of British army trucks to remove the Etruscan Museum specimens (most of them stone) from the corridor which gives access from the spiral staircase to the second floor classrooms desired by the Army School, and the delivery of these for safe keeping to a place designated by the Rector;
 - (b) Agreement that four or five times during the year, for special occasions, the University may, on request of the Rector, use the large hall on the ground floor.
8. Will you please send me two more marked prints of the floor plans - one for the Minister of Public Instruction and one for my files.

9. It will be greatly appreciated if a method can be found for paying the rental, to be agreed upon, currently rather than at some indefinite future date when the Italian Government pays for requisitions.

10. It is essential for the smooth working of the plan and the consequent effective functioning of both the University and the British Army School that the Director of the Army School and the Rector of the University act in a spirit of mutual understanding, good will, and consideration for each other's needs. I believe I can vouch for the Rector of the University doing his full part in this regard - he has been most cooperative throughout these negotiations. I trust that your Director may be instructed that he is to have the welfare of the University in mind as well as the welfare of his school and to try to work, not in the spirit of a military occupant of enemy property, but in the spirit of a colleague sharing university facilities with the representative of a friendly nation.

1. Following the conference with your representative, the Rector of the University of Perugia, a representative (Lt. Col. W.A.R. Smith) of Allied Force Headquarters, and me in Perugia on 8 May, a draft agreement was drawn up which embodied our decisions.

2. On 19 May I went through this agreement in detail with the Rector of the University of Perugia, in Rome. We made certain slight alterations, which were confirmed by telephone with Allied Force Headquarters.

3. A copy of the draft agreement, as submitted to us in English, is enclosed herewith, together with a copy of the Italian translation which embodies the slight changes made.

4. Enclosed also is a copy of my letter to Allied Force Headquarters, confirming the telephone conversation and adding a suggestion as to the spirit in which the plan should be carried out.

5. I have only one set of the floor plans referred to. I shall show these to you at our next meeting, but I have requested an extra copy for your files and a copy for the Rector's files.

6. I hope that this agreement will have your approval. I enclose an extra copy of this letter on which you may inscribe your nulla osta if you approve.

His Britannic Majesty's Principal Secretary of State for War hereinafter known as the Lessee on the one part and the Principal Director of the University of PERUGIA hereinafter known as the Lessor on the other part agree in the following terms

1. That the agreement shall take effect from 1945 and shall cover the conditions under which the British Army in Italy shall enjoy the use of accommodation, apparatus, equipment and amenities of the premises known as the Università D'egli Studi Perugia hereinafter referred to as the Università.
2. The accommodation in the Università listed in Schedule I and shown on the attached plans in red shall be handed over complete with all amenities to the Lessee.
3. The accommodation listed in Schedule II and shown on the attached plans in blue complete with all apparatuses, apparatus, materials and other amenities shall be placed at the disposal of the Lessee on condition hereinafter described for periods as and when required but not to exceed three full working days in any one week.

2. The accommodation in the University listed in Schedule I and shown on the attached plans in red shall be handed over complete with all amenities to the Lessee.

3. The accommodation listed in Schedule II and shown on the attached plans in blue complete with all appliances, apparatus, materials and other amenities shall be placed at the disposal of the Lessee on condition hereinafter described for periods as and when required but not to exceed three full working days in any one week.

4. Accommodation in Schedule I shall be treated as on lease to the Lessee on conditions in every way similar to those governing the use of a requisitioned building.

The accommodation shown in Schedule II together with all appliances - furniture fittings - apparatus and instructional materials and amenities shall be normally held in possession of and be the responsibility of the Lessor except during those periods when they are handed over to the Lessee for instructional purposes. Breakages - deficiencies and materials used for instruction will be listed in detail on the conclusion of each day's session and will be replaced in kind by the Lessee as far as his resources permit. Damages not so replaced will be acknowledged in writing by the Lessee to the Lessor.

SUBJECT : Cultural Interchange.

TO : G-5, AFHQ.

1. As one important aspect of cultural interchange between Italy and the United Nations, it is desirable to effect the interchange of concert artists.
2. In regard to interchange between Italy and the United States the Education Subcommittee has been in communication with Mr. André Mertens, Director of the Foreign Office of Columbia Concert Corporation, who has also been authorized to act for the corresponding organization of the National Broadcasting Corporation. He makes the arrangements for European tours of American artists, and for engagements with Metropolitan Opera, New York Philharmonic etc., for foreign artists to appear on their programs.
3. Things are now far enough advanced in tentative arrangements for the offering of contracts, both ways, to make it highly desirable to have Mr. Mertens come to Italy, make personal contacts with artists and managers, and bring the preliminary arrangements to a head.
4. It is therefore requested that Mr. Mertens be invited to come to Italy (at his organization's expense) and that travel facilities be accorded to him.

Dear Mrs. Leigh-White,

As Mr. Howard no longer deals with Italian affairs, he has passed to me your letter of the 13th March about the proposal that Lady Baden-Powell, accompanied by yourself or by a Swiss colleague, should visit Rome sometime during next June.

While we fully sympathise with the desire of the World Association to encourage the Girl Guide organisation in Italy, we feel bound to point out that there may well be difficulties in arranging a visit such as you suggest owing to the general restrictions on entry into Italy of persons not directly connected with the war effort. The Boy Scout Association have in fact expressed a similar wish, which it has been necessary to refuse.

It is possible of course that circumstances may have changed by next June and we shall therefore ask the Allied authorities in Italy to let us know if and when it is possible to grant the necessary facilities.

Dear Mr. Howard,

We should very much appreciate your help and advice in the following matter.

As you may already know, a Girl Guide organisation has recently been started with a Committee in Rome. This is being helped and supported by the Education Sub-Committee of the Allied Commission under Major Washburne and Mr. Catty, who is acting, partly on behalf of Major Washburne and partly as our representative until such time as we can send a representative of our own.

Both Major Washburne and Mr. Catty have been urging this upon us, the idea being that our representative should help in matters of administration and policy on lines similar to what the Reverend P. Logan did for the Boy Scouts when he was in Rome last autumn. I may say I have seen Mr. Logan recently and he also is strongly in favour of our taking such action. Furthermore, I am told, that the Italian Guides are inviting Lady Baden-Powell, the World Chief Guide, and she herself is most anxious to accept this invitation. Our proposal therefore is that Lady Baden-Powell, accompanied either by myself or possibly a Swiss colleague, should visit Rome sometime during June next. We expect to be in Switzerland all May and this would appear to be a suitable opportunity.

On the other hand, we realise fully that such a visit must have the full support of the Allied Commission and I am writing by the same post to Brigadier Upjohn, Vice President of the Civil Affairs Section of the Allied Commission.

I assume, however, that it will be equally necessary for us to have the support of the Foreign Office and that special steps will have to be taken to secure the necessary permits.

Any help and advice that you can give us in this matter we shall appreciate very much indeed.

I might perhaps mention that Mr. ⁴⁴³Spaigh of the French Division has a copy of a memo which we addressed to Lord Halifax in 1940 on this subject of travel of our representatives, in which we give full particulars of

our work and of our purpose. I feel sure it will be possible for you to see this memo should you wish to do so.

I have seen the application dated the 8th Sept. 1943 of Professoressa Bianca Giudice Silvia asking to be appointed for the teaching of the English language and literature in Secondary Schools. (30)

Considering that Professoressa Bianca Giudice born in Glasgow on the 16th Sept. 1907 has taught in Government Schools since 1928 with intervals, and from 1942-1943 she has been a lecturer in the English language and literature at the R. University of Catania thus giving full proof of a perfect knowledge of these subjects as well as her teaching skill and experience.

Considering the just criterion of the Anglo-American Govt. who propose capable people for vacancies in the Universities and give them fixed posts in order to avoid any prejudice which could arise to the schools by temporary teachers.

Having seen the mandate of 29th Sept. 1943 by which His Excellency the Governor has approved the requested act, authorising this office to publish the appropriate decree.

Having seen the state of the Provincial Schools, and having considered that in the R. Liceo Scientifico there is a vacancy for the English language & literature beginning with the next school year 1943-44.

There being no objection on the part of this office and it being known to us that Prof. Silvia Bianca Giudice is a good teacher and a highly respectable citizen in every way

I am writing to you again with respect to my wife in order to give further details.

" (1) The Provveditore and Staff of Castelforte are kept secret a document which would have solved everything which indeed had already solved the question.

The lessons for the new session begin on the 6th November. So you will see how urgent it is that you do something at once by telephone or wire to the Provveditore agli Studi of Galtanisetta.

I must earnestly implore you to act immediately. It means taking the food from four children."

2. It appears that the elder girl is aged 22, is a graduate of Messina University and a qualified teacher. It is stated that she was given work as a teacher by the "Military Governor" of Salina, but that since the Italians have taken over she has lost her employment.

3. It is further understood that there are three vacant teaching posts in the neighbourhood, one being in Salina itself and two in the neighbouring town of Lingua.

4. Request is made as to whether it is possible to press for employment of the elder girl through the Provveditore degli Studi, Messina.

5. It is requested that the matter be investigated and a report be made soonest to this HQ as to action taken.

TRANSLATION

To:- Provveditore agli Studi - CALTANISETTA

I the undersigned Prof. Sylvia Vianca Giudice, teacher extraordinary of the English language at the R. Liceo Scientifico, Caltanissetta, apply to you as follows:- (25)

- (1) The Preside of the R. Liceo Scientifico, by letter dated 2 Oct 44, notified me of Note No 3869 dated 26 Sep 44, in which it is stated that the Ministry did not ratify my appointment as regular teacher of the English language in the R. Liceo Scientifico.
- (2) I venture to declare that this notification, and its contents, have no judicial effect: indeed, the aforesaid expression of opinion aims at depriving me of my juridical status as a State employee, a status which cannot be taken away by a mere letter from the Ministry.
- (3) However, my judicial status as a regular teacher derives from the following:
 - (a) Act dated 29 Sep 43 by which His Excell. the Governor of Caltanissetta grants my request for an appointment and authorises the Provveditore of Caltanissetta to issue the appropriate decree.
 - (b) Decree of nomination issued by the Provveditore, bearing the signature from His Excell. the Governor of Caltanissetta.
 - (c) The Regio Decreto Legge (Legal Decree) No 31 dated 11 Feb 44 (published in the "Official Gazette" of 16 Feb 44, No 7); which grants full validity "in every case, as if issued by the Italian Government" to all nominations to public or private offices, made by the Allied Military Authorities.
 - (d) Written decision of the Minister Omodeo (No. 1272, received on 19 May 44) whereby all measures taken by the Provveditore agli Studi beyond his normal competence are approved (amongst these, the appointments to the established staff ("ruolo").
- (4) I recall, therefore, that this Ministry's tardy expression of opinion on my appointment has no judicial value, being contrary not only to the fore-going provisions and but also to the law.
- (5) I beg you accordingly to consider both the above quoted note No 3869 of 26 Sep 44 and the letter of 2 Oct from the Preside of the R. Liceo Scientifico, as null and void.
- (6) Moreover, pending definite recognition of my rights, will you please authorise the payment of my salary and in any event KEEP ME IN MY PRESENT POST (EVEN TEMPORARILY) SO AS NOT TO IMPAIR THE CONTINUITY OF TEACHING. 4424
- (7) In the meantime, kindly let me legal copies of the following documents: a) my petition of 8 Sep 44 requesting my formal appointment. b) Act of 29 Sep from "the Governor of Caltanissetta. c) Decree of my nomination with the signature of the Governor. d) Letter from the Minister Omodeo, ratifying my appointment.

On the whole they worked quite independently, one being sectarian and the other non-sectarian. As a rule they only met on terms of friendship at International Jamborees and the like.

Immediately after the liberation of Rome both Associations sprang into life, unknown each other; and Associazione Cattolica at the request of His Holiness the Pope changed its name to "Associazione Giovani Esploratori d'Italia" in a effort to achieve a unity of Scouting unknown in previous days.

The two Associations have now federated together although keeping their internal administration separate, AGEI by mutual arrangement re-assuming its old name of ASCL. The present organization is therefore:-

"Federazione Esploratori Italiani"
The two Associations of which it is composed are (1) Corpo Nazionale Giovani Esploratori, whose Chief Commissioner is Dr. Firotta, and (2) Associazione Scautistica Cattolica d'Italia, whose Chief Commissioner is Prof. Mazza.

The Federation has been achieved to the complete agreement of all parties, and with the blessing of His Holiness the Pope.

Subject : Books for Italian Universities and Libraries.

On May 1st last (MCS.350) the then Military Government Section sent us a copy of a note they had received from the Education Sub-Commission about supplying American and British books to Italian universities and libraries. The Sub-Commission pointed out in their note that Italy had been cut off for many years from current political and economic thought in democratic countries and that as a partial remedy for this it was very important to do what was possible to make up some of the gaps in the bookshelves of Italian universities and libraries by supplying them with British and American books and periodicals.

2. The Foreign Office have also had this question under consideration recently and are prepared to send a British official, Mr. Paroissien, out to Italy to ascertain how British agencies could assist in replacing the losses and filling the deficiencies of the libraries of Italian universities in respect of British books.

3. We should be grateful if you would let us know whether there would be any objection to Mr. Paroissien visiting Italy for this purpose.

Statement of Minimum Essential Need of Basic Scholastic
Equipment for Schools of Occupied Country
for 6-Months Emergency Period

The Conference of Allied Ministers of Education and its Commission on Basic Scholastic Equipment have made a careful study and have prepared estimates of minimum need of supplies required to open the schools during an emergency 6-months period. It is considered by the Conference to be of very great importance to have the schools opened as soon as possible after liberation and to take steps to provide a minimum amount of materials to work with.

The Commission on Basic Scholastic Equipment prepared a standard unit to be used in estimating need. This unit was carefully planned and the special conditions under which such a program would be carried forward were recognized. That is, the amount suggested here is far short of normal peacetime allotments. This very limited unit was unanimously approved by the members of the Commission representing all of the governments concerned. Some amendments were made by the representatives of the governments involved because of special conditions within their respective countries.

In addition to the approval of the limited unit, most of the governmental representatives have designated certain items as being most urgent and the lists for the various countries presented later in this memorandum record these designations of priority. This full cooperation in defining a restricted allotment reflects a splendid cooperative spirit on the part of the representatives of the various governments and reflects also a willingness to accept a very minimum amount of materials for use by pupils and teachers to maintain educational service.

The estimates of need are based upon the population figures available for the different countries covering the pre-war years. For most of the countries the estimates are based upon 75% of the population. This adjustment is made further to reduce the extent of the materials involved and also to allow for any small amount of materials remaining after the enemy is expelled. Also, there has been recognition of the possibility of producing certain items within the various countries, and items which can be made available from within the countries have been dropped from the lists.

- 2 -

I have worked with the Commission on Basic Scholastic Equipment and its Sub-Committee, and in my judgment this statement of minimum need is a very practical and rock-bottom estimate. The size of the territory covered and the number of children involved makes the program a large one. If the total block of material cannot be secured and shipped, it is recommended that the reductions be made on the basis of the indicated priority of urgency of need given in the lists for the various countries. There may even be circumstances making further reduction in the number of units provided for a country. I hasten to add, however, that the present lists provide for an extremely meager body of materials and that further reductions should not be made unless conditions are such as to make provision of these materials impossible.

Copies of this memorandum with the statement of need for the various countries are being sent to the Department of State in Washington for transmittal to CCAC, to the British Foreign Office and the British Ministry of Education, to General J. C. Holmes and General F. F. Scowden of SHARP, and to Mr. John W. Gundelson of the Mission for Economic Affairs for transmission to FEA.

In the study of this problem and in the making of estimates of need, Mr. Hardin of the U. F. S. L. A. Committee and Mr. Gundelson of the Mission for Economic Affairs have given generously of their time and their knowledge. They were especially helpful in the development of the standard unit. Mr. Huxley of the British Foreign Office made valuable contribution in the development of the general plan of operation. Special recognition should be given also to Mr. Scammarfelt and Mr. Van Dyke, Chairman and Secretary respectively of the Commission on Basic Scholastic Equipment, for their work with the Commission and the Sub-Committee which developed the standard unit and for joining with me in the series of conferences with the representatives of the various governments.

In submitting this report I am moved to stress the urgency and importance of the need which would be met by provision of such materials as are listed in this memorandum. The importance of bringing the children and youth together under supervision is of obvious importance in the maintenance of orderly life within the liberated communities. I should like to stress in addition the importance of these materials for

cultural

cultural relations, and the desirability of providing decent living conditions for the children as soon as possible. As the Minister of Education of one of the countries stated, help of this type would have a very good morale effect and count much in offsetting the propaganda of the Nazis.

1. Need based on 1937-38 figures which are about 25% less than the latest general enrollment figures available. Hence by using the 1937-38 figures, we secure an approximate reduction of 25%. As a result of the general devastation in Greece, these figures can be considered to be very conservative.
2. The data are given by section of country at the suggestion of the Greek authorities for such guidance as they may provide in considering shipping arrangements. The total for the entire country is also given.
3. The Greek authorities placed great stress on the urgency of the needs for the nursery schools. They voluntarily suggested the dropping of tools from the schedule for elementary schools to compensate for this additional request for nursery schools.

II. Conditions affecting estimates of need:

1. A number of items have been deleted from the standard list because not urgently needed in Poland's educational program. The remaining items are indicated to be equally urgent.
2. Since the boundary question is not yet settled, it is not possible to estimate the number of units needed with the same definiteness as indicated for other countries. The basic data which can now be secured are presented. Any adjustments which may be required can be made after the controversial issues are settled. If the issues remain unsettled, it is proposed that some fraction of the total need be adopted so that some materials can be procured to meet the most urgent needs of the Polish schools.

III. Number of units needed:

As explained in Section II, number of units needed not calculated. The number can be determined by following the procedure used for the other countries.

1. One unit should be allowed for each block of 25 pupils. This same procedure is used for the three groups--primary, secondary boys, and secondary girls. Note that no tools or needle work items are included in the primary unit. These were dropped at the suggestion of the Polish

authorities in London as not being required in the Polish primary schools. The number of units of tools for the secondary schools is calculated to provide one set for schools under 100 enrollment, two sets for schools from 100 to 499, three sets for schools from 500 to 999, and four sets for schools of 1000 and over.

2. Polish authorities in London have not indicated that any items are more urgent than others. They suggest as many of the complete standard units as the circumstances will allow.

SUBJECT: Payment of Civilian Employees.

TO : G.I., ACC Hq.

1. The nature of the work of this Subcommittee requires the employment of certain highly educated specialists. Since those now employed are all women and no standard rate scale has been adopted by AFHQ for such, authorization of the rates of pay already in effect is hereby requested, as follows:
2. Sig.na Emilia Nobile was employed as Educational Consultant on 15 January, 1944. At that time clearance was obtained (over the telephone) for payment at the rate of 200 lire per day, and she has been working and paid at this rate ever since. She is a professor at the University and was recommended by the Provveditore agli Studi as the most competent available person to do research in connection with a survey of the Italian school system. She has been employed both for research and to read proof, critically, for our new series of textbooks. Authorization of her present pay retroactive to January 15, is hereby requested.
3. Sig.na Anna Odierno Di Lorenzo has been employed since 22 January, 1944, as secretary at the rate of 150 lire per day. This rate was officially authorized by Control of Wages Committee 2 February, as indicates by letter 091.461, 28 Feb., signed by Lt.Col. Junius R. Smith, and needs no further authorization.
4. Sig.na Luigia Barbatti was employed 23 January as office assistant at 90-110 lire per day. She has become executive secretary of the youth Commission organized by us and is doing highly responsible work for this Subcommittee in organizing childrens lunches, boy scout type of organization, student clubs, etc. She is a university graduate fluent in English, and has become invaluable to us. It is requested that her title be changed to "specialist" or "consultant" and that a rate of pay from 120-150 lire per day be authorized.

2)

The 120 lire per day should be retro-active to March 15, and should be increased at the rate of 10 lire per day each month until 150 lire is reached.

1. In view of my imminent departure from this Theatre of Operation I wish to make the following special commendations:

MAJOR GARLETON H. VANHORN, AUS (0518832)(A)

Due to the very great energy shown by this officer it has been possible to bring to a successful conclusion the most difficult task of revising and printing the text books in the field. These books should have been prepared before the invasion and the task of revision and printing in a war-stricken country has been no light one. In recognition of his services to education the University of Messina has conferred upon him the honorary degree of Doctor of Pedagogy.

I recommend that this officer be promoted to the rank of Lieut-Colonel.

MAJOR W.H. SHERWOOD R.E. (146295) (B)

This officer has had the administration of the Sub-Commission under his control and by his work has lifted from my shoulders the bulk of the routine and military work, which has enabled me to concentrate upon the work for which I was specially sent here by the Director of Army Education, namely the removal of Fascism and the restoration of the Educational system. In addition our public relations with Italian Educational Officials have been dealt with by him. In recognition of his work the University of Messina has conferred upon him the honorary degree of Doctor of Letters. On my departure Major Sherwood should undertake the work of the universities with which he is completely conversant, and in order that he shall have the necessary authority I recommend that he be promoted to the rank of Lieut-Colonel.

MAJOR G.E. KORMAN (0517750) (A)

This officer has shown particular devotion to duty especially in the removal of Fascist Provveditori and Presidi in the schools in Sicily. I recommend that this officer be promoted to the rank of Lieut-Colonel.

CAPTAIN A.A. YENSELO, A.E.C. (168363) (B)

This officer entered Region II as the first Director of Education in the Region and has done excellent work in a territory of exceptional difficulty. Although isolated and having little contact with Hq., and needing to use his initiative, he has always done so with judgment and discretion. He has carried out scrupulously the policies laid down by this Hq.

I recommend that this officer be promoted to the rank of Major.

CAPTAIN GEORGE GAYRE (6518130) (A)

On reaching Naples as Director of Education, Region III, he found a difficult situation; the Italian officials having assumed unwarranted powers both in the school and university systems. His handling of this position, which is rapidly bringing Region III into uniformity with the policy of the rest of the territory, has been admirable.

I recommend that this officer be promoted to the rank of Major.
