1. In response to your verbal request the Education Subcommission has made inquiries at the Lycee Chateaubriand regarding the need for Mme. Marie Therese Missionier as a teacher there.

2. The director of the school states that Mme. Missionier is their regular teacher of drawing and history of art, and while they have found a temporary substitute they prefer having their own teacher.

3. The Education Subcommission has previously investigated and approved the school, which is run by the French embassy. On principle this Subcommission would recommend the admission of any teacher desired by the school if there were no specific grounds for objection. There being no known reasons for objecting to Mme. Missionier, and the Director of the school having requested her, this Subcommission is glad to recommend that she be admitted to Italy to teach in the Lycee Chateaubriand.

1. Following your request, the Education Subcommission has sent a member of its staff to the Lycee Chateaubriand to make a first-hand investigation.

2. This school, under the aegis of the French Embassy, is a very good school primarily for children with French parentage. It is now registering students and will open this month. The Education Subcommission and the Minister of Public Instruction have given full consent to the reopening of the Lycee.

3. The attached memorandum of 13 October describes the present status of the Lycee.

4. In view of the total situation, the Education Subcommission recommends that the entry of M.Francois Simien into Italy, with his wife, be facilitated and expedited.

Le Lycée Chateaubriand compte à l'heure actuelle 120 élèves. Il reçoit encore tous les jours et recevra de nouvelles inscriptions. Le chiffre de 150 élèves au moins paraît devoir être atteint prochainement.

Le Lycée comporte toutes les classes élémentaires et secondaires, de la Dixième à la Philosophie incluses, plus une classe de français pour les Etrangers, soit au total 12 classes.

Beaucoup de professeurs sur lesquels le Lycée compte, et qui lui ont été affectés par les Services d'Algier n'ont pas encore rejoint: certains ont pu être provisoirement remplacés par du personnel de fortune, en attendant leur arrivée, pour laquelle les démarches auprès des autorités alliées sont en cours. Néanmoins certains cours ont dû être provisoirement suspendus, en attendant également l'arrivée des professeurs.

Le Lycée ne dispose à l'heure actuelle que de 9 Professeurs ordinaires:

MM. GAGNERES:	Lettres classiques
GUIBERT:	Anglais
IVANOFF:	Allemand
PERONI:	Italien, anglais

et un Professeur occasionnel: M. LUMEROZO, Prof.de Physique et Chimie.

Le Lycée attend la venue de:

un professeur de Lettres classiques:	M. HOFFNER
un professeur de Philosophie:	M. ARRIGHI
un professeur de Dessin et Histoire de l'Art:	Mme MISSONNIER (diplômée de l'Académie des Beaux Arts de Rome)

Tous ces professeurs sont absolument indispensables à la bonne marche du Lycée. Les démarches nécessaires pour leur venue sont en cours auprès des Services français et alliés (S.M. et C.I.) tant à Alger qu'en Italie.

A titre d'indication, le Lycée Chateaubriand, qui, en 1939-40 ne comptait pas plus de classes que maintenant (12 classes), pour un effectif légèrement supérieur (180 élèves), avait 20 professeurs.

SUBJECT: Visit of Andre Gide to Italy

1. M. Gide is a very old, frail and distinguished Frenchman. Both on that account and because he is an ally, the Political Section would naturally wish to see his case considered as sympathetically as possible. But if you ask me whether the reorganisation of French schools and institutes is of "sufficient value to the war effort" for us to approve a visit, I can only say that we have not yet authorised anyone to come out on behalf of the British Council, precisely for the reason that the objects of the Council are for peace and not for war.

2. I do not see that M. Gide can claim preferential treatment and should be inclined to reply to A.F.C. that he should not be allowed to visit Rome until permission has also been given for British Council representatives to come to Italy.
