Il Preside Restaino ha un diritto speciale ad essere accontentato, perché, nel 1942, quale vincitore del concorso speciale per presidenze in sedi primarie, raggiunse Messina proprio nel periodo dei più intensi bombardamenti e, quando quella sede fu declassificata, fu provvisoriamente assegnato ad Avellino.

Essendo ora libera la sede di Napoli, sarebbe atto di giustizia trasferirvi il Preside Restaino, che vi aspira da molti anni perché ivi risiede la famiglia della moglie e perché lì possiede beni patrimoniali da curare.

Pro Memoria

The Prof. RESTAINO Giuseppe, Director of the R. Istituto Tecnico Commerciale at Avellino, wishes to be transferred to Napoli.

The Director Restaino have a peculiar right to be transferred because, winning the Special Competition concerning Primaries Institutes (during 1942), he went to Messina during the period of the most violent bombardements. The Institute at Messina being declassed, he was provisionally sent to Avellino.

The seat at Napoli being vacant at present, it should be a right act to transfer the Director Restaino to Napoli, where his wife's family lives and where he have proprieties to be managed.

1. It would be appreciated if personal attention could be given to the following request.
2. The bearer, Prof. Tullia Raja, has been a teacher of languages (English) in the secondary or Ginasio schools since 1937. At present she is a teacher at Aversa, Naples Province.
3. For the past ten months Prof. Raja has been a valued employee of the Judge Advocate Section of PES in Naples, but now desires to return to her profession as a teacher.
4. A few weeks ago she requested, through her principal and Proveditorato, a transfer to a school in either Bologna or Florence, where she has relatives, and this request has been transmitted to Rome by the Proveditorato in Naples.
5. At the time that she won her competition there was no distinction as to positions in schools situated in large or small cities, but she was given a chair in a small city because at that time no opening existed in a large city.
6. Inasmuch as English, undoubtedly will be in great demand in Italian schools, it would be appreciated if assistance could be given to Prof. Raja in securing a transfer through the Ministry of Education, Rome, to Bologna or Florence or to another large city in northern Italy.
