SUBJECT : Appointment of Teachers
REF. : RA/ED/2.9

1. Several cases have been brought to my notice recently both from Rome and Provinces of dissatisfaction concerning appointment of teachers, especially those "non di ruolo".
2. While I feel that the Provveditori have good reasons for the apparent inequalities in these appointments, I feel some pronouncements on the ministerial level would allay this. The actual complaint seems to be based on the fact that younger teachers are appointed over the heads of teachers with several years service. I quote instances from Rome:
 - 1) Pizzitola Carmelino who has 6 years service, and
 - 2) Capelli Rosaria who has 10.
 Both are "non di ruolo" and both have been refused posts in favour of younger teachers.
3. I will, of course, deal with the matter with my own Provveditore, but in view of the fact that the problem is probably far wider than my Region, I have thought it best to ask your assistance in the matter.

1. Recentemente da Roma e dalle Province mi sono giunti parecchi casi di malcontento per le assegnazioni di posti, specialmente degli insegnanti non di ruolo.
2. Mentre ritengo che i Provveditori abbiano buone ragioni data la scarsità di dette posti, credo che una dichiarazione a proposito del Ministero della Pubblica Istruzione gioverebbe alla cosa. D'attuale malcontento sembra basarsi sul fatto che maestri più giovani vengono nominati al posto di maestri con parecchi anni d'insegnamento. Cito i seguenti casi a Roma :
 - 1) Pizzitola Carmelino il quale ha 6 anni di servizio, e
 - 2) Capelli Rosaria che ne ha 10.

Ambedue insegnanti non sono di ruolo e ad ambedue sono stati rifiutati posti in favore di insegnanti più giovani.

3. Tratterò, naturalmente, la cosa con il mio Provveditore ma considerando che probabilmente il problema si estende ad un campo ben più vasto di quello della mia Regione, ho creduto opportuno chiedere il suo appoggio in materia.
